COVID –19 Update PHASE 2 APPROVED

FEBRUARY 22ND WE MOVED INTO PHASE 2
OF OUR REOPENING PLAN!

The following is what phase 2 means for LCNH.

- Indoor visits for the 2 designated individuals per resident. We will use the list that was provided previously if changes need to be made please contact Life Enhancement Department (785-348-5551). Please call to set up a visit, we will need at least 48 hours notice and all visits are a 30 minute visit due to trying to get as many in to visit their loved ones.
- N-95 masks will be provided at the first visit, these masks will then be your responsibility to bring back to the facility to continue visits, shall these masks not be brought with you the visit will not occur until you have the N-95. These masks are in high demand at this time so we are only able to provide the one per designated individual, a maximum of 2 masks per family.
- Beauticians and Pastors can return to our facility. They will be COVID testing and wearing N-95 masks to enter our facility. The beauticians will only do 1 persons hair at a time. Pastors will be doing communion per our activities guidelines, ensuring that masks are being worn and social distancing of 6 feet between residents.
- Residents will be able to leave the facility to go to their scheduled appointments however they will still have to quarantine the 14 days when they return. We understand that there are a lot of appointments that need to be rescheduled so please be patient with our facility as we create a plan of action to accommodate all of our residents appointments. Only so many residents can be quarantined at a time due to the necessity of separate rooms and a different wing needed for this quarantine time frame. Please let the facility make the appointments at this time. Thank you for understanding.

Also understand that we can revert back to phase 1 at any time due to any change in circumstances around COVID

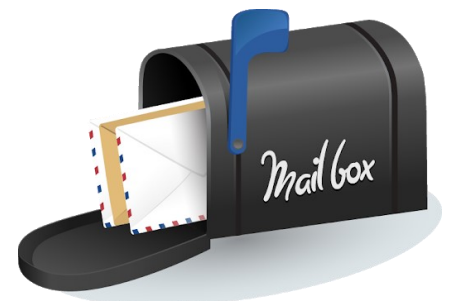
