## Section 21 of the Town Police Clauses Act 1847 (TPCA 1847)

### THE BOROUGH COUNCIL OF CALDERDALE ([ORDER REFERENCE]) TEMPORARY CLOSURE ORDER 2023

1. The Borough Council of Calderdale (Council) gives notice that it has made an Order under section 21 of the TPCA 1847 and any other enabling powers over an area of the highway being Cragg Road (B6138) at Mytholmroyd (from a point adjacent to 32 Cragg Road to the junction with A58 Rochdale Road).
2. The Order is made to avoid obstruction of the highway specified in paragraph 1 during the following event: 'Cragg Challenge 2023'.
3. The Order shall come into operation at 0830 until 1230 on the 30<sup>th</sup> April 2023.
4. While the Order is in operation, traffic including bicycle and equestrian movement along the highway specified in paragraph 1 will be temporarily restricted (except for emergency access) between 0830 and 1230 on the 30<sup>th</sup> April 2023
5. An alternative route will be available for use while the Order is in force being:
  - a) Blackstone Edge B6138 junction with A58 diversion to Mytholmroyd via
    - A58 Halifax Road to Littleborough
    - A6033 Todmorden Road/Rochdale Road to Todmorden
    - A646 Halifax Road to Hebden Bridge
    - A646 Burnley Road to Mytholmroyd
  - b) Mytholmroyd to Blackstone Edge via
    - A646 Burnley Road to Hebden Bridge
    - A646 Halifax Road to Todmorden
    - A6033 Rochdale Road/Todmorden Road to Littleborough
    - A58 Halifax Road towards Ripponden
6. All restrictions will be signed and or staffed and will remain in force only for as long as is necessary.
7. Nothing in the Order will apply to:
  - Any vehicle or bicycle engaged in the Relevant Event; or
  - Anything done with the permission of or at the direction of a police officer.
  - Any vehicle being used for police, fire brigade or ambulance purposes or the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which requires vehicles to be brought onto a section of highway to which the Order applies.
8. Pedestrian access to properties adjoining the highway specified in paragraph 1 will not be affected by the Order.
