ORDER

UPON hearing read the Pleadings herein; **AND UPON** hearing what was alleged by Counsel for the Plaintiff and Counsel for the Defendant; **AND UPON** seeing endorsed hereon the consent of Counsel for *Pension Member's Spouse* and the consent of Counsel for *Pension Member*; **AND UPON** it appearing that the *Pension Member* has an employment pension pursuant to the terms of the Alberta Sheet Metal Workers' Pension Plan; **AND UPON** it appearing that the parties wish to equally divide the *Pension Member's* pension and benefits earned during their marriage pursuant to the provision of the *Matrimonial Property Act of Alberta*;

IT IS ORDERED AND ADJUDGED:

1. THAT *Pension Member's Spouse's* and *Pension Member's* period of joint accrual of *Pension Member's* benefit acquired by him in the Alberta Sheet Metal Workers' Pension Plan, commenced on _____, ____ and ended on _____, ____.
2. THAT *Pension Member's Spouse's* share shall be half of the benefit including *Pension Member's* additional voluntary contributions or optional ancillary contributions or the benefit derived therefrom, acquired during the period of joint accrual.

3. THAT upon *Pension Member's Spouse's* election or choice, made in writing to the Alberta Sheet Metal Workers' Pension Plan, *Pension Member's Spouse's* share shall be transferred to a locked-in retirement account (LIRA) to be owned by *Pension Member's Spouse*, or, to the extent that the Plan provides, and the *Employment Pension Plans Act* allows, *Pension Member's Spouse's* share shall be paid as a pension to *Pension Member's Spouse*. A transfer of *Pension Member's Spouse's* share shall be either at the time of the filing of this Order with the Plan Administrator, or at such other time as may be permitted by the *Employment Pension Plans Act*, at the election of *Pension Member's Spouse*.
4. THAT a copy of this Order shall be filed with the Administrator of the Alberta Sheet Metal Workers' Pension Plan.
5. THAT this Order is a Matrimonial Property Order within the meaning of the *Matrimonial Property Act of Alberta*.
