Consignment Agreement

Between Local Postal ("Trading Assistant") and the Item Owner ("Owner")

This Agreement outlines the terms under which Local Postal, acting as a Trading Assistant (not an employee, agent, or contractor of eBay Inc.), will sell items on behalf of the Owner via eBay.

By signing below, the Owner agrees to the terms outlined herein and acknowledges a full understanding of the consignment process.

1. Authorization to Sell

The Owner authorizes Local Postal to list and sell item(s) on eBay. Standard payment will be issued via PayPal after the buyer has paid, received the item, and either left feedback or 20 days have passed since shipping—whichever comes first.

2. Commission Fees

Local Postal charges a standard commission of 30% of the final sale price. In addition, shipping costs are deducted from the proceeds. The remaining balance after these deductions will be paid to the Owner. A minimum commission fee of \$10 per item applies.

Example: If an item sells for \$100 and costs \$10 to ship, the 30% commission is \$30. After subtracting both the commission and the shipping cost, the Owner's payout would be **\$60**.

3. Item Representation

The Owner confirms that all information and descriptions provided to the Trading Assistant are truthful and accurate. Any known flaws, damage, or defects must be disclosed and will be included in the eBay listing.

4. Right of Refusal

Local Postal reserves the right to decline any item deemed unsellable due to condition, brand, market value, or authenticity concerns.

5. Ownership and Identification

The Owner certifies legal ownership or legal right to sell all consigned items and agrees to provide identification upon request. The Owner must be at least 18 years old.

6. Sale Obligations

If an item receives a bid at or above the starting or reserve price, the Owner agrees to complete the sale unless the buyer violates listing terms or cannot be verified.

7. Exclusivity

The Owner agrees not to sell or offer the item elsewhere while it is listed through the Trading Assistant. Early termination or outside sale will result in a \$25 stop listing fee per item.

8. Shill Bidding

Shill bidding (bidding on your own item or having others do so to inflate price) is strictly prohibited. Violation will incur a \$25 penalty per item and may result in legal action.

9. Damage or Loss

If an item is damaged (excluding acts of nature) before or during the listing process, the Owner will be compensated at the lower of either the starting bid or eBay appraised value. The damaged item will then become the property of Local Postal.

10. Payment Risks

The Owner acknowledges the risks of online commerce and agrees not to hold Local Postal liable for chargebacks, fraudulent payments, or buyer defaults. If payment was already made to the Owner, they agree to reimburse Local Postal in full.

11. Holding Period and Unsold Items

Local Postal will hold and attempt to sell consigned items for up to 60 days from the date of the listing. After this period, the Owner will be notified and must retrieve unsold items within 10 days of that notification (via phone, text, or email). If no action is taken within that timeframe, the item will be considered abandoned property. Local Postal reserves the right to donate, liquidate, or discard the item, and retain any proceeds to cover listing and storage expenses.

12. Disclaimer

All consignment services are provided as-is without warranty. Local Postal is not liable for any loss, damage, or claims arising from this Agreement, the sale of items, or any related services. This document represents the entire agreement between the parties. No verbal agreements or additional terms apply.
