General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

Terrylanigan.com legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- terrylanigan.com needs to perform a contract with you
- You have given terrylanigan.com permission to do so
- Processing your personal information is in terrylanigan.com legitimate interests
- terrylanigan.com needs to comply with the law

Terrylanigan.com will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.

Log Files

Terrylanigan.com follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The

information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable.
