## OUR RIGHTS ARE UNDER ATTACK!



### The 2024 Election will determine:

- 1) Who proposes, approves, enforces, and funds gun control laws and regulations
- 2) Who sits on the Supreme Court and upholds or denies your 2nd Amendment Rights
- 3) Who controls the military, State Police, and federal law enforcement

### Some Major Laws passed by the NYS Democrat majority and signed by a Democrat Governor:

**NYS SAFE ACT of 2013** which prohibits, or requires registration of, a wide range of common AR style rifles with detachable magazines, limits the magazine capacity of all guns, requires pistol & registered rifle recertification with the NYSP every 5 years, prohibits online ammo sales & requires all gun transfers be done through an FFL.

**RED FLAG LAW (ERPO) of 2019** which permits the seizure of firearms without arrest, notification or due process, and requires the seizure victim to pay extensive legal fees to try & get their guns returned.

**CONCEALED CARRY IMPROVEMENT ACT OF 2022** added NYSP run background checks & background check fees to both gun & ammo purchases, shortened the pistol recertification period with the NYSP from every 5yrs to every 3yrs, requires a 16hr training course to apply for a pistol permit, requires a semi-auto rifle license to purchase any type of semi-auto rifle, imposed additional 'Restricted' & 'Sensitive' locations where you are prohibited from carrying a firearm & more.
