Organization Eligibility:

To be considered for a grant, an organization must:

Be a non-profit entity performing public services in line with our mission statement; which is focused toward underserved families and children in the areas we are licensed as a non-profit (Connecticut, New York, Rhode Island, New Jersey and Massachusetts)

The mission of the Barnum Foundation for Life is to improve the quality of life for the people and families we serve through actions that promote change and deepen connections within our community.

Our grants are geared toward those working with / providing for families & children in our local communities.

Grant Awards:

Grants Range from \$50 +. Because funds are limited, the amount approved may be less than the amount requested.

Grants are **not** made to:

- Organizations without a 501(c)(3) status
- Religious organizations/causes
- Fraternal, political or membership/social organizations (such as organizations labeled 501(C)(4) or 501(C)(8))
- Capitol Campaigns
- Elementary, secondary or charter schools including booster clubs, PTO's, PTA's, marching bands and so forth
- Municipalities, local governments or chambers of commerce
- Donation requests should be direct to an organizations cause/programs and not to assist in covering costs for an event used as a sponsorship level.

Additional Information:

- The foundation reserves the right to decline a request
- The foundation reserves the right to request any supporting information if it considers it necessary when evaluating a grant application or at any time after the grant is awarded
- If a grant is at any time found to have been generated by an ineligible person or organizations, the Foundation will expect return of the grant
- A grant from the Barnum Foundation for Life does not constitute an endorsement from the foundation or Barnum Financial Group
- Press release documents shall be reviewed by the Foundation/Barnum Financial Group compliance prior to being posted for the general public.
- Donation requests are reviewed by a committee typically every other month. Please submit your request at least 3 months prior to the date needed by
