- Please be sure to include all information so as to allow us to issue citations under the law:
 - o Date(s) Must Have
 - Complete description of the animal(s) (if known): breed, color, makings, size, sex, name.
 - Complete name(s) and address of the animal's owner.
 - Detailed statement of the alleged violations, including exact time; if producing a statement of a barking dog, indicate the start time and the end time.
- Be sure to sign the affidavit form IN THE PRESENCE OF A NOTARY. Notary service is usually available at Animal Care and Protective Services.
- Mail or deliver the completed affidavit(s) to Animal Care and Protective Services, 2020 Forest St, Jacksonville, FL 32204. We cannot accept faxed affidavits.

Please Note: If your affidavit(s) is not completely and specifically in accordance with the above instructions, it may not be sufficient to issue a citation. Please take special care to follow <u>ALL</u> instructions.

Enforcement of Affidavit

For the following violations, a citation may be issued on one affidavit from **two** unrelated adult witnesses from different households or on an officer witnessing the violation:

462,203

Cruelty to animals

462.301

Failure to remove and dispose, immediately of fecal matter

462.302

Allowing an animal to make objectionable noise continuously for a period of 30 minutes or more

462.303

Allowing an animal to be at-large

For the following violations, a citation may be issued on one affidavit from an adult witness or an officer witnessing the violation:

462.305

Permitting an animal to damage someone else's property or biting

NOTE:
