A MESSAGE FROM AMY MACAK, GENERAL MANAGER



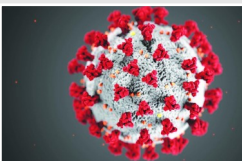
As our community continues to feel the impact of the COVID-19 pandemic, I remain confident that together we can overcome, and our community will emerge stronger. I have pledged transparency to our community, and though we are unable to meet in person, I wanted to provide you all with a few updates, including our response to COVID-19, and what MPC is doing at both a local and national level to support our communities during this pandemic.

OUR RESPONSE TO COVID-19

At this time, the plant is running at a reduced mode of operations, with the majority of our salaried employees working from home. Additionally, the plant has reduced most of the outside contractors from the facility to minimize unnecessary contact.



For those who continue to work at the refinery, a significant effort has been made to maintain appropriate social distancing. All employees have been issued cloth face masks for use in common areas where social distancing could be a problem. On specific jobs where social distancing is not possible, employees are wearing additional respiratory PPE.

As the situation evolves, we continue to utilize CDC guidelines and the Minnesota Executive Order to guide our coronavirus response.

OUR SUPPORT AT A NATIONAL LEVEL



MPC deployed its entire stock of personal protective equipment including gloves and N95 respirator masks to health care providers on the front lines fighting the pandemic. The number of N95 respirator masks MPC has proudly distributed to hospitals & health facilities across the U.S. now exceeds 560,000! These donations include approximately 9,600 masks to Fairview Health, right here in St. Paul.

In addition, the Marathon Petroleum Foundation donated \$1 million to the American Red Cross which will help supply critical resources necessary to safely provide disaster relief and support to those in crisis during the COVID-19 pandemic and beyond.

OUR SUPPORT AT A LOCAL LEVEL



At a local level, I am proud to share our employees have stepped forward in a number of ways. We have continued our partnership with Friends in Need Food Shelf by providing volunteers every other Monday to assist in packing boxes, sorting food and stocking shelves for local families in need.

Additionally, employees have donated time at other food pantries, helping provide necessary goods to those in need, including ready-to-cook healthy meals, care packages to nursing homes, blood or plasma to the American Red Cross, as well as personal monetary donations.



MPC has also announced that it will match all employee donations at 100% up to \$10,000 per employee through the end of 2020! Our employees in St. Paul Park have donated over \$3,000 since March to more than 10 local non-profit organizations including Shriners Hospital for Children, Feeding America, Second Harvest Heartland, and Loaves and Fishes among many others.
