*The buyer accepts responsibility of caring for this kitten and providing properly for it's general health and welfare. Kitten is born the offspring of parents who were tested or whose parents were DNA tested to be PKD negative.

*The buyer agrees that this kitten will always receive prompt medical care from a licensed Veterinarian.

*The buyer agrees to never allow kitten outdoors unless leashed and accompanied by a responsible person to supervise its freedom for its health and safety.

*The buyer agrees to never declaw kitten.

*The buyer agrees that this kitten will never be sold, leased or given to another person, a pet facility, animal shelter or research laboratory. If the buyer can no longer keep this kitten, the Breeder will assist in re-homing or take possession of the kitten without refund to the buyer. Breeder will bore shipping cost and attempt to retrieve kitten in a timely manner.

*The buyer, at his/her expense agrees to have kitten altered prior to reaching 12 months of age. We recommend altering between 6 and 7 months of age. A certificate of alteration signed by your vet is required to the breeder. The breeder will then send the buyer the kittens litter registration papers. CFA slips will be provided to buyer. The buyer will bore the cost of actual kitten registration. Breeding/Show rights can be purchased at an additional cost prior to and in lieu of spay or neutering on Breed or Show quality kittens. Cost is additional \$500.

*The buyer agrees to assume responsibility and cost of transportation or shipping if required.

*The buyer will maintain reasonable contact with breeder for the first 2 years of kitten's life by providing updates to the Breeder on the kitten's health, behavior and overall temperament. The breeder will not be responsible for veterinary costs.

*The kitten will come with age appropriate vaccinations, and be flea and mite free.

*The buyer agrees to a nonrefundable \$250 deposit to reserve their kitten. Balance of adoption fee is due 30 days prior to taking possession, shipping, or before 8 weeks of age. (Whichever comes first)

*Nonpayment or breach of contract in any way releases kitten back to breeder immediately. No refunds will be given for deposit or any other payments received prior to the default. Should a kitten not be available or offered once a deposit has been received, the deposit is fully refundable. Kittens not spayed or neutered on or before 12 months of age will be forfeited back to breeder. Customer will bore cost of attorney's fees should a lawsuit ensue. Breeders has option to refuse sale of kittens or cats to any person for any reason.

KITTEN ~ Health Guarantee:

KITTENS come with a 1year health guarantee which covers life threatening, untreatable genetic defects.

The Buyer has 3 business days from date of purchase to have pet examined by a licensed veterinarian.

If pet is not examined in that period of time, this health guarantee is voided releasing BELLESPURR from any obligations set forth.

This guarantee DOES NOT include minor treatable nuisances such as fungus, coccidia or upper respiratory infections.

A minor Upper Respiratory Infection, Coccidia or fungus can occur as a result of the stress of being relocated into a new home & S BELLESPURR cannot guarantee that this will not happen.

If a licensed veterinarian finds the pet to have a serious illness or the KITTEN is diagnosed by Buyer's vet as having a life threatening, untreatable hereditary defect that in his/her opinion prevents the KITTEN from serving Buyer as a companion pet, Buyer must provide a written statement on licensed veterinarian's letterhead identifying the problem & must be given to BELLESPURR within 10 business days of KITTEN purchase date.

KITTEN can be returned to BELLESPURR at Buyers expense. Only then will another KITTEN of the same breed & cost will be open for discussion. If no KITTENS are available for replacement, Buyer will be offered a KITTEN of similar qualities when a new litter is available.

Although Seller will put forth great effort to replace the exact color of KITTEN, Seller is not obligated to do so.

If KITTEN dies within one year of purchase date due to a hereditary or

congenital defect, the **Seller will replace the pet when proof of the defect in the form of a necropsy report from a licensed veterinarian pathologist in addition to appropriate blood work is received by Seller.**

Seller is not responsible for any vet expenses related to the above KITTEN including autopsy, blood work expenses or any other vet related expenses incurred during the course of pet's life.

>>There are NO Cash REFUNDS<< - ONLY KITTEN replacements in the form of a Monetary Credit for Purchase Price to be Applied toward the Purchase of Replacement Pet.
