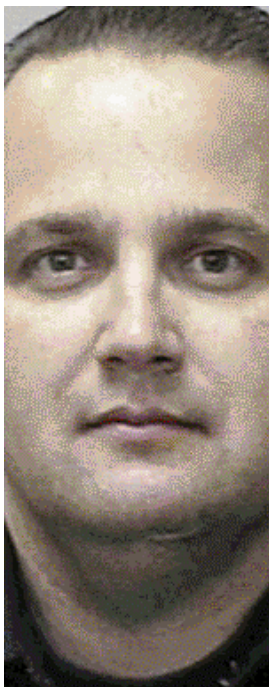
Mark Dunakin
