4. FIRST AID MEASURES

Eyes Contact: Get medical attention immediately. Immediately flush eyes gently with large amounts of water for at least 20-30 minutes. Retract eyelids often. Check for and remove any contact lenses. Chronic exposures to vapors can cause conjunctivitis.

Skin Contact: Remove contaminated clothing. Wash the exposed area with mild soap and water. Flush w/lukewarm water for at least 15 minutes. Launder contaminated clothing before re-use. Seek medical attention if ill effect or irritation develops.

Ingestion: Do not induce vomiting. Never give anything by mouth to an unconscious person. Keep person warm, quiet and get medical attention. Aspiration of material into the lungs due to vomiting can cause chemical pneumonitis which can be fatal. Target organs include liver, kidney, bladder and sternal bone marrow. Can cause gastrointestinal irritation. Symptoms of TCPP exposure may include salivation, sweating, headache, nausea, muscle twitching, abdominal cramping, diarrhea and chest discomfort.

Inhalation: Move exposed person to fresh air. Get medical attention immediately. If it is suspected that fumes are still present, the rescuer should wear an appropriate make of self contained breathing apparatus. Keep person warm and at rest. If not breathing or breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing air to give mouth-to-mouth resuscitation. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway

Advise to physicians: Treat symptomatically and supportively. TCPP may cause cholinesterase inhibition. If cholinesterase inhibition is suspected, atropine by injection is antidotal. 2-PAM (protopan chloride) is also antidotal when administered early and in conjunction with atropine. Following exposure medical follow-up should be maintained for at least 48 hours.

Methods and Materials for Containment and Cleaning Up
