

## **2018 GARLAND COUNTY FAIR RODEO QUEEN CONTEST SEPTEMBER 14-15, Garland County Fairgrounds**

The Garland County Fair and Livestock Show Association welcome contestants from Garland County to compete for the title of Garland County Fair Rodeo Queen. Judging is based on appearance, personality and horsemanship. This fun and entertaining two day event brings beauty and charm, and is the highlight of the Rodeo on Saturday night when the 2018 Garland County Fair Rodeo Queen is crowned.

### **QUALIFICATIONS AND RULES**

1. Contestants must not be less than 17 or more than 21 years of age as of September 15 of the current year.
2. The contestant must be single; never been married, pregnant and/or had a child.
3. The contestant must be a female legal resident of Garland County Arkansas..
4. The contestant may be amateur or professional. Cannot hold an out of County title.
5. Entry constitutes agreement to release Arkansas Livestock Show Association from all liability.
6. Contestants are required to ride as a group in the Garland County Christmas parade and in the Grand Entry each night of the rodeo.
7. Horsemanship pattern and speech topic will be given at the Information Clinic September 6th.

### **CHAPERONES**

Contestant must be accompanied by a parent/guardian or female chaperone appointed by parent/guardian. The chaperone must be present at registration and remain with the contestant throughout the contest.

### **HORSES**

Arkansas horses must be accompanied by the original report of negative EIA test within 12 months prior to exhibition.

### **DRESS REQUIREMENTS**

Each contestant should come prepared with enough WESTERN ATTIRE for the 2 day event, including an interview session, horsemanship, and riding in the Grand Entry of two (2) performances with the crowning ceremony on Saturday night. During Horsemanship Competition, contestants should wear blue jeans and long sleeved white western shirts. Hats are required during all phases of the competition, including the interview. Chaps are not allowed.

### **PHOTOGRAPHS**

Two photographs must be attached to the entry form: 4" x 6" of the head and shoulders (these photos are not used for judging purposes - snapshots are acceptable). Contestants should be dressed in western attire including hat. On the back of the photographs, please print the date, contestant name and address.

### **JUDGING**

Garland County Fair & Livestock Show will appoint 3 judges for Appearance and Personality and Horsemanship. They will be persons well qualified to judge a contest of this kind. Manners, behavior and grooming will be observed at all times from registration to the crowning ceremony. Their decision is final. Poor sportsmanship, tardiness, interference or otherwise inappropriate conduct will affect your score. Rule violations could result in disqualification, from this and future contests.

### **AWARDS**

The contestant named 2018 Garland County Fair Rodeo Queen will receive a Crown, and other awards. The First Runner-Up, will receive various awards. Miss Horsemanship, and Miss Congeniality will receive various awards.
