Age divisions:

The age of the contestant is their age on October 1st, 2024. This is a rule from the Arkansas State Fair.

Youth- 13 years and under

Junior- 14-17 years

Senior- 18-23 years

Adult- 24 years and over

ALL ACTS ARE \$30 EACH

Competition Categories:

EACH CONTESTANT IS ONLY ALLOWED TO ENTER ONE CATEGORY UNLESS YOU ARE COMPETING IN A GROUP AND A SOLO ACT

Vocal Solo- a vocal performance by one person only. No other talent can be performed during this.

Vocal Group- a vocal performance by two or more (no more than 10). No other talent can be performed during this.

Dance Solo- a dance performance by one person only. No other talent can be performed during this. All types of dancing are allowed in this category. (tap, jazz, ballet, folk, contemporary, lyrical, hip hop, etc) NO acrobatics allowed.

Dance Group- a dance performance by two or more (no more than 12) dancers. No other talent can be performed during this. All types of dancing are allowed in this category. (tap, jazz, ballet, folk, contemporary, lyrical, hip hop, etc) NO acrobatics allowed.

Variety- one or more (no more than 10). This category is intended to showcase an act where multiple talents are shown in one performance. Acts that fit the description of any other category will not be allowed to compete in this category. Some qualifying acts are: juggling, ventriloquism, magic, sign language, comedy routines etc.

NO drums, beatboxing, paint, watercolor, swords, open flames or flammable liquid.

Instrumental Solo- an instrumental performance without vocal utterance by ONE performer. No drums allowed.

Rules and Regulations:

- All contestants must be a legal resident of the state of Arkansas. Junior, Senior and Adult MUST reside in Garland County for at least 6 months prior to the contest. Youth is open.
- All contestants must have never been convicted of any crimes or have any criminal charges pending.
- Junior and Senior contestants can not or never have been married, divorced or have any children.
- In the event that the winner of the Junior, Senior or Adult division can not attend the Arkansas State Fair talent competition, the Director, Faith Castle, can send a runner up in their place.
- Only the Junior, Senior and Adult division winners can compete at the Arkansas State Fair. Those age groups require winning a county to continue. The youth division does NOT require a county win. ANY youth contestant can compete at the Arkansas State Fair.
- Group acts have to go off of the oldest age contestant. Younger contestants can age up with them but you can NOT age down.
- All acts have a time limit of 3 minutes. Exceeding 3 minutes will result in a 5 point deduction.
- NO decorative or background/backdrop props of any kind. If a prop is required, it must be used as a functional part of the contestant's act.
- Inappropriate behavior or language of any kind will not be tolerated. If there is an issue, it can lead to the contestant being disqualified.
- Any inappropriate songs, lyrics, or dancing will be disqualified immediately and will not be able to perform.

JUDGING/SCORING:

100 points total

-Talent 50 points

-Showmanship/Entertainment 25 points

-Appearance 15 points

-Preparedness 10 points

The judges for the Garland County Talent Competition will be appointed by the Director. They will be qualified to judge a competition of this kind. Their decision will be final. NO score sheets will be given. Critiques from the judges are not allowed. In the event of a tie, the judges will break the tie based on the overall appeal of the acts.
