Quarterly Medicare Premium B Reimbursement

As previously shared, last year the Trustees for the Health and Welfare Benefits Trust agreed to create a new process so that in lieu of the annual ritual of submitting your Social Security Benefits Statement, a one-time requirement to submit an affidavit would be implemented.

I have been working closely with Zenith in an endeavor to create a smooth process. With the assistance of former President, Dom Summa, and Merri Furler, REACTA Vice President and liaison to the Health and Welfare Benefits Trust, the new process is as follows:

To **continue** receiving the Part B Premium Reimbursement, you and, if applicable, your eligible dependents will need to complete a one-time affidavit and return it with a copy of your Medicare Health Insurance enrollment card issued by the Social Security Administration and/or if applicable, any eligible dependent's Medicare card. This information must be returned by **March 1**, 2024.

You should have received the packet of information including a cover letter explaining the process, the new policy, the reimbursement affidavit, an optional direct deposit authorization, and a self-addressed return envelope. It is also posted on REACTA's Website and Facebook Page. If for some reason you did not receive an addressed return envelope, it should be sent to Zenith American Solutions, 2250 S Rancho Road, Las Vegas, NV. 89102. (continue on page 5)

On the March primary ballot CTA is urging a YES VOTE on Proposition 1 "The Mental Health Service Act." This \$6.35 billion bond will build badly needed Behavioral Health Centers for Californians with the deepest mental health needs.

On the ballot will also be several federal races including President, U.S. Senator, and Congressional seats across the state. We urge you to do your homework and vote for pro-labor candidates who will protect pensions and access to high quality healthcare.

As the November election draws closer, we will update you with CTA's recommendations and with opportunities to get involved as the November election will represent opportunities and risks for REACTA and our members.

If you are currently receiving your reimbursement via direct deposit, there will be no need to submit another direct deposit authorization form. However, REACTA highly recommends that you sign up for direct deposit if you have not done so in the past.

Retirees who are not eligible for Medicare yet, will receive similar information upon your eligibility for Medicare.

It is important for all REACTA members to seek out and assist any retirees that you are aware of who may have difficulty completing this task.

I am sure we will have more challenges before us in 2024. One thing that I do know is that there is no obstacle that the power of our membership cannot overcome together.

CTA HEALTH & WELFARE BENEFITS TRUST

The Trust meeting was held January 9, 2024, via Zoom.

The Investment Consultant reported on the strong year-end performance in 2023, with double digit returns across the board. All investment allocations are in line with their targets and there are no concerns at the present time.

Trustees on the Budget Committee and Compliance Committee held meetings with Zenith reps regarding Transition updates, including eligibility, customer care and service time, open enrollment, and roles and responsibilities. Zenith will be providing additional resources to address eligibility and timeliness issues. Expectations will be placed on the Customer Service Team to become better advocates for participants, and to provide a participant website. The website will include eligibility information, access to claims and EOBs, and will be updated regularly. The website can be found at: https://edge.zenith-american.com. Click on Participant Edge Login.

The Benefits Committee did not have any action items at this meeting but did report out that they are still trying to resolve the Delta Dental issues. Options include adding Ameritas Dental as a supplemental plan, and possibly an increase in Delta Dental's annual maximum amount to reduce out of pocket costs.

Anthem Blue Cross and UC Health are still in contract negotiations, but if an agreement is not in place by February 29, 2024, UC Health will be considered out-of-network as of March 1, 2024. Anthem is obligated to inform HMO participants, but not PPO participants who could incur significant out of pocket expenses. If you or your dependent(s) are receiving current care from the UC Health system, you may want to submit a continuity of care form to Anthem. These contract negotiations do not affect UC employees or students. Contact your local UC Health provider for more information.

The next H&W Benefits Trust meeting will be held, via Zoom, on April 11, 2024.

RETIREMENT TRUST MEETING REPORT

On December 13th the Retirement Trust met for its third meeting of 2023.

As this is the month that determines the zone status for the coming year, it is an important meeting where the trustees are given information on the portfolio performance for 2023.

Zone determination is based on the assets and liabilities as of December 31 each year.

At the meeting, year to date performance was showing a little over a 7% return on investments which matches the trust's expectations.

Surprisingly during the meeting, the markets hit a record high which should actually improve the performance that was reported earlier in the meeting.

As of this writing, December 28th, the markets ended up with a 24% gain as a final point for 2023. Although the markets did not set a record on the 28th, projections for 2024 look promising.

I believe it is safe to say that the California Teachers Association Pension Trust will be in the Green Zone once again.

While our trust investments are diversified among things other than the stock markets, our performance will not match the 24%. However, our returns should be well above our anticipated goals.
