Staying connected also occurred when 84 REACTA members attended our Connecting the Dots zoom panel discussion on April 30th. For those who attended we hope you found it was informative. We were pleased with the positive feedback. Tom Madden and Marlene Bell attended all the way from Italy and stayed up late to join the conversation.

The meeting covered various topics affecting retirees. The four presenters discussed potential threats to government programs, and the importance of **staying connected** in addressing these concerns. **Merri Furler** (REACTA Vice President and liaison to the Health and Welfare Benefits Trust)



gave an overview of the Trust funding and explained how our trust is self-funded. **Alan Frey** (REACTA liaison to the Pension Trust) discussed factors such as stock market fluctuations that can impact funding.



Brian Breslin (active CTA staff in the Santa Maria RRC) reviewed the overall state of Social Security and its funding issues including the recent WEP and GPO offsets that positively impact many REACTA members.

Arleigh Kidd (REACTA Political Education Committee Chair) discussed a variety of issues including the dismantling of the Department of Education, weakening collective bargaining laws, the disregard for the rule of law, vouchers, and their potential impact to CTA funding. He connected the dots between Project 2025 and the current reality. *(continue of page 5)*

CTA HEALTH & WELFARE BENEFITS TRUST

New Third Party Administrator - The Trust has announced that starting September 1st, Delta Fund Administrators will be the new TPA. Zenith is out. The Trust is discussing creating some trainings to answer questions about how the transition will work, what will happen, and when you can expect to see changes. I hope to find out more information at the June 13th trust meeting.

Trust meeting -Future Benefits Changes and Funding for the Trust There are 3 primary funding sources each month for the Health Trust:

- 1) Employer contribution rates
- 2) 16% of active employee payroll to pay for retiree expenses
- 3) Interest from investment income

Not only does the Trust use this funding for benefit expenses, there are also administrative expenses, such as the consultants, attorneys, Stop Loss insurance, and claims processing.


Employer contribution rates are what CTA, and participating chapters pay for active employees and dependents whether Anthem or Kaiser members. These rates are determined each year at the June Trust meeting using past and projected expenses.

Currently there are 473 active employees and 668 retirees. In 2010, it was the opposite. The numbers were about even in 2016-17 and have changed direction since then.

In 2020-21, the assets were around \$27M. Over the last 4 years, the Fund balance of assets has been dropping and is currently around \$15.5M. The Consultant is projecting a deficit at this year's end of \$2.5M and a deficit of \$4.2M by the end of 2025/26.

Current Contract language directs the bargaining parties to direct the Trust to make benefit plan modifications and increases to the employer contributions when the reserves/investments start to reach \$10M. With this in mind, conversations have begun to address the \$10M threshold.

As soon as REACTA is aware of any decisions of benefit plan modifications, we will communicate that to our members.



TREASURER REPORT

Greetings to all. The REACTA 2025 budget is in excellent shape. So far this year, thanks to the generosity of thirteen of our members who contributed to the REACTA Assistance Fund to help our members who lost their homes during the Los Angeles firestorm and our monthly dues contributions, our income is \$8,744.00 and our expenses are \$4,104.41. Total REACTA assets equal \$75,492.32.
