Long Term Care

It is unfortunate that many retirees who purchased long term care policies through the trust are facing significant increases in premium. The Trust investigated this action and concluded there was nothing it could do to fix this problem. There is a nationwide crisis in long term care due to many factors. If you have a plan and want to maintain your current premium, you were given the option to lower benefits, reduce coverage or eliminate the COLA. According to Dan Saling, if you have been in the plan for more than ten years, you may have the option to convert currently paid premiums to daily coverage. This needs to be confirmed in writing with CAN.

Annual Reunion and Business Meeting

The officers decided to invite ALL CTA staff retirees to the Annual Meeting scheduled for October 2-5, 2017, at the Cambria Pines Lodge. Please encourage your former colleagues who are not REACTA members to save these dates. Non-members may attend all functions, however, they may not vote in the annual business meeting. There will also be an additional registration fee since REACTA subsidizes the cost of the conference, including dinner, for our members.
