#### Medicare Advantage Plan...A Seat at the Table

A "shout out" thank you to the many REACTA members who responded to our last Hot Topics Special Edition on Medicare Advantage Plans. I received many compliments and concerns from members about potential issues if our Trust moved to replace our Medicare coverage with an MA plan from Anthem. Our concerns were strongly communicated to both labor and management trustees and it had a positive impact. REACTA was invited to attend a virtual meeting with Trust administrators, Anthem Blue Cross representatives and both labor and management trustees. The purpose is for REACTA to communicate directly with the Trust and present our questions and concerns to the actual decision-makers. This meeting will take place on April 13, 2021.
