Bargaining Continues on Pension Trust

The headline is the same as the last two months, but the content is different! There still is no agreement on how to move our Retirement Pension Trust out of the red zone. The next tripartite bargaining session has been scheduled for June 22. REACTA will keep you informed of the results of the bargaining.

Purchasing Power Retroactivity Delayed

The Health Benefits Trust administrator has finally made the PPA adjustment for 2017 eligible retirees. There are a few retirees who believe they are entitled to an adjustment and we are trying to determine their eligibility. The major concern we have is the trust administrator's continued delay in providing the retroactive payment back to January 1, 2017. I was previously told the retro amount would be sent separately in May. Last week I was informed that the retro amount will be sent by the end of June. This foot-dragging is totally unacceptable. Once again our retirees in greatest need are faced with a delay of payments due from the trust. REACTA officers discussed this problem at our June 8 conference call meeting and decided to request two changes in the way the trust operates. We will be making a formal request to CSO, CAS and CTA Management that each trust (pension and health benefits) designate one trustee to serve as the official contact with REACTA. This trustee will be our main contact to help us resolve issues affecting our retirees. The second change would be to request that our trust administrator designate one person on their staff to be the liaison to REACTA. This person could assist with any issues that might impact our retirees. We hope these changes can be in place prior to our annual reunion and meeting in October.
