CTA, CSO and CAS Reach a Tentative Agreement on Pension Trust Funding

Finally, a NEW headline! A Tentative Agreement has been reached in Tripartite Bargaining that addresses the recommendation of the Actuary to move our Pension Plan out of the Red Zone. Ratification by all parties is expected soon. The agreement has CTA increasing its contribution to the Pension Trust by 2.5% and also redirecting 2% of CTA's non-match 401(k) contribution to Pension Trust funding. Ratification by all parties is expected soon. In addition to the Tripartite Bargaining, both CSO and CAS are negotiating new contracts with CTA. CSO and CTA reached a Tentative Agreement last week. CAS and CTA reached a Tentative Agreement this week. REACTA would like to thank all parties for reaching these agreements so that their energy can be focused on serving CTA members.

This year's increase for some members has been over 100%! When faced with a significant rate increase, you should request from CNA in writing a list of your options. These may include a longer waiting period, a lower daily rate or a waiver of COLA adjustments. You may also be able to convert your premiums paid to a daily benefit period.
