### CTA Recommendations for November 6 Election

CTA's recommended candidates for Governor and Superintendent of Public Instruction will be on the November 6 ballot. While much is known about the record of Gavin Newsom, there are many who are unaware of the work done by Tony Thurmond to provide a quality public education for all students in California. CTA's rationale, as explained to its members, was as follows:

***As a state Assembly member, school board trustee and city councilman, Thurmond has always kept California's kids as his top priority. While on the West Contra Costa Unified School District board, he oversaw truancy prevention programs, supported school-based mental health programs, and launched a program to teach entrepreneurial skills to disadvantaged students.***

***Thurmond passed legislation to provide millions of dollars to school districts to keep kids in school and out of the criminal justice system, fought for money to make sure that all California youth in foster care can go to college, and increased funding for early education programs.***
