Your email address will be added to the participant list in order for you to join the meeting. You will receive a link to our meeting a few days before October 5. Click the link to enter the meeting. You do NOT need a Zoom account or a password to participate. We will have a brief tutorial before the Hot Topics and Annual Meeting.

If you have not yet used Zoom, here are a few tips...

- You may access Zoom using a desktop, laptop, tablet, iPad or smartphone.
- You may jump in or out of the meeting at any time to take care of personal needs. Do not delete the original email from Zoom since this will allow you to get back in.
- You do not have to attend the breakfast or book club.
 You can enter our meeting at the start of any session.
- If you are camera shy, you can click the camara "off" on your screen name. Your name will appear to the group but we will not see you!
- Be aware of your background if you use the camera.
 Stray animals and family members may appear when you least expect it!
- You can participate in our meetings by asking questions or giving comments. Our meeting host will explain this process at the start of each session.
- Your microphone will be muted during presentations to avoid stray sounds from entering our program.
 You will be un-muted when asking questions.
