## **New Medicare Part B Reimbursement Policy**

At the CTA Employees' Health and Welfare Benefits Trust meeting, held on April 5, 2023, the Trust Attorneys presented a new Medicare Part B Reimbursement Policy that was adopted by the Board of Trustees.

The new policy contains a conditional request for **one-time documentation**. All **new** Medicare retirees, and eligible dependents, will (within 12 months of enrolling in Part B) need to submit a copy of their Medicare Enrollment card and a signed affidavit to the Trust Administrator. This will be a one-time submission.

Since the reimbursement verification process for 2023 has concluded and the Trust Administrator believes compliance has been fulfilled, **current** Medicare retirees, and/or dependents, receiving the reimbursement will not be required to do anything this year. Starting next plan year, current Medicare retirees will need to submit a one-time signed affidavit to the Trust Administrator. If the substantiated documentation is not returned, there will be no reimbursement.

The new policy and affidavit also addresses repaying the Trust any reimbursement overpayments, due to a cease in enrollment in Medicare Part B or nonpayment of Medicare Part B premiums.

More information will be sent to Trust participants in the future.

A shout out to the **REACTA Executive Board** (past and present), and to REACTA members who advocated and supported their efforts to simplify the reimbursement process. It will be incumbent on all of us to reach out to our current colleagues during the next plan year to assist where needed. REACTA will continue to work with the Trustees to

help make this transition go smoothly. When we work together, we can make positive changes for our members!
