#### **President's Report**



As of this writing, I have been to a number of meetings throughout the state: two Executive Board meetings (both in Fresno), two meetings (San Dimas) to transfer the Treasurer's duties from me to Art McLoughlin and four regional luncheons. The luncheons were held in the following locations: Sacramento – 16 people from Region 2 North, Irvine – 20 people from Region 4 and 3, Santa Fe Springs – 20 people from Region 3 and 4, and Fresno (Baja) – 40 people. The

last luncheon (Region 1 and Departments) will be on Thursday, June 13, 2013 at the home of John and Ruth Mary Cradler. Attendance continues to grow each year.

Issues for the Executive Board and the Organizing Team to address are:

- Attainment of "ex officio" non-voting seats for REACTA on both Trusts.
- Accountability for the funds earmarked for retirees before 9-1-89.
- Two additional issues were exacerbated by the recession since 2008 and its slow recovery, and the financial impact the recession had on CTA and secondly our disappointing experiences last year with the CTA management and the two Trusts.

More detail will be forthcoming in future REACTOR issues and at the Cambria annual meeting on October 8, 9, 10, 2013

This will be a rather contentious year both within REACTA and in our relationships with CTA, the two Trusts and the two unions. A few members at the Spring luncheons voiced concern that we should NOT be seeking, this year, any monetary benefits un who knows when????

Our next Executive Board meeting will be on Monday, August 12 at the Ontario RRC. It starts at 10:00 a.m. and adjourns at 2:00 p.m. If you would care to weigh in on any article in the REACTOR please put it in writing and mail it to me by August 5. Attend the meeting on August 12 to address the issues you want to discuss. Come join the discussion!

- Protect collective bargaining for public employees, especially educators

### **Health & Welfare Trust**

The April 26, 2013 Health and Welfare trust meeting was concise and short in duration compared to other meetings. Of note; Trust Attorneys Phil Miller and Brandie Barrows presented an extensive document outlining the Trust's obligations under the Affordable Care Act. While the Trust is not the "employer under the Act, the Trust has a number of reporting responsibilities as does CTA as the employer. Medical claims are up however our unit (retirees) is pretty level mostly due to Medicare being the primary payer for most procedures. Projected-not final-cost increases for the plan year 2013/2014 are as follows:

# HOW'S YOUR PURCHASING POWER THESE DAYS?

Without doubt, REACTA can take some degree of satisfaction in having pursued and seen implemented, effective subsequent to January 1, 2010, adjustments to the benefits of those who retired from active service with CTA before Sept. 1, 1989. These improvements certainly were not all that the organization had hoped to see, but they were of genuine benefit to those who were, at the time, hurting the worst and needing it the most. **REACTA** leaders received repeated expressions of appreciation from members whose incomes were adjusted due to this effort. In truth, gratitude was also due to the CTA leaders who, after a fashion, recognized the existence of a dire need and saw to it that additional contributions were made to the retirement Trust that were needed to fund these improvements.

Most will recall that the rationale behind the 9/1/89 date mentioned above was that, prior to that time, retirement benefits were calculated on the basis of 2% of final compensation for each year of service to CTA. Thereafter, In accordance with negotiated collective bargaining agreements, 3% per year of service

was used. While an adjustment had been made effective as of Jan. 1, 2007, that brought purchasing power up to at least 60% of what it was for any retiree at time of retirement, that was 60% of amounts that had been calculated on much smaller final compensations and the 2% formula described above. Clearly, there was great need for purchasing power adjustments (PPAs) for most CTA retirees and for pre 9/1/89 retirees in particular.

For a complete review of what went on in efforts to achieve such adjustments, we strongly encourage you to dig out a copy of the Sept. 2010 "Special Edition" of the <u>REACTOR</u> and reread it carefully. If you can't find that document in your files, get on your computer, go to www.reacta.org., download and read it there, OR, as a last resort, call (559) 217-1201 leave a message and we'll see that you get a copy. It really is interesting stuff.

The point is for all concerned to understand that REACTA did/does have higher aspirations than those achieved. There should be a reasonable purchasing power floor for <u>ALL</u> CTA RETIREES (75% or 80% perhaps??) and it should <u>not</u> be dependent upon the year in which one retired nor the number of years served prior to retirement (so long as one is properly vested at the time of retirement). These concepts were totally ignored in the adjustments that went into effect as of 1/1/10.

If you are feeling the strain of lost purchasing power, even with the relatively low rates of inflation in recent years, there's good reason. Consider the chart that appears on the following pages.

CTA refuses to provide REACTA with information so that we can verify that pre-9-1-89 retirees are receiving correct increases. Note #1: The relative purchasing power percentages shown above apply only to those who retired from CTA AFTER September 1, 1989.

Note #2: CPI figures are those for the San Francisco, Oakland, San Jose area. They have always been used by the Trust in past calculations such as the above. The raw CPI# for Dec. 31 1988 was <u>122.6</u>.

Note #3: The CUMMULATIVE COLA column above reflects COLAs received by CTA retirees over the years covered. (i.e.: 0% from 2001 thru 2012; 2% in 2000; 1% in 1999; 0% in 1998; 3% in 1997, etc.)

#### ADDITIONAL THOUGHTS CONCERNING CTA RETIREE PURCHASING POWER (Post 9-1-89)

Just to give additional meaning to the numbers on the foregoing chart, let's use as an example someone who retired as a primary contact staff person (CSO Contract) in April, 1997 with 20 years of credited experience. His/ her salary at that time would have been \$83,306 per annum. His/her retirement allowance would have been 3% X 20 X \$83,306 = \$49984. (Keep in mind that while it has had only small adjustments in the last several years, the top of the PSO salary schedule is now \$136,884.)

Now, however, that allowance would have a value of \$49984 X .6911 = \$34544 in 1997 dollars...\$15440 less than its value at the time of retirement. In order for it to have the same value in 2013 as at the time of retirement, it would need to be adjusted as follows: \$49984 ÷ .6911 = \$72325, an increase of \$22,341.

Or—let's use someone who retired as an RRC Associate Staff in April, 1998 (CAS Contract) with 25 years of experience. Her/his salary at that time would have been \$4063 / month or \$48756 per year. Her/his retirement allowance would have been \$4063 X .75 = \$3047 per month or \$36564 per year. Now, that allowance would have a value of .6994 X \$3047 = \$2131 / month or \$25573 per year, a reduction of nearly \$11000 per year in 1998 dollars. In order to have the same value in 2013 as at the time of retirement, her/his retirement allowance would need to be increased to \$4357 / month or \$52280 per year. (+\$15,716)

It may be worth noting that, according to information submitted for the REACTA Directory, there are at least 88 folks who retired from 1990 thru 2000 and who are therefore below 75% in their purchasing power as of this time.

While it may not be possible to keep retiree purchasing power at a level existing at the time of retirement, it does seem reasonable to expect that a level of 75% or 80% might be maintained. This is not a matter of grasping for MORE but rather of seeking to keep what we have!
