President's Report

Dear Mr. King,

Later, I was made aware that this same document was sent to a number of other members of the Retired Employees Association of the California Teachers

Teacher's Association (REACTA) of which I am President. This letter is sent to you in response to that "outreach" and with a couple of purposes in mind.

First of all, I want to thank you and CSO for what we are assuming to be an effort to directly communicate with REACTA and its members. As you are well aware, many of our REACTA members were once members and, indeed, many were leaders of CSO and its predecessor, PSO. As such, we have a sincere interest in the ongoing affairs and activities of the current staff unions...not only CSO but also CAS. We don't know whether you intend to continue this effort to communicate, but we would hope so. As I'm sure you and all CSO members realize, our organizations hold many interests in common and <u>one day you will be us</u>. While we probably should acknowledge that some of our interests are slightly divergent, we should never the less be mutually supportive whenever possible. I would urge that we make every reasonable effort to this end and REACTA stands ready to engage in discussions/activities directed thereto.

Next, along the lines of the foregoing, I believe you are aware that I contacted your office by phone to extend an invitation for you to attend our annual Reunion/General Membership Meeting to be held at the Cambria Pines Lodge in Cambria, CA. on October 8-10, 2013. Just to make clear, our offer was to be at REACTA expense for travel, food and lodging and included either the entire or any part of the meeting. We would simply like to have the opportunity for our members who are present to meet and exchange views with you. The response that I got was that a scheduling conflict would not allow you to accept this invitation. We were and remain sorry to hear this. If there is any change in your schedule that would allow you to join us, please let me know immediately. If not and it is possible for one of your other elected officers to join us as a representative of CSO, please inform me of that. We will welcome them on the same basis as described above. Finally, we congratulate you and the other recently elected officers of CSO. The burden of leadership you have accepted is substantial and we wish you every success as you approach the challenges ahead.

Members To Determine REACTA Direction

According to unofficial <u>DRAFT</u> minutes of the August 12, 2013 meeting of the REACTA Executive Board, a motion was introduced by Vice President Lloyd Roberts as follows:

"That there be a discussion held during the morning session (10:30 AM) at the 2013 General Membership meeting at Cambria to be entitled "Wither Goeth REACTA" with Lloyd Roberts to introduce his concepts on changes in direction with full and open discussion to follow. Motion seconded by Bittle."

Discussion of the motion made clear that the Board was not endorsing or recommending a new direction as suggested by Roberts but that there is interest in hearing the points of view that might be expressed by the members present. Further, the President was directed to secure a moderator who would ensure that the discussion would be held in a "fair and balanced" fashion. Motion passed.

In informal discussions during a break in the meeting prior to the foregoing action, Roberts noted that the issue is whether REACTA should continue with the "advocacy" posture that it has assumed over the past several years, including an organizing committee, or if its emphasis should be primarily that of a "social" organization for members. This should make for a lively and meaningful discussion. All members are encouraged to be present and participate. It may well set the organization's direction in the months and years ahead.

DEVASTATING RIM FIRE NEAR & IN YOSEMITE NATIONAL PARK

REACTA members may be aware that several of our members live in the Sierra foothills, near the area impacted by the devastating "Rim Fire" that has recently been so much in the news. Among them are Linda and Lou Boitano whose home is in Copperopolis up in the forty-niner gold country. According to Lou, "We had some serious concerns for all of Tuolumne County and especially for the Pine Mountain Lake area where Browns, Romeos, and Roberts have a vacation cabin. Luckily, most all of the homes in PML were spared, including the Browns! We have had heavy smoke and ash in Calaveras County but no damage. So far, it has burned 255,858 acres and is 80% contained. It has burned into Yosemite National Park and is the 4th largest wild fire ever in California and at one time, there were over 5,000 personnel on the fire. It is still burning and will probably continue on into the winter months."

The Boitano's worked the emergency evacuation center at the Mother Lode Fairgrounds with the Red Cross and three Lions Clubs. Their club, Lake Tulloch Lions Club, had members help cook and serve the evacuees and firefighters along with the Sonora Lions Club and Oakdale Lions Club. "It was heart wrenching to see not only the people who were displaced but also the animals and it was heartwarming to see the huge numbers of donations of food and clothing. Our communities, along with businesses, really pulled together to help those in need."
