MAKING THE CONNECTION

Several years ago, at a REACTA Annual Meeting, there was a lively discussion about whether REACTA should make political recommendations. It was mentioned that if REACTA did so, it would probably have to register as a Political Action Committee and file a lot of forms with the state. Rather than create a PAC, it was decided to establish a Political Education Committee to inform our members about political recommendations made by California Teachers Association. Our success in carrying out our purpose is closely tied to CTA's success in the political arena. Let's review the purposes of REACTA:

 To support, protect and enhance the California Teachers Association (CTA) Employees' Retirement Benefits Plan and the CTA Employees' Health and Welfare Benefits Plan.

- 2. To communicate with members on matters of interest.
- 3. To perform tasks, functions, and activities as determined by the membership.
- 4. To provide social contact between members.

What is the connection?

Proposition 13 is on the March Presidential Primary Election ballot. It is a bond measure that will allow the state to reduce the cost of borrowing for public school districts. If approved, schools could see an increase in students acquiring additional teachers. If this is not approved, district borrowing costs will increase and it is likely that needed construction and renovation of public schools will be delayed. Faced with deteriorating

conditions, parents could pull their students from public schools and place them in private schools. The loss of students translates into the loss of district revenue leading to a reduction of teachers. Fewer teachers reduces CTA membership and leads to a reduction of CTA staff. When CTA staff is reduced, payroll decreases and contributions to our trusts declines. This downward spiral has the potential to reduce our benefits.

REACTA is committed to informing our members of political positions adopted by CTA. We obviously cannot tell you how to vote, but "communicating with members on matters of interest" is one of our core purposes.

IMPORTANT ENOUGH TO REPOST



The Presidential Primaries are not top two elections. They are party elections to select convention delegates pledged to the candidates on the ballot.

- Only registered Republicans can vote in the Republican primary
- Registered Democrats can vote in the Democratic primary
- Voters who are registered as No Party Preference (NPP) may also vote in the Democratic primary if they ask for a Democratic Party ballot from their county Registrar of Voters.
- People registered as Independents cannot vote in the Democratic or Republican primary. If you need to register to vote or change your registration, you have several options.

Long Time Teacher Advocate, and a great friend, passes. Hugh Boyle, was president of the then San Diego Teachers Association in the late 70s. Under his leadership, we negotiated our first contract soon after state laws allowed for collective bargaining.

Under Hugh's leadership the union went on strike in 1977. This was unchartered territory as such a strike had not taken place before under California's then new collective bargaining law. Despite a court order that put an injunction on the strike, Hugh persisted and continued to lead the strike work. For this he was convicted of contempt of court, with a fine of 40 days in jail and a fine equal to about 70% of a teacher's salary. SDTA/SDEA fought this decision all the way to the California Supreme Court which eventually invalidated the previous contempt convictions. With this win, Hugh and SDTA/SDEA established protections for educators' rights around strikes that we still enjoy today.

Last year, the SDEA Representative Council established the Hugh P. Boyle Lifetime Service Award, with Hugh as the very first recipient.

He was my golfing buddy in retirement, and great friend. Hugh, you will be remembered by many.

2020 MEDICARE REIMBURSEMENT

What is the Voter's Choice Act?

The California Voter's Choice Act (VCA) is a new law (PDF) passed in 2016 that will modernize elections in California by allowing counties to conduct elections under a new model which provides greater flexibility and convenience for voters.

This new election model allows voters to choose how, when, and where to cast their ballot by:

- Mailing every voter a ballot •
- Expanding in-person early voting
- Allowing voters to cast a ballot at any vote center within their county

Vote-by-Mail Ballots

In all VCA counties, except in Los Angeles County, every registered voter will receive a ballot in the mail one month before the election. In LA County, voters will receive a ballot in the

mail only if they have requested one.

Voters will have three ways to return their ballot:



- 1. Mail the ballot;
- 2. Drop the ballot in a secure county ballot drop box; or



3. Visit any vote center in the county.

Vote Centers

Traditional polling places will be replaced by vote centers. Voters will have the freedom to cast a ballot in-person at any vote center in their county instead of being tied to a single polling location. Vote centers look and feel like polling places, but provide additional modern features to make voting easy and convenient.

All vote centers will be open from the Saturday before Election Day through Election Day at 8 p.m. Some will be open a full 11 days, including the two weekends before Election Day.

At any vote center in a participating county, a voter may:

- Vote in-person
- Drop off their ballot •
- Get a replacement ballot
- Vote using an accessible voting machine •
- Get help and voting material in multiple languages
- Register to vote or update their voter registration

Which counties will be involved?

Amador, Calaveras, Butte, El Dorado, Fresno, Los Angeles, Madera, Mariposa, Napa, Nevada, Orange, Sacramento, San Mateo, Santa Clara, Tuolumne

California's other counties may choose to implement the VCA in the future.

FISCAL OVERSIGHT COMMITTEE (FOC) REPORT By: FELICE STRAUSS, FOC CHAIR

The newly formed committee is composed of Felice Strauss (BOD), Chair, Craig Nelson (CSO) and Mona Marra (CAS). We met on Wednesday, January 29, 2020 in Oceanside. Felice explained the BOD rationale for creating the committee. The initial issues the committee would be working on include: 2018 reconciliation, 2019 reconciliation, 2020 documents, legal documents, REACTA By-Laws, and recommendations to the BOD.

The committee reviewed the documentation from **2018** from FFCU and Felice Strauss. The Committee agreed that REACTA spent \$18,443.50 in 2018 and deposited \$15,333.25, using \$3111.05 in carryover funds from 2017. The FOC agreed on the 2019 Expenses to be \$19,733.68 with the majority of the costs going to 4 categories: the Exec Board (\$2907), scholarships (\$4000), trust meetings/legal fees (\$3374) and the Annual Meeting (\$5684). The FOC agreed that the 2019 deposits totaled \$18, 145.75. The BOD used carryover of \$1588 from 2018 to cover the added costs.

The Treasurer brought copies of the newly formatted 2020 adopted budget, 2020 expense reimbursement form, 2020 Income and Expenses and Membership payment list for 2020. No FFCU Statement for January 2020 was available at this time. We need to collect about \$500 more in member dues to make our \$16,000 dues projection. Other Income will include money collected for Angel tickets (\$50 each) and Other Expenses will include the deposit paid for the 20 purchased tickets.

The FOC made 12 recommendations to the REACTA BOD. These items were presented to the board at the 2/6/20 Conference Call Meeting. The board will continue to look at the recommendations and discuss them at their April Board meeting in Ontario.

The committee's next meeting is on Wednesday, April 29 at 10:00 in Oceanside. Felice provided committee members with a document to read on fiscal policies and procedures for organizations and showed 2 other documents on creating a template and guidelines.
