PAYMENTS AND REIMBURSEMENTS

How can REACTA help?

As REACTA President, I often receive calls from members on issues regarding our Health Trust. I usually suggest they call Earhart and Company, our trust's administrator. Please read Merri Boston's article later in The REACTOR for contact information. For many years Earhart has generally provided excellent service to active and retired beneficiaries. However, the most recent questions have specifically been related to retiree issues. I list them below since they may also impact you.

Premium Payment for Life Insurance – Many retirees have continued their life insurance benefit by paying a quarterly premium to Earhart. There is a concern that a retiree might forget, misplace a bill or not receive a bill due to an address change, and then risk having their policy lapse. Earhart does not have a system for automatic payments but you can set up your own auto-pay system with your bank. For example, I use Chase Bill-pay and set up quarterly payments to go directly to Earhart. I don't have to worry about missing a payment. You should check with your bank to see how to use this service.

Quarterly Reimbursement of Medicare Part B Premium – Earhart sends a letter to Medicare eligible retirees in the trust requiring you to send a copy of your Annual Social Security Letter which includes your 2022 Standard Monthly Medicare premium amount.

The Trust, through Earhart, reimburses you for this amount on a quarterly basis. When the premium increases, the reimbursement increases. For 2022 the amount of premium increase is \$24.60 per month. If your letter is submitted after April 1, 2022, you will not be reimbursed for the premium increase for the first quarter of 2022. I have contacted Earhart and asked them to provide me a list of retirees who have not submitted their 2022 letter from Social Security. Unfortunately, this information cannot be legally shared. I was informed that about 95% of our retirees submit their letter on time. If you are aware of a retiree having difficulty with this process, let me know and REACTA will try to assist.

Our insurances, through the Health and Welfare Benefits Trust, offer security and peace of mind for retirees. Please make sure you are getting all the available benefits.

WHO 'YA GOIN' CALL

The CTA Employees Health and Welfare Benefits Trust has several providers for our health benefits, including Anthem, Kaiser, Express Scripts, Delta Dental, and Vision Service Plan. If you or your dependents experience issues, have questions or complaints regarding claims, billing, payments or eligibility, please contact the Trust Administrator, rather than the provider.

The Trust Administrator, The William C. Earhart Company, will appropriately and expeditiously try to solve issues or problems, as they have direct contacts with the providers. They are available for your questions or comments from 8-5, Monday through Friday and have a dedicated phone number for CTA participants. The CTA Only phone number is (503) 460-5242 and Toll Free at (877) 396-2942. During the pandemic, they may be working from home, but will return your call quickly. You can also sign up at their website (www.wcearhart.com) to leave encrypted messages.

All calls from participants are documented in order to gauge the type and number of issues or complaints regarding the providers. The call logs, *with no identifying information*, are available for the Trustees to review, and are one of the ways for the Trustees to determine how well your benefits are working.

Also, please contact the Trust Administrator if you have a change of address; change of dependents; death or divorce; or have questions regarding travel and medical coverage.

CHIMPANZEE AND GORILLA TREKKING

In September 2021, I was able to make my third visit to Africa visiting Uganda and Kenya. My goal was to observe chimpanzees and mountain gorillas in Uganda and to go on safari in the Mara North Conservancy in Kenya.



I was able to spend two days of chimp trekking and habituation in the Kibale Forest in Uganda. I was fortunate to observe two communities of chimps with 24-30 members. Chimps have 52 ways of communicating with one another and share a 98% DNA match to humans.

After taking a bush plane, I arrived at the ancient Bwindi Impenetrable Forest, home to 280-320 gorillas living in 15 groups. Again, I spent two days observing two different troops of gorillas. The silverbacks I observed were magnificent creatures, extremely strong and weighing in the neighborhood of 350-480 pounds.

The experience was physically demanding as wherever the chimps and gorillas moved, I moved with them. The rainforest was extremely dense with lots of underbrush, logs and streams. I was accompanied by a guide, 3 trackers, 2 porters and 2 rangers. They were all incredible and made the trek enjoyable and safe. The experience was up close and personal and I would highly recommend it.

Uganda is an incredibly beautiful rural country that depends on subsistence farming. The Ugandans were quite concerned about climate change as they depend upon rain for watering their crops. Unfortunately, by mid-September the rain had not begun.

Ugandans are warm and friendly with a beautiful culture. It's heartbreaking that schools in Uganda have been closed for almost two years due to COVID.
