The Retirement Trust met on June 10. This was the second meeting of the calendar year marking the end of the first quarter.

The vast majority of the meeting addressed Economic Forecasts and the returns on the trust portfolio.


RV Kuhns Company, the trust's financial advisor went through various scenarios regarding both national and international markets and outlooks for future performance. Overall, the outlook was positive. Kuhns' representative informed the trust that the returns year to date have been slightly less than six percent.

The Actuary Report was the most interesting part of the meeting as Horizon Actuarial Services presented a long-term forecast of potential scenarios regarding the viability of the trust for the next ten years. All scenarios predicted that the Trust will be well into the Green Zone in the near future and fully funded by the end of the ten-year period.
