There continue to be new changes with the Health and Welfare Benefits Trust. The Trust has conducted an RFP (Request for Proposal) for a new third-party administrator due to retirements of key personnel at W.C. Earhart and numerous complaints from trust participants. The process has been completed and Zenith American Solutions ("Zenith") was selected as the new third-party administrator. According to the Trustees, Zenith will begin the process of assuming Earhart's role and will fully transition by September 1, 2023. REACTA learned that a key advantage of selecting Zenith is that Zenith will process trust claims, rather than Anthem, which should result in both better savings for the Trust as well as simplified processing for Trust participants. Zenith came highly recommended by both the Trust professionals and other clients of Zenith. We should be receiving more information as it gets closer to the transition date. Stay tuned....


Region 4 lunch was held at the South Coast Winery. **Jim and Mary Clark, and Karen Bost** were among the new members attending.

RETIREMENT TRUST MEETING REPORT

The Retirement Trust met on Thursday March 30 at the CTA Headquarters in Burlingame. The Trust is now on a schedule of having every other meeting in person with the rest on Webex.

In attendance were all the official trustees and many of their alternates. Additionally in attendance were representatives from the Trust Administrators, Investment Advisors, Legal Counsel, Auditors, and the Actuaries.

A significant portion of each meeting involves routine business matters such as reviewing and approving the minutes of the previous meeting and housekeeping chores such as review of compliance audits, approval of new retirement resolutions, evaluations of trust professionals' overviews of new laws that might affect the trust and similar matters.

Early in each meeting a report from our investment advisor goes over the trends in all the markets from Treasury bills to real estate investment to common stocks.

The actual Trust Portfolio is very diversified throughout a large number of investment options. The theory behind this diversity is that while some markets may go up, and others may go down, we basically hedge our bets that the trust will continue to benefit from up markets and offset any losses on a downturn.

Another major report is given by the actuaries from Horizon, the firm the trust employs to perform the required federal reports all retirement trusts have to file.

The good news from the Actuaries is that while the CTA Retirement Plan was in the yellow zone in 2022, we will now move to the GREEN ZONE for 2023

While clearly this is very good news for the Retirement Plan, the Trust will still need to be cautious in future years to monitor the policies of the Plan to insure stability. As everyone knows the economy is subject to wild swings and these vicissitudes can have an impact on our trust.

All in all, your retirement Plan is in good shape and you can look forward to our next report after the June meeting.
