- A parent meeting for all new participants is scheduled for October 10th, from 8:00-8:30pm at Central City Dance.
- Please note that due to factors such as age, skill level, height, costume availability, and size, your child may or may not be placed in the same role(s) as in previous years. By signing the agreement contract, you acknowledge and accept this possibility.
