# WCPA-GREN Africa Coordinator Meets with Mayor of Banjul

Ratification of the Constitution for the Federation of Earth by 25 Countries, will provide elaborate human rights protection for sustainable stability in Africa, in all countries of the world!

The GREN Africa Coordinator, Mr. Kenday "Ken" Samuel Kamara visited The Gambia in January, 2001. During Mr. Kamara's visit he had audience with the Mayor of Banjul, Hon. Samba Faal, a long time world government activist, and presented a plan for immediate action to be accelerated in the Gambia.

The Gambia, though very small, is quite relevant in Africa. The Gambia is home to the African Center for Democracy and Human Rights Studies and the OAU Commission on Human Rights.

The WCPA-GREN Africa Coordinator is optimistic that with the total cooperation of Mayor Samba Faal to take the lead in the Gambia GREN drive the GREN movement can make credible progress in the Gambia, and all through Africa. Plans are therefore underway for an All-Africa Ratification Strategy Convention be held at the Gambia in April 28, 2001. Complete details of this convention will be released in due course.

The GREN Africa Coordinator also made a trip up country while in the Gambia to sympathize with the plight of Sierra Leonean refugees. So deeply concerned about what is going on in Sierra Leone, Mr. Kamara undertook the fatiguing journey traveling 388 km from Banjul to the refugee town of Basse to donate bags of rice to refugees. In his statement during the donation ceremony, Mr. Kamara prayed for the truth and permanent peace to prevail in Sierra Leone. "It hurts to say, we are a threatened people. Threatened of extinction, that's why most of us have to flee. Our lives been made so miserable by years of unending political violence so complicated that we are perpetually the victims of this senseless conflict for power", Mr. Kamara articulated. He further admonished that "the lessons we have so far learned are so hard and caustic. Let's now start by having compassion for ourselves, learning to share, and to love one another."

#### More elaborately the GREN Africa Coordinator has this to say:

"This very small donation of rice I am presenting today to the most needy refugees here in Basse is to show how deeply concerned I am for our present circumstances. I wish I could get my institution to do more. Our global program is indeed deeply concerned about the multiplying problems across the globe, especially Africa. And we are not satisfied with the role of the United Nations in all these circumstances all across the world that have so badly affected us in Sierra Leone. That's why our institution is fully established to identify the weaknesses of the United Nations with the larger goal to replace it with a

# Charting Our Course

**A**t the Malta session of the Provisional World Parliament, one major direction was clear: to proceed with the series of GLOBAL EXPOSITIONS, and with the sessions of the Parliament in conjunction with the Global Expositions.

## The reasons are several:

1. THE GLOBAL EXPOSITIONS as described in our original brochure (see below) will be organized to feature primarily the products and potentials of "developing" countries, and for this reason are something that developing countries, including their governments, can get excited about for participation.

2. In particular, the GLOBAL EXPOSITIONS will offer a forum and stage to present and promote the opportunities for economic development and trade in and among all exhibiting countries, and so can be of great immediate economic benefit to developing countries.

3. Sessions of the Provisional World Parliament when organized and held under the canopy of the GLOBAL EXPOSITIONS, can solve the visa problem for delegates to the Parliament. Because of the economic benefits expected from the GLOBAL EXPOSITIONS, the host and sponsoring nations may be expected to grant visas to delegates who will come to the Expositions, and who can at the same time attend sessions of the World Parliament – since the World Parliament will be both a sponsor and an exhibitor at the Expositions.

4. THE GLOBAL EXPOSITIONS, as we propose, are not merely "trade fairs", they are for the purpose of dramatizing the potential of developing countries in all aspects, and for expanding opportunities in life during the Twenty-First century. Each nation will be encouraged to present its 5-Year Plan to serve the many needs of people for peaceful living.

5. As the way to finance development, and all useful activity, the GLOBAL EXPOSITIONS will provide the opportunity to expedite introduction of the New Global Finance and Credit System as defined by World Legislative Act Number Eleven. The introduction of this new finance and credit system, which can expand rapidly, will free developing countries from the limitations and dictates of dependence on loans and investments from present dominating sources.

6. In this favorable atmosphere, the GLOBAL EXPOSITIONS can clear the way for many countries to concur at the same time on ratification of the Constitution for the Federation of Earth, which in fact is a priority for implementing the new Global Finance and Credit System.

7. Together with ratification of the Constitution for the Federation of Earth and introduction of the New Global Finance and Credit System, it then becomes possible to inaugurate the first dozen or so functioning World Ministries of the World Government under the Constitution for the Federation of Earth. The beginning World Ministries can each have exhibits at the GLOBAL EXPOSITIONS to explain their work.

## HOW EACH GREN ORGANIZATION CAN HELP:

The plan for the GLOBAL EXPOSITIONS, with sessions of the World Parliament included, gives work for GREN organizations in all countries to carry out, especially for GREN organizations in developing countries. The work includes the following:

A. Help convince national governments and national legislatures to co-sponsor the GLOBAL EXPOSITIONS, and to plan and prepare exhibits. Each co-sponsoring national government is invited to name a representative to the organizing Committee for the GLOBAL EXPOSITIONS. Sponsorship of the Global Expositions should be expedited among member nations of the Group of 77.

B. Help obtain exhibitors for the GLOBAL EXHIBITIONS. Major exhibitors may also be invited to name representatives to the Organizing Committee for the Global Expositions.

C. Find exhibitors who will help pay expenses of delegates to sessions of the Provisional World Parliament, held at the Global Exhibitions.

D. Prepare exhibits of Non- Governmental Organizations for the GLOBAL EXPOSITIONS.

**Locations** for the first three GLOBAL EXPOSITIONS are now being explored and negotiated. This includes possibilities for South Africa, India, Cuba and China. Other locations may be considered among the Group of 77.

For GREN ORGANIZATIONS and individual members who will take up the work of helping to promote the GLOBAL EXPOSITIONS, a special organizing packet is being prepared, which will include a color brochure, all details, and initial preliminary sign-up forms for exhibitors. Meantime, please refer to the color brochure previously sent to all GREN organizations.

# THE FEDERATION OF EARTH

The old Indian Philosophy of 'VASUDHAV KUTUMBKAM' means the whole world is one family. Translated into real life this means use of all resources for the betterment of ALL.

Later however, when Adolf Hitler called for a unified Europe reflecting his vision of the world to be, people called it mis-placed as his vision of a unified Europe was based on destroying the self-confidence of nation states.

We have since come a long way to a functioning European Union and now we have before us a call for a unified world for the welfare of all Humankind- THE FEDERATION OF EARTH.

The Federation of Earth is founded on the underlying principle of respect for the humankind and to provide uniform opportunities to all humankind.

Unlike the genesis of European Union of today flowing from the Marshal plan, the fear of USSR, the Schuman Plan etc. - all of which shows that the idea of a unified Europe sprang from political and military necessities and the artificial distinction of the North & the South.

On the contrary, the Federation of Earth is driven by the principle of achieving welfare of the humankind.

The out look of the Federation of Earth is global and should address itself to global needs and actions required to achieve the welfare of the humankind.

In this regard therefore the Constitution of the Federation of Earth achieves immense importance and the same should be ratified by all nation states.

But before we call upon all nation states to ratify, accept or up-hold the Constitution for the Federation of Earth, it is necessary that certain issues of global relevance are deliberated and a globally accepted position on each of such issues be arrived at in order to cause all nation states to accept the same.

Some of these issues of immense global relevance are:

- i. World legislation to obtain world disarmament.
- ii. Protection of human rights on the global scale and constitution of the World Ombudsman.
- iii. Right of peaceful world assembly
- iv. Sustainable development and employment for all
- v. Eradication or finding solutions

of ethnic conflicts worldwide.

The balancing act between achieving world disarmament and addressing the defence needs of various nation states, all of which is linked. Peculiar regional conflicts is a task to be reckoned with by any proposed legislation proposing to achieve world disarmament.

Any legislation for world disarmament should have a flexibility to address and resolve regional disputes, the resolution of which is a pre-requisite for getting concurrence of the nation states for any such legislation.

The only answer to the problem of achieving world disarmament is to create the political will among nation states wherein the defence needs of the nation states be substantially reduced.

Regional security perceptions, threat perceptions of the nation states will therefore be required to be specifically addressed.

Globally policing by a constituted body acceptable to all nation states is therefore essential.

It is important that all conflicts involving more than one nation state should necessarily be referred to the Global policing body and at the same time the role of the global policing body should only be limited to act as a deterrent to any nation state against creating a security threat or inflicting a war upon any other nation state.

It is therefore important that even before proceeding to resolve all the aforesaid issues, the political will of having/achieving a no-conflict world and agreeing to submit to a Global policing body should be formed by all nation states.

The absence of a political will to this effect by any nation state is sufficient to

derail the process of achieving thim mentation of a world legislation to obtain world dis-armament.

Uniform global understanding will also require to be achieved among al nation states in relation to protecting the global environment.

Globally accepted benchmarks on emissions and permitted pollution levels will be required to be achieved.

Researching development towards cleaning up of the environment and generation of oxygen supply is a natural step in this regard.

This again leads us back to the issue of policing and implementation of uniform global benchmark/standards relating to environment protection.

Similarly, human rights which has been an issue of global concern and interest, will need to be addressed globally.

To start with this would require a uniform perception of the definition of what constitutes human rights which should be accepted by all nation states.

A world Ombudsman, a body created to identify human rights violations globally should be constituted.

The world Ombudsman should to start with identifying all human rights violations and advise the nation states to rectify the same within a prescribed time frame.

Upon the failure by the nation states to do so the World Ombudsman should invite the Global policing body to intervene and rectify any human rights violation and restore human rights.

A right of peaceful world assembly should constitute a human right available to all of the human kind.

Therefore, a right of peaceful world assembly should be available to all

humankind and any breach of a right of peaceful world assembly by any nation state should warrant the intervention of the World Ombudsman followed by the Global policing body in the event of continuing breach.

The Federation of Earth should also address the issue of providing employment opportunities to all.

Development of nation should be driven by the need to increase employment opportunities.

A balancing act between mechanization and labour intensive means of production will be required to be achieved but not at the cost of change and improvement for development of Humankind.

Related issues of a uniform economic policy and common global currency are issues that need to be more closely examined. World disarmament, human rights and reduction of political/ethnic

conflicts cannot be achieved unless the same are balanced as economic needs of nation states.

The European Union, can definitely be an eye opener in this regard.

A lesson can be learnt on handling sensitive issues on a inter-governmental basis from the functioning of the European Union.

The road to achieving a full fledged unified global village called the Federation of Earth will require to first achieve the handling each of the sensitive issues raised above at an inter-governmental level.

The merger of nations into a global village union can only be achieved after the nation states develop confidence in the functioning of global bodies at inter-governmental levels.

This would create right political will towards achieving unified global village union called the Federation of Earth.

To summarize, making the Federation

of Earth a reality will not be easy and some painful decisions may need to be taken by all nation states.

The historical achievements of the human kind, their varied culture, immense energy, skill and adaptability ought to be fully utilized in a unified global village union where all humankind is equal and has equal protection of the law.

In the late 18<sup>th</sup> century, Edmund Burke describes the once mighty Spain as a "whale stranded upon the coast of Europe".

If sufficient will is not shown to the Constitution of the Federation of Earth over the coming years, some future historian may sadly liken humankind to a whale stranded upon the coast of Earth.

November 2000

That the "Manifesto to Begin World Government Including 70% of Earth Surface" be given the additional designation of World Legislative Bill Twelve (#12), in order to facilitate its codification within the scheme of the whole of world legislation adopted by the Provisional World Parliament .

Unanimously passed by the Fifth Provisional World Parliament, Meeting in Malta.

## New Humanity Center in Kalamata

This Fifth Session of the Provisional World Parliament hereby resolves to study the feasibility of the offer of the New Humanity Center in Kalamata, Greece, to accept the New Humanity Center as one of the campuses of the World University System.

As soon as is feasible, representation from the World University System shall arrange to visit the New Humanity Centre for research and possible collaboration. These representatives may be Members of the World Parliament, Members of the Board of Trustees of the Graduate School of World Problems, or persons directed to do this by the Board of Trustees.

# Resolution to Elaborate and Build the Work of Standing Parliamentary Commissions

*Resolution introduced by the Youth Movement for Peace and Non-Violent Communication  
Adopted by the Fifth Session — 27 November 2000*

To accept and assist the Global Ratification and Elections Network (GREN) for implementing its vital functions, this Fifth Session of the Provisional World Parliament hereby resolves to improve the world parliamentary intersession communication system. Furthermore, this Parliament hereby forms and assigns the work of the Standing Parliamentary Commissions, based upon the primary commission selection stated by certified delegates in their delegate registration forms.

These Commission Members shall communicate networking hubs, insofar as possible, via the 10% of GREN organizations which have electronic mail access. From these hubs, GREN organizations shall form phone and paper mail local networks to intercommunicate the preliminary work of the Commissions.\*

Commissions shall consider drafts of legislation for suitable elaboration prior to the next session of the Provisional World Parliament, so that legislative proposals shall be of quality and delegates will already be apprised somewhat of possible legislative bill content, even before the required initial readings made during bill introduction in Provisional World Parliament Sessions.

Furthermore, this Fifth Session of the Provisional World Parliament encourages the Standing Parliamentary Commissions to establish sub quarters worldwide, with particular emphasis on those locations, such as in Sub-Sahara African countries, where the Provisional World Parliament Delegate base is already strong.

Finally, this Parliament encourages trade organizations wherein youths will participate and raise funds for the Parliament and youths also benefiting in the trade.

## Strategy Committee Meets: CORGEM takes priority

A WCPA Strategy Committee meeting was held at headquarters February 17 - 18, 2001. Various issues discussed, but what took priority was the CORGEM Strategy to facilitate the establishment of World Government.

Eugenia Almand presented the progress on the curriculum project and on the preparation for the Core Group Empowerment (CORGEM). The curriculum is expected to be completed by May. The course designs for World Government Philosophy and World Government History have been completed by Terence Amerasinghe in Sri Lanka. Course design for study of the Earth Constitution, World Legislation, Rules of Order, Legislative Drafting and Climate Change are being prepared by Eugenia Almand. She will have this prepared by September of 2001. Professor Philip Isely is preparing training for the presentation of the program to national administrations, for the creation and administration of the world ministries (public administration) and for the financial independence of participants.

Recent reports of WorldWatch Institute, Science magazine and other reputable magazines which report on climate change have come around to report a differential climate change, though the term used currently is called "out-of-phase" climate change. Eugenia reported the gist of the reports, which is that Greenland and Northern Europe is getting colder and wetter, while Antarctica and everywhere else is getting warmer. The thermohaline circulation of the North Atlantic is being shut down by freshwater runoff in the arctic coastlands. This implies further cooling for Greenland, Northern Europe and possibly the Laurentian Shield. Solid ice shelves in Antarctica may break off from the warmer seas, releasing many cubic kilometers of fresh water from fluid ice dammed above the shelves, which could in turn raise sea levels twenty feet in twenty years.

Eugenia Almand also reported development of the WCPA-GREN database. Including the progress of the improved communication for the intersession work of the working commissions of the Provisional World Parliament. So far in the study, approximately 6% of PWP delegates have live e-mail connections. The working commissions and intercommunications for GREN will be built from these.

Participating WCPA-GREN activists during the 2-day deliberations were: Max Steele (Chair), Eugenia Almand (Secretary), Dr. Glen Martin, Kenday "Ken" Samuel Kamara, and Sarwar Alam. Professor Philip Isely participated during recesses in conferences held with him, and reports made of organizing committee meeting proceedings. ■

# Palestine Council for GREN on the events since the outbreak of the Al Aqsa Intifada

On behalf of the Palestine Council for GREN I am writing to appraise you of developments here in Palestine over the past seven weeks and since the outbreak of the Al Aqsa Intifada. The visit to Al-Haran Al Shariff by right wing politician Ariel Sharon accompanied by some 3,000 police on September 26th was an act of extreme provocation to the Muslim world. However, the series of events since then, specifically the brutality and use of excessive military force, and its "shoot to kill" policy which the Israel army has deployed against unarmed civilians, including children has resulted in the deaths of over 200 civilians and over 7,000 injured.

For the past nine years the Palestinians have faced the intransigence of successive Israeli governments, and their refusal to adhere to signed peace accords, namely Oslo-Wye River Plantation and the Sharm El Sheik Agreements. This is a process

that cannot go on indefinitely with no tangible results in terms of the implementation of UN Security Council 242, and 338, and the full withdrawal of the Israeli forces to the pre-1967 borders.

In their determined resistance to the ongoing Occupation and Palestinian areas, and institutions have been bombed from the air, and civilians targeted with ground rockets and live ammunition. The towns and villages of the West Bank and Gaza have been placed under siege, and air and sea-ports closed. Borders and main access roads are arbitrarily closed making it impossible for workers to reach their work places and essential services, particularly educational establishments and health services.

The Palestinian people are resolved to gain their liberation and establish an independent sovereign State of Palestine with Jerusalem as its Capital. In this very critical time as the Palestinian people are facing atrocities,



we turn to our colleagues and friends in the World Constitution and Parliament Association to stand alongside and support us in our struggle in order that we achieve our independent and Sovereign State of Palestine, with Jerusalem as its capital. We call to you from Jerusalem, our holy city that is under siege in our belief that you can greatly assist us to achieve our goals.

## Declaration on Palestine adopted by 5th Session of the Provisional World Parliament Malta, 26 November 2000

This Fifth Session of the Provisional World Parliament reaffirms its position of recognizing and supporting the right of the Palestinian people to establish the State of Palestine in its national soil, with Al Quds Al Sherif (East Jerusalem) as its capital, on the border of 1967. (UN 242-November 1967, UN 338 -September 1969).

It is the resolution of this Fifth Session of the Provisional World Parliament to recognize Palestine as a nation within the World Federation upon ratification of the Constitution for the Federation of Earth and agreement to abide by the World Law established under the Earth Constitution. Upon preliminary ratification of the Earth Constitution by the official authority of Palestine, Palestine will be recognized as an equal member among the Nations of the Earth Federation. Confirmation by an additional decision by future Sessions of the Provisional World Parliament shall not be necessary.

It should be noted that with Preliminary Ratification, the people of Palestine reserve the right for final ratification, as specified by Article XVII Section A of the Constitution for the Federation of Earth. This is the assurance of popular sovereignty within the context of independent World Government.

We direct Israel, and all nations, to abide by the Constitution for the Federation of Earth and World Legislative Bill #1, to outlaw all nuclear weapons and other weapons of mass destruction.

The Provisional World Parliament urges Israel to adhere to the principle of land for peace. Israel must end the occupation of Palestine land. Israel must comply with the prior agreements and United Nations resolutions regarding the right of return of refugees, Israeli withdrawal to pre-1967 borders with Al Quds Al Sharif (East Jerusalem).

### We specifically express the following:

We condemn the atrocities against the Palestinian population committed by Israeli administrations, especially the 'shoot to kill' of civilians, including children, by military forces and settler militias; helicopter gunfire and air to ground rockets.

We deplore the current siege of Palestinian towns, villages and roads, which severely curtails the movement of people to their homes, places of work, access to essential services, and the closure of sea and airports. Such actions are an affront upon Palestinian dignity and the dignity of human beings everywhere.

We fully support the right of return for Palestinian refugees to return to their homes if they wish, to receive compensation. (UN 194 - December 1948)

We reaffirm and defend the territorial integrity of the Palestinian land; Al Quds Al Sharif (East Jerusalem) is indivisible from the Palestinian lands of 1967.

And finally, but not least, the World Parliament extends its regards to his Excellency Yasser Arafat for his endless efforts to achieve a just and durable peace in the region and for his initiatives to defend the supreme norms and values for Humanity. A statesperson with these qualities will surely win freedom. ■

# MANIFESTO: WORLD GOVERNMENT BEGINS WITH MORE THAN 70% OF EARTH INCLUDED

## WHEREAS-

**F**ederal World Government is already at least 48 years overdue, since it should have been established at the end of World War II instead of the delusory United Nations organization;

Because of this delay, a multi-trillion dollar nuclear arms race has ensued, resulting in extreme insecurity for all inhabitants of Earth, and the radioactive poisoning of the environment spreading for thousands of years, while hundreds of wars have raged and dozens continue at this moment;

During the tenure of the United Nations, almost all individual nations, both large and small, new and old, have continued arming with the latest technology for war and destruction, which has robbed all people of all countries of many trillions of dollars and vast resources which could otherwise have been used to serve peaceful human needs, while guns and violence spread everywhere.

Environmental destruction and degeneration has taken place almost everywhere, on land, in the sea, and in the atmosphere - gravely threatening Earth's food supply - and is rampaging across all continents because no agencies of global scope are in control;

In particular, climate changes of catastrophic consequences have begun, due to multiple uncontrolled factors, including: the continued burning of fossil fuels which adds daily to the climate changing load of carbon dioxide in the air; destruction of the rain forests and of the phytoplankton in the oceans, which are together the principal lungs of Earth and necessary for survival of the people of all lands; and the universal depletion of soil fertility;

Meanwhile, most of the people of Earth are condemned to live in poverty, squalor and spreading diseases because of the prevailing global economy organized to maximize private profits, under which the gap in incomes becomes ever greater between the minority of affluent people and the great majority of deprived people in most of the countries of Earth;

Instead of expanding opportunities for good living, life on Earth for most people is fraught with multiple and simultaneous problems and crises situations, of diverse sorts too numerous to list here, which continue to accumulate and become worse with no way to arrive at good solutions;

Into this scene, because of continued lack of direction for human civilization on Earth, thousands of protest movements and hundreds of proposals to remedy the situation have multiplied over the years, resulting in great confusion about what to do.

## THEREFORE-

**W**e believe the time has come for very decisive action to cut through the confusion and delay and establish positive direction to get the common affairs of the inhabitants of Earth under responsible and democratic controls for the mutual and equitable benefit of everybody: This requires democratic federal world government.

For this purpose, a Constitution for the Federation of Earth has already been prepared by delegates from all continents, working in four sessions of a World Constituent Assembly

from 1968 to 1991. The Constitution for the Federation of Earth is ready for immediate ratification and implementation, to replace the grossly defective U.N. Charter which does not represent the people and has very limited abilities to solve or mitigate any problem.

*Accordingly, to begin Federal World Government under the Constitution for the Federation of Earth, we who are delegates from non-governmental organizations, meeting together in the Fourth Session of the Provisional World Parliament, organized under Article 19 of the Constitution for the Federation of Earth, do hereby proclaim and take the following action:*

**B**y this **MANIFESTO**, acting on behalf of all inhabitants of Earth, we hereby take possession of all oceans and seabeds of Earth from 20 kilometers offshore of all land masses and island territories of existing nation-states, thus comprising at least 70 percent of Earth for the beginning of World Government, but reserving the first 200 miles offshore for the priority fishing rights of adjoining countries.

We also take possession on behalf of all inhabitants of Earth the territory of the Southern Polar Area, known as Antarctica, together with all other territories and islands which are not already claimed under the recognized ownership of nations; and together with all airspace above the oceans and Antarctica, and all stratospheric space of Earth above the nations and oceans, and together with Earth's moon.

## ONE

**W**e take this action in accordance with Article XVI, Section A, of the Constitution for the Federation of Earth, which defines World Territory; and as a supplement to the implementation of World Legislative Act Number Three for the ownership and administration of the oceans and seabeds adopted on 12th September, 1982, by the first session of the Provisional World Parliament, which takes precedence over any later conflicting claims to the oceans and seabeds.

## TWO

**W**e further invite and urge all nations and national governments wanting to share the benefits to be derived from administration of the oceans and seabeds as the common heritage of humanity, and wanting to enjoy all of the manifold benefits to be achieved under World Federation and World Government as provided by the Constitution for the Federation of Earth, to quickly join the World Federation by ratification of the Constitution for the Federation of Earth, thus joining together under a Federal World Government which starts immediately with more than 70 percent of Earth and may easily include 90 percent of Earth before the year 2000.

Each nation which joins may immediately select a delegate or delegates to the House of Nations of the World Parliament, and shall arrange for elections by the people to the House of Peoples of the World Parliament, as provided under the Constitution for the Federation of Earth. Both Houses shall convene as the First Regular Session of the World Parliament for World Government as soon as 25 nations

have ratified the Constitution for the Federation of Earth, together with a duly composed House of Counselors.

Until 25 nations have ratified the delegates to this Fourth Session of the Provisional World Parliament shall serve as the Provisional World Parliament of a Provisional World Government, and shall expeditiously begin the administration of the oceans and seabeds and all other world territory claimed under this Manifesto.

## THREE

As a First Act of Administration, in order to help rid the Earth of nuclear weapons and all weapons of warfare, so that a peaceful world society to serve human needs may be developed, we do hereby outlaw and forbid the transport by ocean or through the air space above the oceans or through the stratosphere above national air space, any and all nuclear weapons and components, any and all weapons of mass destruction, all chemical-biological weapons, all other weapons for the conduct of war, all ammunition and supplies and parts for all such weapons, all means used for the delivery and transport of such weapons, and all soldiers, marines, officers, pilots and all other military and support personnel for the use, command, operation, installation and maintenance of such weapons, ammunition, supplies, and means of delivery and transport.

Any violations of prohibited shipments or transport shall be punished by fines imposed by the World Government or Provisional World Government in amounts equal to 100% of the value of items shipped or transported and \$5,000 for each person transported. Such fines shall be applied against the sellers, shippers and transporters. Non-payment of fines after ninety days shall result in cancellation of equal value of claimed debts owed by developing countries which join the World Federation and ratify both this Manifesto and the Constitution for the Federation of Earth.

## FOUR

As a Second Act of Administration, for the purpose of supplying ample financial credit for development, for industrial and commercial enterprise, for social and public services, and for the care of the global commons, including both public and private projects and endeavors, we immediately activate World Legislative Act Number Eleven (as amended) for an Earth Financial Credit Corporation, by pledging the total wealth of the oceans and seabeds behind all creation of financial credit per World Legislative Act # 11.

Revolving lines of credit shall be extended to each country or nation ratifying the Constitution for the Federation of Earth, on the basis of not less than one billion dollars for each million of population. The lines of credit, per World Legislative Act #1, shall be in Earth Dollars, which shall be made available immediately upon ratification and may be used immediately for all domestic purposes, and may be used in world trade wherever the new Earth Dollar accounting system is accepted. There shall be no requirement or priority for privatization. The public sector shall have full access to such financial credit for all desired purposes, and to guarantee full employment for all. Credit under this section of the Manifesto may never be used for military purposes, nor for production of energy by nuclear reactors or the burning of fossil fuels. Apart from both the immediate and long term benefits of supplying ample financial credit for all peaceful endeavors to supply human needs, and to sustain full employment at good

standards of living for everybody while protecting the environment, an immediate purpose of this section of the Manifesto is to free all countries and peoples from the financial limitations, forced restructuring, and austerity regulations imposed by the International Monetary Fund, the World Bank and other financial sources; and to free nations and peoples from the fear of being cut off from current financial sources when they join the World Federation.

## FIVE

As a Third Act of Administration, we hereby activate World Legislative Act # Six (as amended) for an Emergency Earth Rescue Administration, to cope with the on-rushing global climate crisis, and at the same time solve or help solve dozens of other environmental problems.

When World Legislative Act #6 was adopted at the second session of the Provisional World Parliament in 1985 the climate crisis was being unscientifically interpreted and reported as "average global warming" which was expected to melt ice caps and raise sea levels over a hundred years or so. The true nature of the climatic crisis is seen when measured not by averages but as a "differential greenhouse effect", with rising temperatures at lower latitudes and lower temperatures at higher latitudes, due to the conveyance of moisture evaporated from warming oceans and land at lower latitudes, and brought to the higher latitudes where the moisture condenses, forms cloud cover, then precipitates as rain and then increasing snow. This is what is actually happening.

The recent revelations by study of ice cores retrieved from Greenland and other locations, showing weather and temperature changes over 200,000 years or more, are conclusive evidence of sudden and extreme climate changes when an interglacial period ends and a glacial period begins, thus upholding the thesis defined in World Legislative Act #6. To prevent the sudden and catastrophic climate changes of this kind, which may be expected at the end of the current interglacial period which has already lasted about 11,000 years, during which all of human civilization has taken place. World Legislative Act #6 stipulates a series of emergency actions designed to recapture the excess amount of climate-changing carbon dioxide in the atmosphere, together with numerous other remedial actions, which together may sustain and continue the friendly climate conditions of the present interglacial period, and prevent the quick onset of another long-lasting ice age. Unless the climate changing process, already underway, is quickly reversed, agricultural production over much of Earth may become so disrupted that the human carrying capacity of Earth may be drastically reduced and so result in the starvation of many hundreds of millions of people (or even several billion) in a very short time, with the consequent reduction of modern civilization to chaos. Because of the enormity of the climate crisis, which is global in scope and threatens the lives and welfare of everyone on the planet, a globally coordinated rescue campaign is required which will require a trillion dollars, or more, a year for the next 50 years, employing all available personnel. We urgently plead that the national governments of all countries immediately join the World Federation by ratifying the Constitution for the Federation of Earth, so that World Legislative Act #6, and any needed supplementary global legislation, can be rapidly and fully implemented.

**W**e, the delegates of the Fifth Provisional World Parliament at Malta, meeting under the auspices of the Constitution for the Federation of Earth in November 2000, do hereby affirm the following resolution:

In the light of the fact that many people today express a fear of what they call "big government," a sentiment that makes them hesitate before the idea of world government out of concern that local autonomy and individuality may be diminished,

In the light of the fact that many people today express a fear of what they call "bureaucracy," a sentiment that individual freedoms may be curtailed under a global federal bureaucracy which might require permits for everything and anything people wish to do,

In the light of the fact that some nation-states today express a fear that world government might diminish their integrity and autonomy as individual nations, which they now claim is defended under the concept of "national sovereignty,"

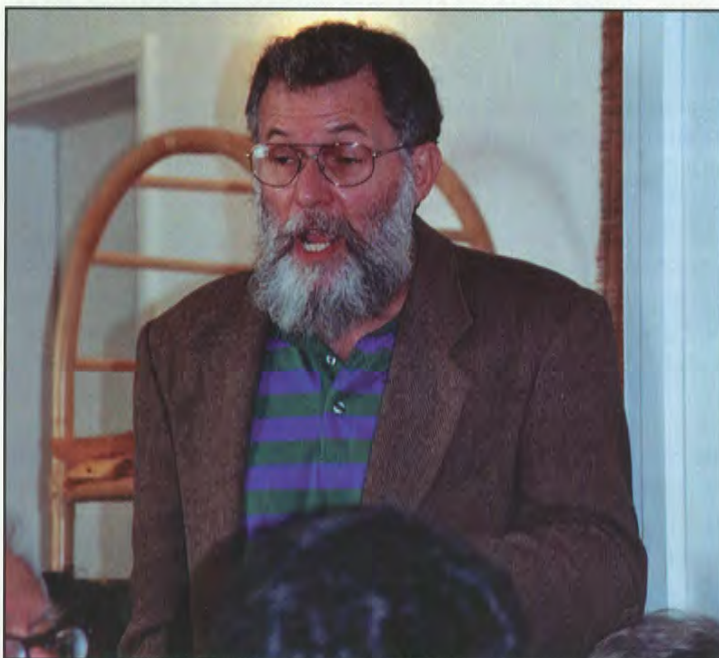
We wish to emphasize that the Constitution for the Federation of Earth is carefully written to eliminate these potential dangers of world government. The Preamble of the Constitution asserts that "the principle of unity in diversity is the basis for a new age - when war shall be outlawed and peace prevail; and when basic human rights and responsibilities shall be shared by all without discrimination." The Constitution is written with the protection of individuals and the integrity of nations in mind, and creates a separate branch of government known as the World Ombudsman to explicitly prevent world government from violating the rights and freedoms of individuals, groups, and nations.

At this Provisional World Parliament, we assembled delegates wish to emphasize these principles embodied in the world constitution by formulating a guideline for future legislation:

The foundation of a secure future for humanity and our natural environment is genuine democracy for all citizens of the planet. This means the empowerment of citizens from the local level to the global level through a social infrastructure providing education and other institutions aimed at

making possible effective participation of citizens in democratic decision making.

We wish to emphasize that world government must be a federal system that preserves sufficient local autonomy for citizens to concretely work on the local level for a broad range of economic, political or social goals.

Citizens must be free to work for justice and the redress of grievances on all levels from local, to national, to global.

They must be free to pass local laws to address their particular concerns within the larger democratic framework of a world government that ensures universal political, economic and social rights to all.

Citizens must be encouraged by world government to recognize and challenge undemocratic institutions and practices at every level. The Constitution as quoted above emphasizes "responsibilities" as well as rights. World government must encourage a broad range of active citizen involvement in local, national, and global issues.

Active citizenship and taking responsibility is not fully accomplished through periodic voting, but through attending public forums, organizing, signing petitions, protesting, street theater, non-violent civil disobedience, writing articles and editorials, contributing money, teaching, supporting and establishing alternative media, and many other ways. The active involvement and critical questioning upon which the democratic process depends both permits and encourages each citizen to take active responsibility for good government.

Similarly, nation-states must be protected from unwanted imperialism by other nation states, or by world government itself, whether this takes the forms of cultural, economic or power based attempts at coercion. The integrity and autonomy of individual nation-states can only be effectively protected by the democratic authority of the whole of humanity, which is the only legitimate sovereignty on earth. Under the principle of unity in diversity, a truly federal system emphasizing the diversity of individuals, peoples, and nations is to be promoted and protected. This resolution emphatically states that future legislation enacted under the Constitution for the Federation of Earth should conform to the principles outlined herein. ■

# Only Federation of Earth meaningfully addresses challenges facing mankind in the new millennium!

**D**istinguished Excellencies, Members of the Diplomatic Corps, Distinguished Guests. Participants and Dignified Fellow World Citizens, Good Morning. I am glad to be with you all at this epoch-making 5th Session of the Provisional World Parliament. I stand here this morning as a citizen of the World with heartfelt wishes for a world that is genuinely tolerant of 'DIGNIFIED HUMAN EXISTENCE'. This 5th session of the Provisional World Parliament like all previous sessions has double significance in that it seeks firstly to address in a participatory, the pernicious problems facing mankind today and secondly, to put in place concrete programs, processes institutions to facilitate the implementation of the CFE. It is against this background that I would want to register my profound thanks to our revered touch-bearer Professor Philip Isely, his team, the Government of Malta and to all those who in diverse ways contributed to making this gathering a reality.

Following the establishment of the United Nations in 1945, there was an air of considerable optimism for peace, democracy and prosperity for majority of the World Citizens. The reality of the situation today, however, proves the opposite. The UN is for example, today widely known for its inability to resolve the manifold problems of mankind (poverty, ignorance, weapons of mass destruction and war) on an enduring basis.

It was in view of this UN inability to adequately resolve world problems among many other reasons that a group of people committed to the task of improving mankind decided to come together to vigorously pursue the campaign for the implementation of the Federation of Earth. The purpose of my presentation is to contribute albeit in a modest way to the on-going efforts to implement the CFE. It will seek to prove the hypothesis that it is only the Federation of Earth that could meaning-

fully and adequately address the numerous challenges being mankind in the new millennium. With this purpose in mind, I will try to do three things. Firstly, to briefly discuss some of the major ideals and principles of the Federation of Earth. Secondly, to advance reasons why there is need for the speedy implementation of the CFE. Finally, to show how the practical implementation of the CFE can be realized.

The urge to establish World Government or the Federation of Earth is not a recent human craving but one of very old vintage traceable as far back to the beginning of organized human settlements. Man's quest for communal existence in order to achieve desired goals through collective action was noticeable for example, during ancient times. However, 1968 will always go down as a very historic date in the evolution of the ideal of World Government. The year registered the beginning of effective practical steps to convene the first working session of World Constitutional Convention and People's World Convention at Interlaken, Switzerland and Wolfach, West Germany.

The whole notion of World Government or Federation of Earth is predicated on the popular belief that collectivism should reign supreme over individualism if the complete happiness of HUMANITY is to be ensured. It is basically implying that there is need firstly for genuine, serious and practical initiatives by all citizens of the world to ensure the equitable distribution of the World resources in a transparent and accountable manner. In this regard, the Federation of Earth is putting premium on serious efforts to ratify and implement Legislative Bills number 1 and 11 that talk about the ownership of the world's oceans and sea beds and the Earth Financial Credit Corporation. Federation of Earth also presupposes

the existence of a world free of wars, arms and instabilities. Consequently, it is advocating for convergence rather than divergence, cooperation and tolerance between national and international actors. Against the above background, it is extremely urgent that nations all over the world should work assiduously for the speedy implementation of the Federation of Earth. It is a task even more urgent for developing African States. This is the case because of some the following reasons:

Firstly, the overall economic performance of small developing African countries over the years been less than satisfactory. The incidence and depth of poverty have for example been increasing ever since the early 1980s. More than half of the African people live below the poverty line. Estimates are that if current trends continue Africa will perhaps be the only continent in which poverty will increase in a dramatic fashion both in absolute and in relative terms. Of 47 countries in the World classified as indebted low income countries. 25 are in Africa (UNDP, 1992). On the whole, the preferential relations between developed and developing countries have done relatively little to stamp out the structural poverty and under-development in these countries. In the face of this of this predicament, I think it is only the Federation of Earth that will salvage Africa.

Furthermore, there is need for urgent steps be taken to implement the CFE because the debt bondage created by the unfair and biased international system has among many others helped to compromise national sovereignty and to further pauperize many developing countries including Africa. This

intolerable situation can only be redressed by a fair and transparent World Government.

The continuing political instability and turmoil in the world and particularly in Africa calls for urgent steps for the implementation of the ideals of World Government. This is particularly urgent reflecting on the inability of the UN to meaningfully resolve conflicts in the world. This indictment can be substantiated by the abysmal failure of

the UN Peace Keeping Forces to maintain peace and security in such countries as Somalia, Rwanda and Sierra Leone. In the case of Sierra Leone for example, a UN Peace Keeping Force of about 13,500 has still not been able to maintain peace and security in this small war-torn West African State.

In conclusion, some of the following recommendations can be useful in the speedy implementation of the CFE.

1. Genuine will and determination to the Constitution.

2. National, regional and international coordinated efforts to convince national governments to ratify and implement the Constitution for the Federation of Earth.

3. Commitment to provide funds and resources for the campaigns to implement the CFE.

4. Putting in place active campaign clubs, nationally and internationally to speed up the implementation of the Constitution for the Federation of Earth. ■

As a Fourth Act of Administration, we do what should have been done at the first session of the Provisional World Parliament in 1982: As delegates to this Fourth Session of the Provisional World Parliament, we are designating a standing Parliamentary Committee on Disarmament, as specified in World Legislative Act # One, and we are beginning the process of appointing 50 Trustees to the World Disarmament Agency, which shall be completed by the Provisional World Cabinet defined under item EIGHT of this Manifesto.

The World Disarmament Agency shall proceed as rapidly as possible to establish the full institutional machinery for the rapid implementation of World Legislative Act Number One (as amended), including: Arrangements for the weapons of mass destruction of all ratifying countries to be turned over for supervision by the World Disarmament Agency to achieve rapid and universal immobilization, dismantling and elimination, or conversion to peaceful uses where practical; in particular, to establish the procedures and means for global supervision for the complete and speedy dismantling and elimination of all nuclear weapons of all nations, employing scientific and engineering personnel already prepared for this work; and the monitoring of all shipments of weapons, munitions, and military supplies and personnel, etc., as defined and prohibited under the First Act of Administration of this Manifesto.

As delegates to the Fourth Session of the Provisional World Parliament, we are enacting world legislation for a comprehensive Global Energy Administration. Priorities of the Global Energy Administration, related also to the work of the Emergency Earth Rescue Administration, and including a division for the work of the World Hydrogen Energy System Authority defined by World Legislative Act #10, shall be:

a) To eliminate the burning of fossil fuels for energy as rapidly as possible, and to shut down all nuclear power reactors as rapidly as possible;

b) To initiate and carry out a multi-billion dollar program of research, development and construction to substitute solar power, hydrogen power, magnetic power, and other environmentally safe energy sources for fossil fuels and nuclear power;

c) To construct a super-power energy grid connecting most parts of Earth for efficient low-cost energy supplies, as foreseen by Buckminster Fuller, but with due safety measures to protect people from possible harmful radiation effects, e.g., by the transmission of electricity within conduits which prevent outward radiation.

d) To rapidly phase out and eliminate all off-shore oil wells.

As a Sixth Act under this Manifesto, we are establishing a continuing Provisional World Cabinet, to serve until replacement after 25 countries have ratified the Constitution for the Federation of Earth, in accordance with Article XIX of the Constitution. Ministers and Ministries for the following departments and agencies are proposed for election as a beginning, with others to follow as rapidly as feasible:

Oceans and seabeds

Human Rights and World Ombudsman

World Disarmament Agency

World Water Supplies

World Financial Administration

Atmosphere, Space and Moon

Emergency Earth Rescue Administration

World Districts and Regions

Global Energy Supplies

Ratification and Elections

As a Seventh Act under this Manifesto, we are electing a continuing Presidium for the Provisional World Parliament, and ensuing Provisional World Government, to serve until replacement under the provisions of the Constitution for the Federation of Earth after 25 countries have ratified the Constitution, and as defined under Section D of Article XIX of the Constitution for the Federation of Earth.

TEN

For locations to carry out the administration of the terms of this Manifesto, and to begin the functions of the Provisional World Government, in conformity with Article XV of the Constitution for the Federation of Earth, we shall designate or direct the Presidium to designate locations within five continental areas of Earth as the first five Federal World Districts.

Approved in principle at the Fourth Session of the Provisional World Parliament meeting on September 14 to 17, 1996, at Barcelona, Spain. ■

# Dr. Wabbi Leonard seeks justice

Dr. S. Wabbi Leonard, Coordinator of Buddu Social Development Association. Busoda, PO Box 1796, Masaka, Uganda, East Africa, states as follows:

1. I was invited to attend as a delegate to the 5th Session of the Provisional World parliament held in Malta, November 22 to 27th, 2000.,
2. As a citizen of a Commonwealth Country. I am entitled to enter Malta without a visa.
3. I arrived in Malta Airport on the 27th of November.
4. On arrival, I was subjected to gross humiliation by the Malta Immigration.
5. I was subjected to relentless questioning.
6. I was strip-searched in the most humiliating manner.
7. I was kept waiting for over 4 hours. This was after I had made a long and arduous plane journey. I was without food for all the four hours of waiting.
8. The Malta immigration Authorities were fully aware that I was in Malta to attend the Fifth Provisional World Parliament and that this assembly had been notified to the authorities by the organizers several weeks before.

7. Hotel Rooms had been booked at the New Dolmen Hotel and the Topaz Hotel.

10. My temporary detention at the Airport and the humiliating treatment is a gross violation of my human rights and appears to have racist innuendo. Finally to make any humiliating more compounded I was given a three day stay in Malta, where Commonwealth countries have a right for a three month stay.

11. I call upon the secretariat of the Provisional World Parliament and its organization authorities GREN and the World Constitution and Parliament Association, 8800 West 14th Avenue, Lakewood, CO 80215, USA to take immediate action on my behalf and the hundreds of other delegates from Africa and Asia who were prevented from attending this 5th Session designed to work towards the establishment of a Federal World Government under a Constitution for the Federation of Earth.

It is my wish that this matter be raised in the European Court at Strassbourg and the Human Rights Commission in Geneva and that the perpetrators of this assault on Human dignity in general and my one humiliation be brought to justice.

## To the Government of Malta:

**W**e the delegates of the Fifth Provisional World Parliament wish to protest the humiliating and degrading treatment given by the Malta Airport authorities to our delegate from Uganda, D. S. Wabbi Leonard.

Dr. Leonard informs us that he was strip searched, detained at the airport for four and one half hours, and questioned repeatedly in a humiliating and unjustified manner.

Not only is Uganda a Commonwealth country, but the Provisional World Parliament is a respected, legitimate world Organization which had previously discussed its meetings with the Government of Malta.

We strongly protest at this outrageous treatment by the authorities in Malta, not only in the matter of Dr. Leonard. but also to the rejection of over 400 delegates who were prevented from attending the Parliament.

## Resolution of the Fifth Session of the Provisional World Parliament Regarding National Requirements for Visas

**T**his Fifth Session of the Provisional World Parliament held in Malta from the 22nd to 27th of November 2000, at its closing session wishes to place on record the lack of cooperation shown by the Immigration of Malta in denying visas and entries into Malta despite previous assurances that there would be no difficulties for the issue of visas to delegates.

This Provisional World Parliament also wishes to point out that over 1400 registered delegates could not attend the Session. Most of these delegates could not attend on account of inequitable international economic structures worldwide.

Beyond these, over 400 delegates had the money but were denied travel, even most who had passports, as well as some that had no requirement of visas were denied. The Parliament senses that a hidden hand is behind this attempt to sabotage a Session that was planned to forward the Democratic Federal Government under the Constitution for the Federation of Earth.



# Report from Bangladesh and India

I spent the last week in December in Dhaka, Bangladesh and the first week in January in Calcutta, India. My host in Bangladesh was Dr. Mujibur Rahman, a vigorous supporter in his country of democratic world government under the Constitution for the Federation of Earth. Even though my visit was during the most significant holiday in Bangladesh when many heads of GREN organizations were not in Dhaka, Mujibur Rahman organized an excellent meeting with a number of leaders of important organizations. Enclosed is a photo showing most of the participants in the meeting.

At the meeting, we discussed how to promote the Constitution to the government and people of Bangladesh and I distributed about 20 copies of the Constitution and other WCPA/GREN literature to those present. I also described our plans for a global fair and exposition in India in the year 2002.

Those present were very pleased at this since they had been unable to come to the Malta Parliament because of the cost of transportation, but said they would more easily be able to come to India.

During my stay in Bangladesh, I also toured three of the some 170 slums in Dhaka, and learned first hand about the terrible problems of poverty, flooding, population explosion, and environmental degradation threatening their beautiful country. All of these terrible problems cry out for world government under the Constitution as the only reasonable and possible solution.

During my visit, I also had the privilege to meet with the Chairwoman, Vice-Chancellor and other prominent members of Queen's University in Dhaka, to which Mujibur Rahman is Advisor for International Programs and Academic Affairs. Everywhere I went, I found people very interested in our movement for democratic world government and gave out copies of the Constitution and other literature. It occurred to me that a fruitful relationship might eventually be developed between our own Graduate School of World Problems and Queen's University. In addition, some people I met had contacts with high officials in

the Bangladesh government and promised to arrange meetings with them upon my next trip to Bangladesh.

From Dhaka, Mujibur Rahman and I flew to Calcutta for a large peace conference entitled "World Peace Thinkers Meet" jointly organized by the International Society for Intercultural Study and Research (ISISAR) and International Philosophers for Peace (IPPNO). Both of us presented lectures on world government under the Constitution for the Federation of Earth and promoted awareness of our movement whenever possible. I gave out 40 copies of my paper entitled "The Route to Global Peace: Democratic World Government and a Specific Plan for Economic Conversion." This paper will be published in India as part of a volume of papers from the conference.

In addition to a week of meetings and special events, we held a large peace



march through the streets of downtown Calcutta. The march included hundreds of school children in colorful uniforms, some playing musical instruments, as well as trucks decorated as floats insisting on the right to peace. In my view, the right to peace is synonymous with the right and duty to live under democratic world government. Enclosed are two photos of banners from the peace march.

The one announcing "Peace March" shows E. P. Menon marching in the center, just above the word "peace." He is Executive Trustee of India Development Foundation and prominent Indian supporter of non-military democratic world government. The banner for "International Philosophers for Peace" shows Mujibur Rahman marching just to the right of the person carrying the banner.

# Core Group Empowerment - CORGEM -

**CORE GROUP EMPOWERMENT is to prepare, develop and organize a strong core of dedicated persons to carry out all aspects of the multiple campaign for World Government.**

## THE NEED

**D**uring recent years, many people and organizations have become interested in participation and helping to achieve the objectives of the Global Ratification and Elections Network and all that is included under that banner and that of the World Constitution and Parliament Association. To achieve these objectives requires sustained leadership by persons who are completely informed and prepared to do all that is necessary.

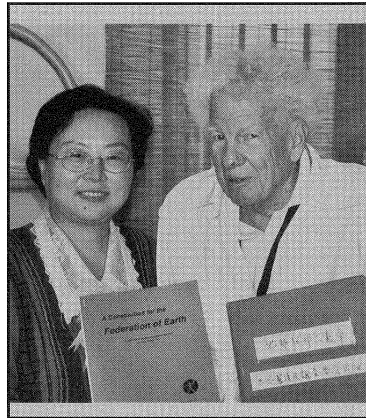
## PURPOSE

Following from the above statement of need, the purpose of what shall be known as CORE GROUP EMPOWERMENT (CORGEM) is to prepare, develop and organize a strong core of dedicated persons to carry out all aspects of the multiple campaign which includes the following:

- a) Ratification of the Constitution for the Federation of Earth;
- b) Sessions of the Provisional World Parliament, becoming sessions of Parliament under a ratified Constitution for the Federation of Earth;
- c) Establishment of functioning Ministries of World Government and of the Integrative Complex as defined by the Constitution for the Federation of Earth;
- d) Implementation of legislation adopted by the World Parliament, and
- e) Organization of a series of Global Expositions related to an emerging global economy and society within the context of World Federation designed to serve peaceful human needs.

## WHO?

Persons to participate in the sessions for Core Group Empowerment shall be selected on the basis of applications, primarily from among those who are already active in our global campaign, and then opened to others. From 10 to 30 persons may be included in each session of the CORGEM for beginning, possibly more later. For the year 2001, two sessions may be possible, depend-

ing on how rapidly basic preparations can be carried out.

## WHERE?

CORGEM sessions shall be held in a country, or countries, where visas will be easily granted and obtained by participants from all countries - particularly by participants from "developing" countries. Since the purpose of the CORGEM is essentially to prepare participants to carry out a global revolution, it would be important for the government of the country where CORGEM sessions are held to be friendly to the purposes of the CORGEM, or at least tolerant.

Further, it is desirable for the first sessions of the CORGEM to be located within easy travel distance for myself as a key Professor. Considering the above, the choice of host countries may be limited - at least until there is a breakdown or big cracks in the present world order (or disorder) dominated by the USA. One country in the Caribbean comes to mind: Cuba. Whether there are others requires investigation.

## WHEN?

Factors affecting when the first CORGEM session can be held include the following: a) Investigation of where; b) clearance of visa procedure; c) circu-

lation of information among potential participants, and the receipt and processing of applications; d) collection and orderly preparation of all essential study materials; e) sufficient funding; f) preparation and availability of the CORGEM teaching staff - who will also be learning through the CORGEM.

A first session of the CORGEM in May or June of 2001 would be desirable, but in view of the preparation needed, September or October may be more feasible. Another strategy to be investigated is to plan the first CORGEM session to begin concurrent with some other compatible international meeting is going to be held to which CORGEM participants might get visas for attending.

## DURATION?

A minimum CORGEM session would be four weeks or one month, considering all that needs studying. (See CONTENT below) Those making applications to attend must be ready to commit themselves fully for the specified length of the CORGEM session.

## COSTS?

For the first two sessions of the CORGEM, from 10 to 20 scholarships will be granted to dedicated partici-

pants, based upon applications.

The scholarships will include housing, meals, tuition, books and round-trip air transport. Allowance for housing and meals will be based on \$20/day for housing and \$20/day for meals, for 30 days. Anything in excess must be paid by the participant. Such allowance will be made only for full time participants. Any days' absence from the class will be deducted. Class attendance will be 5 days per week. Round-trip air transport will be economy class, arranged at lowest cost for advance booking.

In addition to those attending on scholarship, others up to a maximum of 40 in total will be welcome on a paying basis, for housing and meals as well as transport.

No tuition will be charged for the first two sessions. After the first two sessions, tuition may be charged, but also tuition scholarships may be granted.

To pay costs for the first two COREGEM sessions, a fund will be pledged from the Margaret Ann Isely Foundation. Other contributions will be solicited. Funding contributions may be expected in due course through the Foundation for Humanity.

Persons who take the CORE GROUP EMPOWERMENT course must then have some way to earn a living and get money to carry on the Provisional World Government, after they return to their homes or universities or home countries,

Therefore, alongside the CORGEM course, there needs to be an agency which can help graduates of the CORGEM course to earn money - especially until the new global finance and credit system is generally operative.

Soliciting contributions is an unreliable source of money, particularly outside of rich countries, and particularly for the political action which is central to the Work and not for tax deduction. Some graduates of the CORGEM course may have suitable jobs, allowing them time to work for the Provisional World Government. But most may want help to find ways to earn money, which will still allow time to positively contribute to the Provisional World Government.

### A way is defined here:

A few of us can start to develop economic enterprises which graduates of the CORGEM may carry forward in many countries. Such enterprises may be started on a small scale, at first, and grow.

The company will develop several enterprises which can be carried out in MANY COUNTRIES. The company should be eminently useful in providing

people with needed goods and services for peaceful living, and most should be of a nature which can be undertaken on a small scale with comparatively small investments, and grow. Graduates of the CORGEM can be prepared to take up and go ahead with such small-starting enterprises - all under the auspices and logo of the company. The company which I have in mind may start with sale of goods produced from abroad. It should be adaptable for production and consequent expansion in Third World and "developing" countries.

A few possible company enterprises may include the following:

\* Supplying rice which is a basic food necessity in many Third World countries.

\* A special line of essential vitamins under the new international label SPRINGS OF YOUTH. These vitamins products which leave repeat sales potential will be designed for such universal needs as energy, mental alertness, heart health, eyesight, joint flexibility, guard against infections, cancer

\* Small vehicles, like scooters with seating and utility carrying capacity for going to market, etc., powered by electric motors, and hydrogen fueled motors.

more functional and constitutionally responsible federal body capable of aptly addressing the gross injustices of our world.

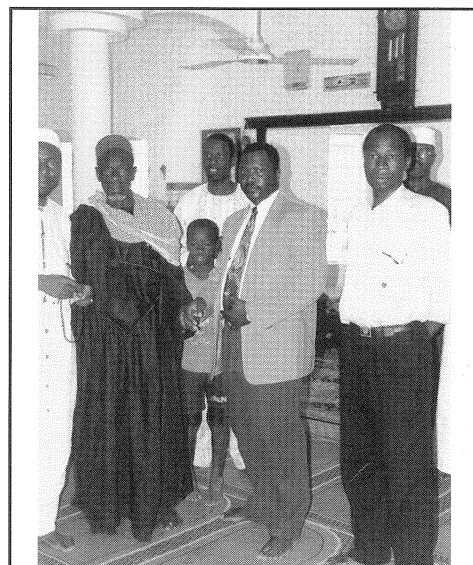

To explore the full potentialities of this audacious plan, and to expedite achievement in reality, we request an audience with you in the early first part of the year 2001.

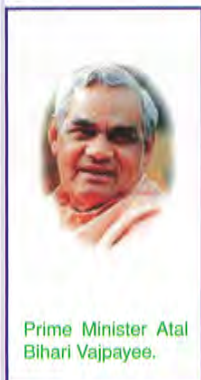
