## PROVISIONAL WORLD PARLIAMENT

Second Session, New Delhi, India, March 1985

With 900 people in attendance, the Second Session of the Provisional World Parliament was inaugurated at New Delhi, India, on March 17, 1985. Opening addresses were delivered by Hon. Balram Jakhar, Speaker of the Lok Sabha (Parliament) of India, who accepted to serve as Honorary Speaker of the Provisional World Parliament; H. E. Zail Singh, the President of India, who applauded the aims of the Parliament; Hon. Ram Niwas Mirdha, M.P., and Minister of Communication, who is a V. Pres. of the World Constitution and Parliament Assn.; Ing. Reinhart Ruge, Minister of Water for the State of Morelos, Mexico, and Co-President of the W.C.P.A.; Philip Isely, Integrative Engineer, and Secretary General of W.C.P.A.; Sat Paul Mittal, M.P., who served as Organizing Chairman for the Parliament in India; and Mrs. Savitri Nigam, ex-M.P., President of the India Housewives Federation.

During this session of the Provisional World Parliament, which continued until March 25, three "world legislative bills" and two resolutions were adopted. Another world legislative bill on the environment was given preliminary approval. The adopted bills, numbered as a continuation from the first session of the

Parliament held in 1982 in Brighton, England, are the following:

World Legislative Bill #6, titled: **EMERGENCY EARTH RESCUE ADMINISTRATION**, is designed for a comprehensive program to overcome the excessive accumulation of carbon dioxide in the atmosphere, which is described as the "new common enemy of the people of Earth." By trapping the sun's heat, excess CO<sup>2</sup> in the air, as graphically detailed in the bill, introduced by Philip Isely, USA, threatens catastrophic climatic and agricultural changes, leading to the possible starvation of most people on Earth, unless the CO<sup>2</sup> accumulation is reversed soon. The aim of the Emergency Earth Rescue Administration (**EERA**) is to carry out a three-fold global campaign, including:

(a) Massive reforestation worldwide, to recapture excess CO<sup>2</sup> by the growth of trees, which will also produce valuable crops of food, lumber and fuel;

(b) Massive re-mineralization of all forest and crop lands, to foster healthy forest and crop growth, to maximize the re-capture of CO<sup>2</sup>, while providing more valuable tree and other crops.

(c) Rapid transition from burning fossil

fuels, which put great quantities of CO<sup>2</sup> in the atmosphere and contribute to acid rain, to non-polluting and sustainable energy supplies, such as sun power.

To carry out the program of the Emergency Earth Rescue Administration on an effective global scale, a Board of Trustees of up to 200 members will be elected or appointed by national governments and other agencies which ratify the Bill. 30% of the Trustees are to be designated by national governments or national parliaments, 25% by sub-national political entities which ratify the bill, 25% by non-governmental organizations and corporations, and the other 20% by the Provisional World Parliament or Provisional World Cabinet.

To fund this massive campaign, the bill specifies that "since the task of **EERA** is similar in nature to a war for which all available resources are mobilized and given priority, the **EERA** shall be funded in similar proportions, amounting to a hundred billion dollars per year, or more." Accordingly, the bill seeks appropriations by national governments equal to 20% of the amounts currently being spent for military purposes.

The full text of the bill for the Emergency Earth Rescue Administration is included with this issue of Across Frontiers, together with ratification forms by which any group or individual may immediately help in implementation. A list of 35 benefits resulting from **EERA** is given on pages 11 and 12.

World Legislative Bill #7, titled: **WORLD GOVERNMENT CORPORATION**, designed as a comprehensive funding program, introduced by Philip Isely, USA. The aim of this bill is to establish a procedure by which national governments, city governments, private corporations, non-governmental organizations and individuals will loan money to the World Government Corporation on a contingency basis. The loans would be repaid, with interest, after the Constitution for the Federation of Earth (or other constitution for world government) has been duly ratified by a minimum of 50 countries. The money thus loaned to the World Government Corporation (**WGC**) will be disbursed to carry out the complete program to achieve democratic world government, and to

begin effective implementation of the several World Legislative Bills adopted by the Provisional World Parliament. Activities to be funded by the **WGC** shall include the following:

- The entire campaign for ratification of the Constitution for the Federation of Earth;
- All expenses of the sessions of the Provisional World Parliament;
- Begin implementation of Bill #1, to outlaw nuclear weapons, together with other weapons of mass destruction, and establish a World Disarmament Agency;
- Begin implementation of Bill #2, to establish a World Economic Development Organization, including a new global system for finance and credit based on productive potential, as the basis for a "New World Economic Order";
- Begin implementation of Bill #6, for the Emergency Earth Rescue Administration;
- The entire work of the Earth Rescue Corps (as described in Across Frontiers for Aug-Sept, 1985);
- Assist the Graduate School of World Problems, including regional divisions in several locations around the world:
  - All expenses of the next session of the World Constituent Assembly;
  - The work of the emerging agencies of the Provisional World Government;
  - Implement other World Legislative Measures adopted by the Provisional World Parliament.

To organize and develop the World Government Corporation, a Board of Directors will be formed, to include the original incorporators plus 12 Directors named by the original incorporators, together with up to 100 Directors named by the sources of funding. National Governments and other funding sources will elect members to the Board of Directors on the basis of one director for each \$10,000,000 pledged to the W.G.C. To get the W.G.C. into operation, \$100,000 is sought now as start-up money.

World Legislative Bill #8, titled: **WORLD COMMISSION ON TERRORISM**, introduced by Dr. Terence Amerasinghe, Sri Lanka. In view of the growing problem of terrorism in many forms and in many parts of the world, the aim of this bill is to establish an objective World Commission on Terrorism (**WCT**) which can, on the one hand, "investigate and clarify the issues and circumstances of any situation in which terrorism is involved . . . in particular . . . on a transnational level," and which, on the other hand, can "define possible solutions . . .

particularly . . . in the context of an emerging world federation."

Specifically listed as objectives of the **WCT**, is "an end to all transnational shipment and trade in arms and terrorist supplies of all kinds," as well as "an end to all training of persons to engage in terrorist activities," particularly those crossing national boundaries. The **WCT** may "invite each country affected by the activities of terrorists to send both government and peoples representatives to serve on the World Commission on Terrorism." The full text of Bill #7 on terrorism is given on page 15.

### RESOLUTION FOR ZONES OF PEACE AND NUCLEAR FREE ZONES:

The first resolution adopted by this session of the Provisional World Parliament was introduced by Rabi C. Shrestha of Nepal. The full text follows:

*"This Second Session of the Provisional World Parliament recognizes, supports and encourages the declaration and implementation of Zones of Peace and Nuclear Free Zones by any and all countries, cities and other governmental bodies which will adopt such declarations, so that such countries and other areas can freely pursue policies of economic and social development in a peaceful and friendly manner, with the ultimate aim that the entire Earth, together with surrounding space, will become a Zone of Peace, free of nuclear weapons and other weapons of mass destruction, in the context of a non-military democratic World Federation."*

### GOAL OF TEN MILLION

**SIGNERS:** The second resolution, submitted by the P<sup>a</sup>liamentary Commission on Disarmament, concerned methods for achieving the ratification of World Legislative Bill #1 to outlaw nuclear weapons and other weapons of mass destruction, and to establish a World Disarmament Agency. A goal of 10,000,000 individual signatures for ratification of Bill Number One, to be obtained before the next session of the Provisional World Parliament, proposed by Margaret Isely, was accepted.

Professor Ramachandra Rao, who declared his commitment to devote the next 25 years of his life to work for world peace, was named Co-Chairman of a continuing Commission on Disarmament. World Legislative Bill #1 was also

amended to enlarge from 100 to 200 the number of persons to be elected to the Board of Trustees of the World Disarmament Agency.

World Legislative Bill #9, titled: **GLOBAL ENVIRONMENTAL PROTECTION AGENCY**, was introduced by Emil Peter of The Greens Party of West Germany. In its original form, this bill was considered incomplete by some delegates. During debate by the Parliamentary Commission on Environment, various additions were proposed. Dr. Rashmi Mayur, Director of the Urban Development Institute of Bombay, and Third World Coordinator of the World Future Society, prepared a long paper describing the many world environmental problems to be dealt with by the Global Environmental Protection Agency.

When the proposed bill was reported back to plenary session, but without a finished bill, the Parliament gave preliminary general approval with instructions that the points detailed by Dr. Mayur should be incorporated into the bill. A revised version of the complete Bill #9, being worked on by Emil Peter and others, will be printed in an early issue of Across Frontiers, prior to final action by the Provisional World Parliament at its next session in 1986.

### SPEAKER AND DEPUTY

**SPEAKERS:** Elected Honorary Speaker of the Second Session of the Provisional World Parliament was Hon. Bal Ram Jakhari, who is Speaker of the Lok Sabha (the People's House) of the India Parliament, and is currently the Chairman of the Commonwealth Parliamentary Association.

Elected Deputy Speakers, who took turns presiding, were: Ing. Reinhart Ruge, Minister of Water for the State of Morelos, Mexico, and Co-President of the World Constitution and Parliament Assn.; Dr. Terence P. Amerasinghe, attorney-at-law of Sri Lanka, Jt. Deputy Secretary General of the W.C.P.A., and President of the Sri Lanka Branch of Universal Love and Brotherhood Assn.; and Hon. Madan Bahadur Pradhan, M.P. of Nepal, twice Minister of Agriculture, and President of Nepal Branch W.C.P.A. Elected to serve as Secretary of the Parliament for this session was Mr. Brij Nigam, civic leader of New Delhi. Treasurer for the Parliament was Mr. N. S. Rao, Bombay businessman and civic leader, who contributed a major share of funding for the Parliament, including prin-

## ***"The Present World Situation Makes It Necessary to Have a World Constitution, a World Parliament, and a World Government."***

ADDRESS BY DR. BAL RAM JAKHAR, SPEAKER OF  
THE LOK SABHA (PARLIAMENT) OF INDIA

Our Excellency, Mr. President, Hon. Office Bearers of the World Constitution and Parliament Association, Mr. Mirdha, Mr. Mittal, Distinguished participants in the Second Provisional World Parliament, Ladies and Gentlemen:

I am extremely delighted to have been invited to preside over the inauguration of the Second Provisional World Parliament. My sincere thanks to the organisers of today's function. Before saying anything else, I would like to take you back to the year 1981, when our late Prime Minister, Smt. Indira Gandhi, whose physical absence has created a void in the galaxy of international personalities, gave a very inspiring message to the Fourth Annual Convention of the World Constitution and Parliamentary Association, held in New Delhi. How positive and thoughtful she was when she said:

"The World is becoming more and more interdependent. Developments in communication, problems of equitable distribution of the world's natural resources and the common dangers posed by the increase in conventional and nuclear armaments demand that mankind must act as one. A just international order is inescapable necessity for man's survival. Such an order must rest on equal respect for all nations as well as equal opportunity for each people to develop to its fullest potential. Enlightened representatives of nations must develop international conventions which will make it possible for all Sovereign nations to cede some of their powers out of their free will to international institutions in the confidence that their dignity and just interests will never be compromised."

This is a great tribute to her far-sightedness, keen desire for human welfare and love for a just order.

Coming to the relevance of today's function, let me confess that at the first mention, the concept of World Parliament sounds a bit too idealistic. Living as we are in a world of intense national pride and competition for supremacy, the idea of a world government, covering all peoples and nations seems far from a reality. But on reflection, one is led to the inescapable conclusion that it is precisely the present world situation, in its totality, that makes it necessary to have a world constitution, a world parliament,

and a world government. Looking at the enthusiastic faces of so many eminent people from all over the world, seated in this Hall, I can say with confidence that the time has come when this great idea is going to be translated into reality. It was in this very hall that the Heads of State and Governments of the non-aligned movement — representatives of the majority of the world population — met about two years ago and called for increased international understanding and co-operation. It was again here that the Heads of Government of six nations from five continents met and urged the super-powers and all others concerned to halt the armament race. It is quite appropriate, therefore, that the inauguration of the Second Provisional World Parliament is taking place here in this historic Hall.

Friends, the advancements in science and technology have made the world a very small place. The nation state became a stable form of human organisation at a time when the binding forces on the lives and affairs of men were religion, language or culture, limited to a particular geographical area. Things have changed radically in the recent past. From the moral, scientific, economic, technological and even social points of view, the nation state is becoming an inadequate form of organisation to guide and control the lives of people. In fact in many cases the nation states, as they exist today, are often leading to international tension and wars. Hence the need for thinking in terms of the human race as a single unit of organisation. Therefore as citizens of the world, we must think and work for the welfare of the human race. The world government will have no equals and no rivals. It will have no foreign affairs and there will be no frontiers to be guarded. It will work only for the good of all. What a wonderful arrangement! The various agencies at the international level are, no doubt, useful but the question is whether they are adequate for the needs of the present and future generations. A world government and world parliament, as envisaged now, can solve many of the problems confronting humankind. The exploitation of

one country by another will come to an end; the vast inequalities that exist today in regard to the living standards of people in different regions of the world could be more efficiently and earnestly dealt with and there will be no national rivalries and competitions. A more rational distribution of human and material resources of the earth is possible only under a government encompassing the entire human race.

World peace and order can best be preserved by world law. The provisional World Parliament has already made a number of enactments as its first session touching disarmament, a new world economic order and a system of World Courts. The present session's agenda of implementing legislation to ban nuclear weapons, and of passing legislation to prevent environmental deterioration, to establish a World Commission on Terrorism, and an Emergency Earth Rescue Administration, etc., covers many of the vital issues facing the human race today. A world-wide ratification of these enactments will provide them with the necessary moral authority to guide the peoples everywhere. The involvement of institutions, universities, national parliaments, and the people in their individual capacities, is a must. That would persuade the national governments to voluntarily relinquish part of their rights and authority as a beginning to give legal authority also to the world government.

Before I conclude, I would like to reiterate that together we can build a world community based on love, freedom and justice: the goal of all our striving. As competition for dwindling resources grows more fierce, the centres of economic power intensify their exploitation; and as stockpiles of nuclear weapons grow, hope must never desert

## "On Pain of Chaos and Extinction, World Government Can No Longer Be Ignored as a Dream for the Distant Future"

ADDRESS BY PHILIP ISELY, SECRETARY GENERAL OF THE WORLD CONSTITUTION AND PARLIAMENT ASSOCIATION, at 2nd Session of Provisional World Parliament, 17 March, 1985

Fellow inhabitants of Earth —

In the few minutes given me, I will try to show that the first priority and the central policy of the Government of India and of any national government truly concerned with the welfare of its citizens and the survival of humanity on Earth, must of practical necessity be the achievement of World Government.

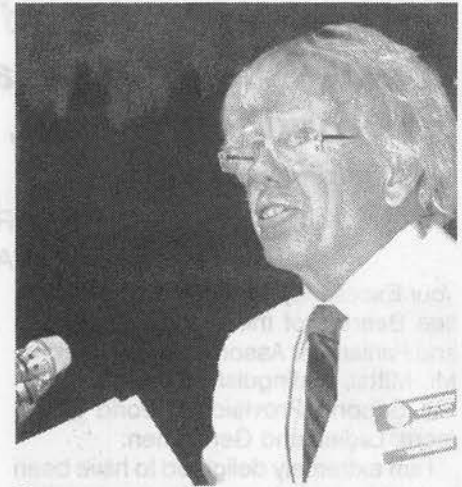
On pain of chaos and extinction, world government can no longer be treated or ignored as a dream for the distant future, as a matter for pleasant generalities, or as a side issue. The reasons are:

**FIRST:** Nuclear disarmament and complete disarmament cannot be reached by negotiations among sovereign nations. The proof is in the record of disarmament conferences for the past 30 years: Instead of disarmament, the military expenditures of nations have risen from less than a hundred billion to nearly a trillion U.S. Dollars a year — with a 10,000 to 20,000 fold increase in nuclear weapons, while about a hundred sovereign less-developed nations have steadily increased the burden of armaments for their citizens. Disarmament can only be achieved in the context of an emerging World Government, with a world legislature, a world executive, a world judiciary and a world disarmament agency empowered under a World Constitution to solve world problems peacefully for the good of all. Ratification of a World Constitution — such as you have before you is therefore the first requirement for practical politics in today's world.

**SECOND:** The People of Earth are today confronted with a new common enemy: the rapid increase of carbon dioxide in the atmosphere, which is already causing extreme changes in climate, weather and agricultural production. If continued for even 10 more years, these climatic changes may become irreversible, and result in continued and expanding areas of drought, repeated crop failures in the temperate zone bread baskets of the world, and other disasters leading to the probable starvation of not merely a hundred million people, but

more like 4 billion people before the end of this century, including most of the people of India. The only chance for averting these calamities is a very massive global campaign to recapture the carbon dioxide from the air by massive re-forestation, massive soil re-mineralization for healthy growth of forests and crops, and quick transition from fossil fuels of oil and coal to non-polluting energy sources. Such a massive and coordinated planetary campaign will never be undertaken by negotiations among sovereign nations, but requires the implementation of a world plan of action under the direction of a World Parliament and an emerging World Government. Such a programme can employ all persons now in military forces and all others unemployed. As a practical necessity for survival, the nations must throw away their arms and immediately join in common defense under a World Government against this new common enemy of mankind.

**THIRD:** In 1984, the burden of debt of the developing countries rose to nearly \$900 Billion and payments to \$90 Billion, mainly for interest — not for badly needed new development. This is an intolerable situation and cannot last. But to correct the situation without descent into world chaos, it is necessary for the debtor countries to escape from the trap of re-cycling loans under austerity conditions simply to pay the interest demanded by the present international money changers. To escape from this trap requires a truly New World Economic Order, which includes a new world financial and credit system based upon productive capacity and a single world monetary system. The introduction of such vast changes cannot be done by negotiations one-by-one among sovereign nations, but requires collective action by non-aligned and debtor countries within the framework of a new global system of finances mandated under a world constitution. By organized and collective action within the context of an emerging world parliament and world federation, the demand for acceptance of the new world economic order becomes possible.

**FINALLY:** to initiate the actions which I have mentioned, requires funding comparable to expenditures for military purposes. As this is "budget session" time, everybody knows that public policy is serious only where money is appropriated. Therefore, we invite any country which desires to escape from the lunatic fantasies of national militarism and from the death grip of power politics, to invest in a common Earth Rescue and Defense Fund, to be administered by the emerging agencies of World Government. As a beginning, we suggest appropriations for the Earth Rescue and Defense Fund equal at least to 10% of current military budgets. To give global leadership in time to avert the extinction of the human race on Earth, we are seeking the first five countries which will join in this common action. We hope India will be one.

## MEETING WITH MAYOR SAATHI

During the Parliament session, a delegation met for 45 minutes with Shri Mahinder Singh Saathi, Mayor of Delhi. Serving his second term, Mayor Saathi (51) not only agreed to be an Honorary Sponsor of the Provisional World Parliament, but said that he would ask the City Council of Delhi (pop. over 5 million) to ratify the Constitution for the Federation of Earth, and that he would recommend such action to other cities of India, and devote 5 minutes of his allotted 20 minute presentation at the World Convention of Mayors in Milan, Italy, in June, to the subject.

Mayor Saathi, who came from a working class background, has a degree in Political Science, and is a staunch supporter of Hindu-Sikh unity, said that he would attend the Third Session of the Provisional World Parliament in Miami in June, 1986, and would be glad to go with a delegation to obtain acceptance by various countries of our total plan of action. The meeting with Mayor Saathi was arranged by Savitri Nigam.

## MEETING WITH INDIA'S CHIEF JUSTICE

During the Parliament, a delegation met for 20 minutes with Hon. Y. U. Chandrachud, the Chief Justice of the Supreme Court of India since 1978. In agreeing to serve as an Honorary Sponsor of the Provisional World Parliament, Dr. Chandrachud wrote: "I approve the aims and purposes of the Provisional World Parliament and agree to serve as an Honorary Sponsor. The Provisional World Parliament must become a focal point for the radiation of peace, goodwill and humanity all over the world. The peoples of the world must marshal their strength and courage to halt the nuclear race. The alternative is the destruction of humanity." The meeting with Chief Justice Chandrachud was arranged by Savitri Nigam.

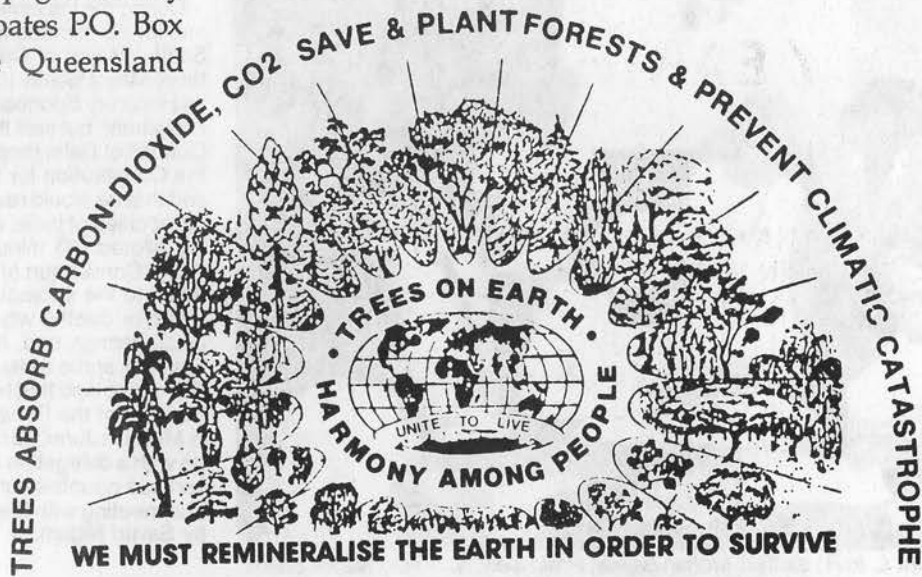


## GROUP GOES TO NEPAL

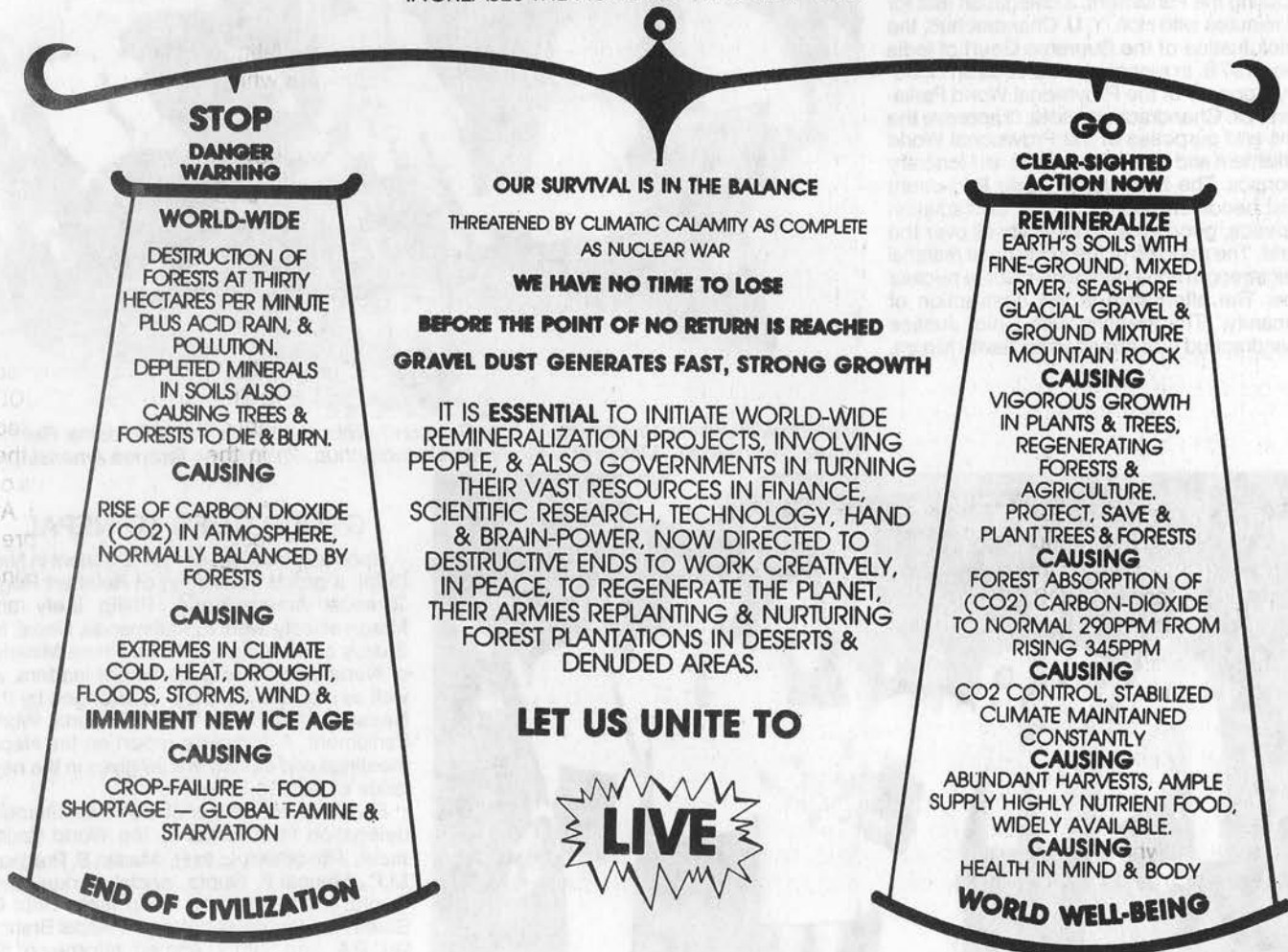

## World Legislative Bill Number Six\*

**EMERGENCY EARTH RESCUE ADMINISTRATION****WHEREAS —**

**THE PEOPLE OF EARTH HAVE A NEW COMMON ENEMY, WHICH REQUIRES AN EMERGENCY WORLD-WIDE CAMPAIGN IN WHICH BOTH EAST AND WEST, NORTH AND SOUTH, MUST ABANDON ARMAMENTS AND JOIN IN COMMON CAUSE FOR SURVIVAL.**

The new Common Enemy is the rapidly accelerating increase of Carbon Di-oxide (CO<sub>2</sub>) in the atmosphere, which will result in cataclysmic climatic changes unless overcome soon.

The climatic changes and resulting catastrophes, which could become irreversible within a decade unless the "greenhouse syndrome" of accumulating CO<sub>2</sub> is reversed, include:

- Widespread drought, which is likely to continue relentlessly year after year, and to devastate more and more countries;
- Rapidly spreading deserts and forest die-outs;
- Many erratic weather extremes, together with high winds and forest fires, all serving to make agriculture, food production and living conditions difficult;
- Repeated crop failures in the temperate zone "bread baskets" of the world;
- Massive starvation for hundreds of millions of people, beginning in the poorer countries, but spreading to the developed countries as food supplies run low;
- Excessive evaporation from oceans in the lower latitudes, then drawn by air currents to higher latitudes where precipitation as snowfall will increase under continuous cloud cover, thus resulting in accumulations which will turn to ice;
- The unexpectedly rapid onset of a new ice age;
- Vast areas become uninhabitable, leading to attempted mass migrations of people, but with nowhere to go;
- Soon the pressure of growing ice fields on Earth will result in increasing volcanic eruptions at release points, spewing great quantities of CO<sub>2</sub> into the atmosphere, and pushing the whole process beyond the point of no return.

**Several concurrent reasons for the rapid increase of CO<sub>2</sub> in the atmosphere include:**

I. Rapid de-forestation, due to over-cutting for fuel, lumber, and conversion of forest land to the raising of cattle for beef, particularly in the tropics and sub-tropics where vigorous forest growth is particularly critical to hold the CO<sub>2</sub> in dynamic balance;

II. Weak and un-healthy forest growth, resulting from general soil-demineralization worldwide, together with acid rain and other pollutants. Healthy forest and tree growth is necessary to keep the balance of CO<sub>2</sub> in the atmosphere, because trees take in CO<sub>2</sub> and store carbon in the process of growth.

III. Burning of fossil fuels, both coal and oil, which releases stored carbon in CO<sub>2</sub> form.

IV. General loss of top soil and soil fertility, leading to generally less healthy plant growth, which is then unable to use up as much CO<sub>2</sub>.

V. Heavy meat eating diets, which are increasing as affluence spreads, which puts economic pressure for conversion of forest lands to cattle raising and other meat production.

We recognize that present day civilizations have developed during an inter-glacial period of a little more than 10,000 years, and that another ice age might ordinarily be expected to recur from natural causes, as in the past history of the Earth. In the present circumstances, however, the actions of people are hastening the advent of another glacial period. At the same time, it may be equally possible for people to prevent a new ice age from overwhelming civilization by taking appropriate corrective steps now to restore a dynamic balance.

**THEREFORE —**

**A. AN EMERGENCY EARTH RESCUE ADMINISTRATION IS HEREBY CREATED.**

**B. THE EMERGENCY EARTH RESCUE ADMINISTRATION (EERA) shall carry out a coordinated worldwide emergency campaign on several major fronts concurrently, in order to overcome the increase of CO<sub>2</sub> before climatic and geological changes become irreversible:**

**I. First Front: MASSIVE REFORESTATION.** The following shall be carried forward:

- a) Make an inventory of all areas in the world suitable for reforestation and tree plantings to re-capture maximum net amounts of CO<sub>2</sub>. Give special attention to soil mineral content and other particular requirements of each area.
- b) Select areas to begin re-forestation and tree plantations, where the fastest growth and maximum retrieval of CO<sub>2</sub> may be accomplished in the shortest possible time. For this purpose, particular attention may be given to tropical and subtropical areas, providing water is available.\* \*
- c) Select a variety of trees suitable for re-forestation and tree plantations for various areas, taking into consideration rapidity of growth, net CO<sub>2</sub> recovery, water requirements, fruit and nut crop production, usable timber crops.
- d) Establish and expand nurseries to expedite growth of many billions of trees for re-planting.
- e) Proceed with re-forestation and tree plantings on as much available land as possible, including de-forested lands, publicly owned lands, private lands, roadside strips, wind-break strips, continuously renewable tree crop areas, tree crops to produce food and wood products.
- f) For the work of re-forestation and tree plantings, employ the unemployed wherever possible, particularly the unemployed of less developed countries as well as the unemployed everywhere, and also of people who may be displaced during the transition away from fossil fuels.

**II. Second Front: MASSIVE RE-MINERALIZATION OF FOREST LANDS AND CROP LANDS,** since the mineral content of the soil is most important for healthy, vigorous growth, able to re-incorporate the carbon content in trees and plants, and also for truly nutritious food crops.

- a) Determine mineral mixes in powdered rock form best suited for healthy tree and plant growth in various areas. E.g., combination of lava flow, glacial deposits and limestone.
- b) Contract with or establish quarries and rock or gravel grinding operations in locations around the world, to provide hundreds of millions of tons of appropriate mineral mixes ready for application.
- c) Select areas to begin re-mineralization operations, particularly areas to be reforested and planted in tree crops, and areas where forests are dying or weakened from de-mineralized soils, acid rain and other pollutants.
- d) For re-mineralization on a mass scale, equip thousands of airplanes to carry out the re-mineralization in a manner similar to crop dusting. Where possible, convert available military aircraft for this emergency campaign in the common cause for survival and peaceful living on Earth.
- e) Continue until all forest lands, tree crop areas and crop lands are re-mineralized, which in addition to maximizing vigorous tree growth will also result in more nutritious fruit

and nut crops and more nutritious agricultural products generally.

**III. Third Front: EXPEDITE THE TRANSITION FROM FOSSIL FUELS TO SAFE AND SUSTAINABLE ENERGY SUPPLIES AND TECHNOLOGY.** The following shall be carried out:

- a) Initiate, or help initiate, and coordinate a global crash program of research and development for alternative sources of energy which are both safe and sustainable.
- b) Particular attention shall be given to the potential and technologies for solar power and energy.
- c) The goal shall be to achieve a 50% to 90% reduction in use of coal and oil as energy sources within six to ten years.
- d) Do whatever possible to expedite the transition both for heating and cooling purposes, for industrial and commercial power, for conversion to electricity, and for transportation.
- e) Collaborate with other agencies working towards the same ends, particularly under the terms of other world legislation concerning world energy supplies and technologies.

**IV. Fourth Front: PUBLICITY.** To mobilize worldwide public support and cooperation in this emergency campaign, the EERA shall carry out an extensive global program of publicity, information, education and advertising.

**V. ON ALL FRONTS,** encourage, foster and coordinate the participation of all concerned agencies, both public and private, both local, regional, national and international, in this common campaign for re-forestation, re-mineralization, and the transition to safe and sustainable energy supplies.

**VI.** The "fronts" of the emergency campaign shall not be limited to those defined herein, and other fronts may be defined and developed by the Administration of the EERA.

**C. A BOARD OF TRUSTEES** of up to 200 members, serving terms of five years, shall be created to direct and administer the EERA, within the framework and specifications of this World Legislation, and shall be composed as follows:

- a) 20% of the members shall be elected or appointed by the Provisional World Parliament or by the Provisional World Cabinet to be created by the Provisional World Parliament.
- b) 30% of the members shall be designated by the national governments or national legislatures which ratify this World Legislation. The first 10 ratifying countries shall name ten members, the next 20 ratifiers shall name ten members, the next 30 shall name ten members, and the remaining countries shall name ten members. Until such ratifications have been accomplished the Provisional World Parliament or Provisional World Cabinet may appoint parliamentary or governmental leaders from various countries to serve on a temporary basis until members are duly named by the ratifying countries:

\* \* Note: If CO<sub>2</sub> accumulations continue too long, causing protracted draught and desert conditions, the affected areas may then become difficult or impossible to reforest from lack of water and rain.

- c) 25% of the members shall be elected or appointed by sub-national political entities which ratify this world legislation, including states, provinces, cities, local and regional authorities;
- d) 25% of the members shall be elected by organizations and corporations of all kinds which ratify this World Legislation.

The Provisional World Parliament or the Provisional World Cabinet shall designate three Co-Chairpersons for the Board of Trustees from three different continents, and shall designate an Executive Director and five Regional Directors, all of whom shall serve ex-officio with vote on the Board of Trustees. Each Trustee shall have one vote and only one vote, and there shall be no proxy voting.

The Board of Trustees for EERA shall do whatever is necessary to implement this world legislation as expeditiously as possible, and shall establish its own rules of procedure and operating structure within the framework and terms of this World Legislation.

The Board of Trustees shall at all times be responsible to the Provisional World Parliament and Provisional World Cabinet, and in due course to the World Government established under a ratified Constitution for the Federation of Earth, and shall make annual reports together with interim reports as necessary.

**D. An EARTH RESUE EXECUTIVE COUNCIL (EREC)** of 21-33 members shall be elected by the Board of Trustees to manage the day to day conduct and operations of EERA, officio on the EREC shall be the three Co-Chairperson and the Executive Director. The EREC shall be responsible for preparing the operating budgets for EERA, subject to approval by the Board of Trustees, and shall employ all necessary key personnel.

**E. FUNDING:** Since the task of EERA is similar in nature to a war for which all available resources are mobilized and given priority, the EERA shall be funded in similar proportions, amounting to a hundred billion dollars per year, or more. Sources of funding shall include:

- e) Appropriations by those national governments which ratify this world legislation for EERA. Appropriations requested from national governments for EERA shall be 20% of the amounts currently being spent for military purposes.
- b) National governments shall also be requested to cancel military contracts, especially contracts for nuclear weapons and other weapons of mass destruction, and to transfer unspent funds to the Emergency Earth Rescue Administration, as well as for other useful peacetime projects for world economic development and to serve human needs in accordance with World Legislative Bill Number Two of the First Session of the Provisional World Parliament.

c) Appropriations and contributions from sub-national political entities, communities, corporations, organizations and individuals who recognize the common enemy of humanity as defined herein.

d) Sale of EARTH BONDS, if other sources of funding do not prove adequate, such Earth Bonds to be redeemed plus interest by the World Government if and when established under a ratified Constitution for the Federation of Earth. The procedure for the sale and redemption of Earth Bonds shall be as provided in other World Legislation to be adopted by the Provisional World Parliament.

**F. ORIGINAL EXECUTIVE COMMITTEE:** To begin the EERA and make sure that everything moves along expeditiously, the Provisional World Parliament or the Provisional World Cabinet shall appoint an Original Executive Committee, to be composed of from 5 to 21 members. The first 5 members of the OEC shall be appointed at the Second Session of the Provisional World Parliament, and the first 5 may then co-opt additional members. The OEC shall include at least one Co-Chairperson and the Executive Director for EERA. The OEC shall begin immediately to initiate all activities of EERA, and to implement all provisions of this World Legislation. As soon as a permanent EREC is elected by the Board of Trustees, the OEC shall be replaced by the EREC. The OEC shall be responsible to the Provisional World Cabinet or to the Provisional World Parliament through the Standing Parliamentary Commission for EERA.

**G. GLOBAL RESCUE TEAMS:** As soon as funding of \$50,000 has been obtained, or sooner if feasible, the OEC shall recruit, employ and dispatch several Global Rescue Teams or two or three persons each, to travel to as many countries as possible for the purposes of obtaining ratification of this World Legislation for the Emergency Earth Rescue Administration, together with funding and other participation in expediting the work and objectives of EERA. The Global Rescue Teams shall seek ratification by national parliaments and national governments, by communities, states and other subnational political entities, and by corporations and other organizations.

**H. STANDING PARLIAMENTARY COMMISSION FOR EERA.** A standing Parliamentary Commission for EERA of 9 members shall be elected by the Provisional World Parliament, to serve as liaison between the EERA and the Provisional World Parliament, for the purpose of ensuring that the provisions of this World Legislation are carried out. The Standing Parliamentary Commission for EERA shall appoint the OEC if the OEC is not otherwise composed within six weeks after the adoption of this World Legislation. The OEC may include members of the Standing Parliamentary Commission for EERA.

Because EERA requires global crash program to develop efficient non-polluting sustainable energy supplies, particularly solar energy, in order to phase-out burning of fossil fuels.

Because EERA plants billions of trees which hold soil on hills, and restores soil fertility on all crop lands, which means humus building conditions which retain water.

Because EERA tree planting and re-mineralization to promote healthy tree and crop growth reduce rapid water runoff during heavy rains.

Because EERA prevents rapid water runoff together with rapid erosion, thus making dams useful for longer periods of time.

Because EERA requires rapid end to off-shore oil wells, rapid phase-out of super tankers for oil transport, greatly reduces pollution from burning of fossil fuels, and substitutes re-mineralization plus humus for agricultural fertility instead of too much inorganic nitrates and phosphates which quickly leach into streams and rivers and then into oceans, upsetting plankton growth.
14. **SAVES THE EARTH'S OXYGEN SUPPLY:**  
Because EERA prevents death of the oceans which recycle 60 to 80 percent of Earth's oxygen supply, and improves healthy forest and plant life on land which recycles the rest of Earth's oxygen supply.
15. **IMPROVES QUALITY OF FOOD SUPPLY FOR GOOD NUTRITION:**  
Because re-mineralization of all agricultural and tree-crop lands, required by EERA, means the production of more nutritious and good tasting food.
16. **IMPROVES WORLD FOOD SUPPLY THROUGH SUSTAINABLE OCEAN FISHERIES:**  
Because EERA keeps the oceans healthy, especially the most usable areas near shore.
17. **IMPROVES WORLD FOOD SUPPLY THROUGH NUT AND FRUIT CROPS:**  
Because EERA requires planting of more trees for nut, fruit, and other crops wherever possible, e.g., tree crop plantations; roadside, fence row, and backyard trees, with emphasis on trees which produce valuable crops for human use, not only the recapture of CO<sup>2</sup>.

Because EERA requires sustained use planning and planting of all forests in the world, and attention to fast growing trees which can be used for wood products, etc.

Because EERA requires massive re-mineralization (with humus where possible) on all forest lands, tree crop areas, agricultural and pasture lands, so that healthy mineralized growth resists pests and infestations, as well as fungus type and other maladies.

- 24. REDUCES AGRICULTURAL DISRUPTIONS FROM UNPREDICTABLE CLIMATE HAZARDS:**  
The increased incidence of late frosts, early freezes in areas seldom affected before, violent rains, etc., which disrupt crop planning and production, are the result of climate changes resulting from excess CO<sub>2</sub>, which is corrected by EERA.
- 25. SOLVES THE "OTHER ENERGY" CRISIS:**  
Because EERA requires sustained-use tree plantings, those parts of the world which depend on wood for fuel are assured of sustainable supplies of wood if they cooperate in EERA program
- 26. LEADS TO SHIFT AWAY FROM HEAVY MEAT EATING DIETS:**  
Because increase in beef and meat eating diets puts heavy pressure to convert forest lands, especially in tropical countries, to beef production, which takes 7 to 9 times as much land as grain products used directly for human food, the EERA program must encourage reduction in beef eating (while maintaining dietary protein balance) to save forests and recycle CO<sub>2</sub>.
- 27. GREATLY REDUCES POLLUTION IN THE CITIES:**  
Because EERA requires rapid transition away from fossil fuels to non-polluting energy sources, thus eliminates most gas and oil powered vehicles in favor of electrically powered vehicles, and eliminates coal and oil as energy sources for factories, for heating and cooling homes, offices, etc.
- 28. GREATLY REDUCES THE PALL OF HAZE OVER MUCH OF THE WORLD:**  
Because EERA eliminates major sources of haze producing pollution, which is important not only for cities and towns, but also for enjoyment of mountains, rural areas and vacation areas.

**29. SAVES ARCHITECTURAL AND ARCHEOLOGICAL TREASURES OF THE AGES:**

Because EERA eliminates most acid rain, acid fog, and atmospheric pollution which destroys the architectural heritage of history and civilization.

**30. SOLVES WORLDWIDE UNEMPLOYMENT PROBLEM:**

Because EERA campaign can employ every able bodied and able minded unemployed person, and every under-employed person, available throughout the world. These emergency campaigns will continue for the next 20 years.

**31. SOLVES DISARMAMENT PROBLEM:**

Because EERA program requires that all military arms programs be discontinued and abandoned immediately, and that expenditures, resources, manpower, and scientific talent now squandered in military programs must be turned immediately to fighting the new common enemy of mankind, which is the rapid increase of CO<sub>2</sub> in the atmosphere.

**32. HELPS SOLVE PROBLEM OF MILITARY CONVERSIONS TO PEACEFUL USES:**

Because all available personnel and useable technology now in military "service" is required for EERA campaigns for reforestation, re-mineralization, and conversion to non-polluting energy.

**33. PREVENTS RAPID ONSET OF NEW ICE AGE, WHICH WILL DESTROY CIVILIZATION:**

Unless reversed, the increasing levels of carbon dioxide in the atmosphere (now almost at the point of no return at 350 parts per million) will trigger rapid and irreversible onset of new ice age, which could last for tens of thousands of years. EERA program can bring CO<sub>2</sub> levels down to safety and dynamic balance, if implemented expeditiously.

**34. PREVENTS NEW UPSURGE OF VOLCANIC ACTIVITY:**

If CO<sub>2</sub> induced climatic changes are not reversed quickly, the ensuing build-up of snow an ice in polar latitudes will trigger (by geologic pressures) worldwide increased volcanic activity, which will spew great quantities of CO<sub>2</sub> and dust in atmosphere, and make the new ice age irreversible. 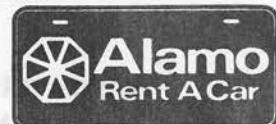

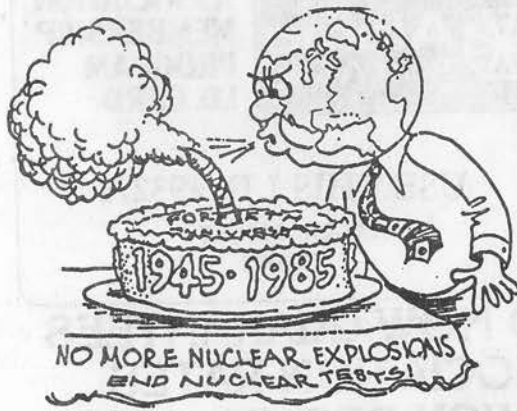

# WORLD COMMISSION ON TERRORISM

## World Legislative Bill #8

### WHEREAS

\* In a world already beset with many global crises and difficult problems, the situation is made more difficult by terrorism;

\* Both organized terrorism and random terrorist acts serve to confuse issues, enflame passions, exaggerate problems and make peaceful and reasonable solutions more difficult;

\* Sometimes terrorism is organized by States against other States or against people, even their own citizens; sometimes terrorism is organized by people against States or against other people;

\* In some situations, regardless of basic issues, the economic and social fabric of entire countries is disrupted, the living and working conditions of people made dangerous and miserable, and many innocent people are killed and their property destroyed;

\* In order to cope with terrorist activities, some smaller countries which might otherwise desire to apply resources for peaceful development, are forced to divert funds for military defense against terrorism;

\* Instead of an end to terrorism, more and more situations appear to be caught up in terrorist complications and intrigue.

### THEREFORE

**Art. I. A WORLD COMMISSION ON TERRORISM** is hereby created.

**Art. II** Terrorism is defined as the use of violence against lives or property, or threat to use such violence, without a formal declaration of war, for the purpose of trying to achieve objectives which may appear difficult to achieve by peaceful means.

**Art. III** The objectives and functions of the World Commission on Terrorism (W.C.T.) shall include the following:

(a) To investigate and clarify the issues and circumstances of any particular situation in which terrorism is involved, and in particular any situation in which terrorism appears to be or-

ganized on a transnational or world-wide level;

(b) To discover, uncover, clarify and define any just grievances or partly just grievances which may be involved;

(c) To discover, uncover clarify and define any extraneous, ulterior, hidden, manipulative, devious or false issues or reasons for terrorist activities;

(d) To uncover and clarify the true facts and nature of situations where terrorist activities may be used to enflame or confuse and utilize local or transnational situations, e.g., ethnic conflicts, for the achievement of objectives pursued by third parties.

**Art. IV.** To discover and define possible solutions to particular situations involving terrorism, and solutions to any aspects of terrorism which transcend national boundaries; in particular, to define, recommend and encourage solutions in the context of an emerging World Federation:

(a) To expose and seek an end to all transnational shipment or trade in arms and terrorists supplies of all kinds;

(b) To expose and seek an end to all training of persons to engage in terrorist activities, particularly where terrorists are trained in one country for terrorist actions in another country;

(c) To publicize the true nature of situations where violations of human rights may be involved, and to have such violations referred for solutions to the World Ombudsmus, to be set up under the Constitution for the Federation of Earth;

(d) To publicize the true nature of economic problems which may be involved, where such problems transcend national boundaries, and to have such problems taken up for peaceful solutions by the World Economic Development Organization, with adequate resources applied to implement peaceful solutions;

(e) To expose and seek the apprehension of any terrorist agents or individ-

uals engaged in transnational terrorist activities, without just cause, and to seek to bring such agents and individuals before World Courts of Justice.

**Art. V.** The nucleus of the WCT shall consist of members of the Provisional World Parliament, at a minimum of one from each country.

**Art. VI.** The WCT shall be empowered to invite each country affected by the activities of terrorists to send both government and peoples representatives to serve on the World Commission on Terrorism.

**Art. VII.** The WCT is authorized to begin its work forthwith.

**Art. VIII.** Funding for the WCT shall be from the World Government Corporation, which is set up under World Legislative Bill #7.

ting of several thousand copies of the Constitution for the Federation of Earth, under which the Parliament is organized.

### NEXT SESSION OF THE PROVISIONAL WORLD PARLIAMENT:

Two locations were offered for the Third Session of the Provisional World Parliament: Florida and Mexico. After much discussion, during which Philip Isely circulated a 3-page paper analyzing the potential and requirements for holding the session in Florida, probably Miami Beach, easily accessible to delegates from the Caribbean and Latin American countries, the vote was cast for Florida. Tentative dates were set for June 20 to 30, 1986, which will be the 9th anniversary of the session of the World Constituent Assembly at Innsbruck, Austria, where the Constitution for the Federation of Earth was completed and adopted on June 27, 1977. A budget of \$255,000 was proposed for a successful Parliament in 1986, with a minimum of \$100,000 required.

At the close of the New Delhi session of the Parliament, Mrs. Najma Haptullah, M.P., Chairman of the Rajya Sabha, addressed the Provisional World Parliament.

## RAJIV GANDHI MEETS WITH PARLIAMENT DELEGATES

During the 30 minute meeting with Rajiv Gandhi, the historical situation was described by Philip Isely, spokesperson for the group. In 1961, when Mr. Isely visited with Pandit Jawaharlal Nehru, then Prime Minister of India, and Rajiv Gandhi's grandfather, Mr. Nehru demurred on taking action to help convene a World Constitutional Convention for World Government, on grounds that first the U.S.A. and the U.S.S.R. must agree to disarm. The ensuing history of the arms race shows the futility of that approach. Later, when Mrs. Indira Gandhi was Prime Minister, Rajiv Gandhi's mother, she again deferred definite action despite several appeals to her, although she nominally favored world government.

Now the responsibility and opportunity falls upon Rajiv Gandhi's shoulders, not only as Prime Minister of India, but also as the young leader of the Non-Aligned Movement of the Third World, to take the bold action truly and desperately needed to move in the direction of World Government, by specifically recommending provisional ratification of the Constitution for the Federation of Earth, along with participation in the Provisional World Parliament and implementation of world legislation by the Parliament, as well as assisting in convening the 1987 session of the World Constituent Assembly.

Mr. Gandhi listened quite attentively, but replied in much more general terms, although saying that he would study the materials. The meeting with Mr. Gandhi was arranged by Sat Paul Mittal, M.P.
