


Libya to Host The Fifth Provisional World Parliament to Establish World Government

Irrespective of political pressures, the RCM stands by its principle of supporting grass roots movements and non-governmental organizations, says Dr. Salem Elzubedi

A three-member high level delegation of WCPA-GREN consisting of Professor Philip Isely — Secretary General, Dr. Ing. Reinhart Ruge — Co-President, and Mr. Sarwar Alam — Youth Coordinator, visited Libya from July 5th to 10th 1999 to exchange ideas and information with the Revolutionary Committees Movement (RCM) about finding the possibilities in promoting bilateral interests and relationships, and the holding of the 5th session of the Provisional World Parliament.

During the visit, the delegation met several Libyan dignitaries and visited some places of interest including the city of Sirte, the proposed location for the 5th session of the provisional World Parliament. And the delegation held several sessions with a delegation of the RCM made up of: Dr. Mustafa Zaidi (Coordinator of Foreign Affairs Department at RCM), Dr. Salem Elzubedi, Dr. Ali Gadban, Dr. Salem Ben Amer and Dr. Ramadan Breki.

As an outcome of the visit and meetings, the delegation successfully came to a bilateral agreement on issues ranging from the Revolutionary Committees Movement agreeing in principle to host the 5th Session of the Provisional World Parliament and to expedite arrangement for Libyan visas for ssssall registered delegates to the 5th Session of the Parliament and waving any kind of visa fees, to providing the necessary Arabic to English interpreters, and GREN to arrange English to French and French to English interpreters. The RCM also agreed within its capacity, to invite its members and friendly organizations to join GREN

and to send delegates to the Parliament.

In a recent correspondence dated May 6, 2000, RCM informed WCPA-GREN that a Libyan National Preparatory Committee has been set up. And preliminarily, the Committee has accomplished the following steps: It has secured for the 5th session the patronage of the Leader of the Revolution Brother Muammar Al-Qaddafi. It has booked the Ouagadougou Convention Center. It has booked suitable accommodation for the participants. It has made plans to arrange transportation facilities (buses and cars) needed internally to run the session. It has confirmed plans to provide (50) free air tickets to participants representing African organizations.

Nonetheless, the WCPA-GREN Strategy Committee members in their meeting of March 18, 2000 held in the Rossevelt Hotel in New York had raised concerns of the RCM's slow pace of implementing the Continued on Page 5



WCPA-GREN to Implement New Ratification Strategy to Establish World Government


Necessary action for a successful ratification campaign, which can be led by the 2000 member organizations in GREN, comprising more than one hundred million individual members.

reviously, we have sought ratification of the Constitution for the Federation of Earth by itself. All GREN organizations have endorsed ratification of the Earth Constitution, and many individuals have ratified, but no national government. There is one overpowering reason why national governments (apart from those few now ruling the world) have not ratified. This reason is fully explained in the first chapter of Immediate Economic Benefits of World Government: no government of a developing country or country seeking loans and investments from outside has dared to step forward to be the first to ratify because of fear of economic reprisals by present world rulers, particularly by the present most powerful world ruler.

Two things are necessary for a successful ratification campaign, which can be led by the 2000 member organizations in GREN, comprising more than one hundred million individual members:

- 1. About 25 countries, with their national governments and national legislatures, must be prepared to ratify <u>at the same time</u>.
- 2. Ratification must include the concurrent ratification of world legislation to inaugurate a new global finance and credit system, as defined in World Legislative Act Number Eleven, and in fact the immediate

implementation of the new finance system, simultaneously with ratification of the Constitution for the Federation of Earth. By concurrent ratification, the economic benefits can then greatly exceed possible reprisals.


Therefore, a new ratification resolution is proposed. This resolution includes both ratification of the Constitution for the Federation of Earth, and ratification of World Legislative Act Number Eleven, with immediate implementation.

Before going into some details of the new combined ratification campaign, I must mention that the venue for the 5th Session of the Provisional World Parliament is now firmly confirmed to be Sirte, Libya.

To proceed with the new ratification campaign, all GREN organization are urged to indicate their support and participation by adopting the new ratification resolution form published on page 19 of this issue of Across Frontiers.

Next, for official ratification by national governments, the proposal is that this be done simultaneously by the leaders of at least 25 national governments at the next full session of the Provisional World Parliament in October 21 - November 4, 2000.

The proposal, further, is that leaders in national parliaments or legislatures be pre-



pared to introduce legislation for ratification and push for its adoption concurrently with the ratification action taken at the next session of the Provisional World Parliament in October, 2000.

Prior to convening the Parliament, preparations must be made for beginning the new global finance and credit system, so that this can be implemented without delay following the ratification ceremony at the Parliament in October, 2000. Ratification of World Legislative Act #11 means that each ratifying nation or country accepts the new universal Earth Dollar currency, credit, and accounting (as defined in World Legislative Act #11) as the legal medium of exchange and accounting for all purposes within the country, as well as for international transactions, together with all other ratifying countries. In this way the new Earth Dollar currency and credit accounting becomes the accepted "hard" currency for all countries joining the World Federation, to be insisted upon likewise in commercial transactions with countries not yet members of the World Federation. Lines of credit will accordingly be immediately issued for each ratifying country, equal to many times all loans and investments available from all sources of the present international profiteering and exploitation system. The Group of 77 calls for a Fairer Global Order

Cuban Leader Fidel Castro calls for another Nuremberg to put to Trial the Economic Order Imposed on South Countries.

Representing 80 percent of earth's population, leaders of developing nations conferred in Havana, Cuba, in April, 2000, calling for a 'New Global Human Order" to spread the world's wealth and power.

The G-77, as known (now 133) has been an effective negotiating force within the UN system on resolutions pertaining to trade, finance, economic and social development, environmental issues, and other items. However, it was acknowledged - in frustration - by the current chairman of the Group President Olusegun Obasanjo, President of the Federal Republic of Nigeria while speaking at the plenary sessions of the summit, that most of the resolutions remain dead letter, that many important issues have been shifted to negotiations outside the UN system, and that the Group is confronted in general, with a weakening role for the UN in vital areas of war and peace and economic and financial decision making for world economy.

President Obasanjo cautioned his colleagues that the Group still has a long way to go. He elaborated that, it is indeed, disconcerting to observe that the problems of poverty, underdevelopment and global equity not only persist but under the impact of a fast globalizing world economy. He said the Group must come to grips with the reality that the Group's uncertain journey into the new millennium will continue to be shaped by the profound forces of globalization and liberalization unleashed in the final years of the 20th century. As such, "the Group must device strategies to cope with the challenges," he suggested.

Speaking further on globalization, President Obasanjo maintained that globalization has brought mixed blessings. The prosperity it engenders is unevenly shared among countries and regions of the world. While the industrialized countries remain major beneficiaries, the vast majority of members of Group of 77 have been unable to take advantage of the opportunities. He asserted that globalization has failed to spur economic recovery, faster growth, greater employment opportunities and poverty eradication in developing countries. Rather it has exhibited a tendency to accentuate the income and welfare gaps between the rich and poor, among and within countries and regions. Never has the world witnessed such massive disparities in international economic and social activities. And

nowhere is this trend more glaring than in the countries of the South, the president lamented.

He then suggested to the Group that they must strive for a more stable and predictable global political system and security structure. "Peace, security, development and cooperation are inextricably linked and cannot be dealt with in isolation," the president maintained. And he admonished that multilateralism should never be sacrificed for short-term and sometimes short-sighted domestic political expediencies.

The President eloquently concluded his summation that the new world of increasing interdependence compels them as developing countries to work together to rekindle their partnership with other members of the world community with whom they share a common destiny as members of the human family. He anticipated the South-South Cooperation to grow from strength within a fairer global order.

On a more forceful note, Fidel Castro, the revolutionary leader of Cuba spoke about the injustice and blatant exploitation deliberately imposed on South countries. He put in plain words that the Third World is forced to immobilize financial resources and grow indebted to keep hard currency reserves in the hope that they can be used to resist the attack of speculators. He was however disappointed to state that over 20% of the capital revenues obtained in the last few years were immobilized as reserves but they were not enough to resist such attacks as proven by the recent financial crisis in South East Asia.

Presently, Fidel Castro explained, 727 billion US dollars from the World Central

Bank's reserves are in the United States. He said this leads to the paradox that with their reserves the poor countries are offering cheap long-term financing to the wealthiest and most powerful country in the world while such reserves could be better invested in economic and social development.

The Cuban leader thus defiantly lambasted the International Monetary Fund (IMF) as the emblematic organization of the existing monetary system and the United States enjoys veto power over its decisions. He said, as far as the latest financial crisis is concerned, the IMF showed a lack of foresight and a clumsy handling of the situation. It imposed its conditioning clauses that paralyzed the governments social development policies thus creating serious domestic hazards and preventing access to the necessary resources when they were most needed.

Fidel Castro therefore called that, it is high time the Third World to strongly demand the removal of an institution that neither provided stability to the world economy nor works to deliver preventive funds to the debtors to avoid their liquidity crises; it rather protects and rescues the creditors.

The Cuban leader went further to analyze the facts that, over 820 million people are undernourished and 790 of them live in the Third World. And it is estimated 507 million people living in the South today will not live to see their 40th birthday. Two out of every five children suffer from growth retardation and one out of every three is underweight; 30,000 who could be saved are dying every day; 2 million girls are forced into prostitution; 30 million children

While the Iraqis are still Sanctioned to Disarm, Trace of Nerve Gas escapes in Salt Lake City — USA

leak of toxic nerve agent from a chem-Aical weapons incinerator in Toole County worries the state's top hazardous waste regulator.

The incinerator, 50 miles west of Salt Lake City, will remain shut down until experts figure out what happened.

Eighteen milligrams of GD nerve gas escaped from the exhaust stack at the Desert Chemical Depot near Stockton, Utah early this month. The amount was estimated based on levels in sampling tubes in the smokestack.

Editor's Note

Since 1945, all of the disarmament conventions, commissions, stud-

ies and resolutions of the U.N. have failed to stop the increase and spread of military arms for war, have failed to stop the introduction of new technologies for more destructive weapons, have failed to stop more nations from acquiring nuclear weapons and nerve gases, have failed to achieve disarmament. Today, the Iraqi people are perpetually been punished by the United States and Britain, fully supported by the United Nations to disarm, when the United States continues the building and maintaining of vast factories to produce nerve gases and nuclear weapons like the one that recently suffered a leak of toxic nerve agent in Stockton, Utah in the USA.

Under World Government, abolition of war requires complete disarmament and the elimination of all weapons of mass death and destruction by all nations on planet Earth, not just the Iraqi people, as the first priority for survival of humanity on Earth.

do not have access to elementary education and 250 million minors under 15 are bound to work for a living.

The world economic order instead works for 20% of the population and it leaves out, demeans and degrades the remaining 80%. The Cuban leader thus insisted, "this is not the time for begging from the developed countries or for submission, defeatism and internecine divisions. This is the time to rescue back our fighting spirit, our unity

and cohesion in defending our demands."

He lamented, "the pictures of mothers and children under the scourge of droughts and other catastrophes in whole regions of Africa remind us of the concentration camps in nazi Germany; they bring to us memories of stacks of corpses or of moribund men, women and children."

The Cuban leader thus surmised that another Nuremberg is required to put to trial the economic order imposed on South countries, the same that is killing of hunger and preventable or curable disease more men, women and children every three years than all those killed by World War II in six

As a matter of fact the RCM affirmed to GREN that the National Preparatory Committee set up to oversee the arrangements for the Parliament is conducting its business as usual.

As you have pointed out the nations of the world are faced with nothing but "international chaos". The situation permits the US and its junior partner to play the role of "policemen of the world". NATO'S NEW STRATEGIC CONCEPT was




Photo taken at Heathrow Park Airport Hotel on 20 January, 1998 during preparatory meeting for the 5th Session of the Provisional World Parliament.

approved by Heads of State and Governments of 19 member nations meeting in Washington DC on 23rd and 24th April 1999. The core of the concept is the phrase "Non Article 5 Crisis Response Operations". Previously Article 5 of the NATO Charter had limited NATO to defense responses if member countries were attacked. By expanding to non article 5 crisis response (crisis management) operations, NATO is authorized to take action anywhere in the world. To make sure this is fully

Mandela accuses Britain, US of International Chaos

LONDON, Wednesday (Reuters). Former South African President Nelson Mandela accused Britain and United States on Wednesday of encouraging international chaos by ignoring other countries and playing policemen of the world.

Mandela said in an interview with Britain's Guardian Newspaper that the British and US governments had gone ahead with military actions on Iraq and Kosovo without seeking permission from the United Nations Security Council. "The message they're sending is that any country which fears a veto (from the UN) can take unilateral action," Mandela said.

"That means they're introducing chaos into international affairs; that any country can take a decision which it wants." Mandela suggested a possible racist motive behind American policy towards the United Nations.

"The US did not do this when the Secretary General was white. They are doing it now, ignoring the UN under Kofi Annan," he said.

"And there are many people who are whispering that it is because the secretary-general is black. That perception is disturbing."

Mandela said British prime minister Tony Blair was a "young man" whom he liked very much. "But I am resentful about the type of thing that America and Britain are doing. They want now to be the policemen of the world and I'm sorry that Britain has joined the US in this regard," he said.


Democratic Federal World Government - A must for the New Millennium



Palmgrove Hotel in Chennai in January, a Chennai Chapter of the WCPA was inaugurated by Dr. Terrence P. Amerasinghe, Co-President of the WCPA.

Dr. Amerasinghe pointed out that everyone talks of the need for peace but the big question is HOW TO BRING IT ABOUT. The right to peace is the greatest of all Human Rights. In the absence of it all else is mere nothing. This was forcibly focussed on the Indian Public in the recent highjacking of an Indian Airlines Airbus. How could a mere handful of desperate highjackers bring a mighty country like India to its knees and forced capitulation by a dastardly act? The Airbus landed at Kandaharan Afghan territory. Having on board a full complement of passengers, the highjackers knew that they were immune from any action India might take to force a solution. India in spite of its second largest army in the world stood impotent, for the simple reason that it could not violate the sovereignty of Afghanistan. India could have done it as did Israel at Entebbe but wiser counsel prevailed. Had it done so it would have called upon itself the condemnation of other sovereign nations, a possible UN condemnatory resolution, an intervention of the Security Council with its attendant consequences. India found it unthinkable to ask the UN to intervene in view of the U.N.'s record of incompetence in such previous interventions. So India ate the 'humble pie' and gave in to the highjackers. Innocent lives of Indian and other nationals were saved. But what of the future? Does it mean a field day for terrorists and would be highjackers?

India has suggested a global solution to terrorism. Though salutary, the solution

cannot be done piecemeal. Today any terrorists can commit a dastardly act and seek refuge in a sovereign country that is willing to give him asylum. The injured country could do nothing. Embedded in the U.N. Charter is the principles of the sovereignty of nations. In such situations powerful countries have found their own solutions. The U.S.A. particularly has found a way out to its own advantage.

The NATO recently announced its NEW STRATEGIC CONCEPT. NATO is now authorized not merely to defend but to intervene and take the offensive anywhere in the world where "Peace, Security and Stability" of NATO members may be considered

It is time the Non-Aligned Nations, the Afro-Asian Bloc, the Latin American countries intervened with their solution. The new millennium demands new thinking. Now is the hour of reckoning. The 20th Century saw mankind accumulate enough knowledge to seek a way out of the present impasse. They had the failure of the League of Nations as an example. They can now see the spectacle of an impotent and ineffective U.N. leading the world to destruction. Long ago the poet Tennyson reminded us that "Knowledge comes but wisdom lingers". The coming years of the new Millennium can either lead us to catastrophe or lead us to a brighter more prosperous era for mankind if we draw conclusions from the

bloodiest wars of the 20th century. Everything points to the need for the creation of a World System wherein nations agree to cede part of their sovereignty to a global body with enforceable powers.

That is why, Dr. Amerasinghe said, the World Constitution and Parliament Association is working for a DEMOCRAT-IC WORLD GOVERNMENT truly representative of both peoples and Governments under an established Federal Constitution and a World Parliament.

Our Planet Earth Matters!

Our World Matters! Yes, Planet Earth Matters! And it is our responsibility to further impress this on the so called developed countries that our PLANET MAT-TERS!

Our GREN campaign believes in the establishment "of a strong global union which is the one resort that offers any realistic practical chance of outlawing war and the massive use of heavy and destructive weapons, or of saving the planetary ecology. For as long as independent sovereign states continue to give precedence each to its own national interests, and to pursue the power politics that necessarily prevail in diplomatic relations, neither of these aims can be achieved, and both are urgently essential if mankind is to be rescued from ultimate catastrophe."

"The only way world peace can be assured is for a global body that would enact world law that could be enforced against individual law-breakers, as it is within national states. Sovereign nations can be brought to book only by military action and the consequent waging of war; and recent history has proved conclusively that even that will not deter them from pursuing their own conceived national interests in defiance of any international law. The sole and indispensable condition of world peace therefore is world federation."

Humanity is fortunate already, as our world view has been shaped by work of four constituent assemblies. From 1958 to 1991, the Constitution for the Federation of Earth was written and revised through these assemblies made up of world citizens from all over the planet. Our organization is today supported by millions of people world wide. This carefully written constitution makes possible a world free of militarism, imperialism, economic exploitation, environmental destruction, and grinding poverty for the majority living in the so called third world. It replaces the UN with non-military democratic government which protects the integrity and independence of every nation on Earth, large and small, by creating a democratic federal power over everyone which can legislate enforceable law and settle disputes with enforceable court decisions.

loans or investments will be needed from outside. The procedure is fully outlined in IMMEDIATE ECONOMIC BENEFITS OF WORLD GOVERNMENT.

To encourage national governments and national parliaments to get ready for effective ratification action at the Parliament in October, 2000, the benefits of the new system must be well explained beforehand. The leaders of each country must see that the immediate economic benefits of joining the World Federation will far, far exceed any loans or finances from present sources - which is in reality financial subjugation of benefit only to the rich.

Thus, it is essential to be ready for rapid expansion of the new global finance system, which is designed to serve human needs, and does not require loans or investments from outside, to replace the misleading export-led exploitation system.

We hope you will study carefully this strategy, and discuss among your members and your delegates to the Provisional World Parliament. We shall look for your cooperation and participation in this freshly designed campaign!





The Global Peoples Assembly meets in Samoa

John Ewbank of Home Rule Globally introduced a resolution to the Peoples Global Assembly, that in all the efforts to change the United Nations and its Charter, the Constitution for the Federation of Earth should be used

For Euro-centric observers, the complexities of Samoan culture resemble the problems of the proverbial blind men's perspectives on an elephant. Eradicating Human Rights Abuses


It is time the world realized that international affairs must be governed by the rule of law, not of war.

Pradicate, of Latin origin,
means "uproot". Before we
can cure an evil we must determine its root causes. Otherwise
we merely treat the symptoms
without harming the germ that
causes the disease.

In communities governed by the rule of law, there is access to legal remedies for breaches of human rights. Not so in despotic states, where the government itself is usually the criminal. Such governments hide from retribution behind the myth of national sovereignty. We ought to have recognized this ages ago. Such recognition is the first step towards the eradication not only of violations of human rights but also of war itself, the root cause of which is

this claim to act as judge and jury in ones own case. International lawyers have been slow to wake up to the fact that this myth is as out of date as the divine right of kings, and is the primary cause of war, transcending such secondary causes as dictators, poverty, greed, social injustice, armament kings, etc. Belief in its sanctity is, however, gradually crumbling. The English Supreme Court (Pinochet, House of Lords) ruling that national sovereignty must yield to humanitarian considerations was one welcome crumb. NATO's similar assertion

regarding Yugoslav national sovereignty was another, though in this case the only remedy available in the present order of things has proved to be perhaps as vile as appeasement. Peace cannot be achieved by mass terrorism. Justice has no use for weapons of mass destruction, which apart from other devilish results – cause what is euphemistically called "collateral" damage.

It is time the world realized that international affairs must be governed by the rule of law, not of war. The only way to enforce law peacefully is to make it applicable to individuals. True law applies equally to everybody, acts peacefully (policefully) on individuals – not on whole communities as such – and is therefore made by individuals through a democratic legislature. The United Nations Charter and similar alleged sources of "law" violate all these principles.

Protesters against the present system of trying to keep the peace by warlike means are usually pacifists, mundialists, churchmen and other idealists. It is high time their protests were reinforced by objections from the materialists, egotists and realists, who would say:

"The present system is exhorbitantly expensive and must be replaced by a more efficient and

less costly system. paying lawyers' fees does not destroy wealth – it merely redistributes it. Let's have law, not war."

Federalists have been advocating the remedy ever since Cassandra (Dorothy Thompson) declared, on the birth of the UN:

"The United Nations Charter is worse than nothing. It is nothing behind a façade of illusory security. Its sole purpose is to lull people to sleep in the face of danger."

We ought to move towards a system of



understood, the phrase non article 5 crisis response (or management operations) is specified at least 9 times in the document and the phrase to carry out "the full range of alliance missions" is repeated throughout the document. In addition other language is used at least 41 times to emphasize that the scope of NATO's concerns is now beyond the borders of NATO countries, and takes the entire world.

In the course of your interview, you observed quite rightly, Mr. Mandela, that the British and US Governments had gone ahead with military actions on Iraq and Kosovo without seeking permission from the United Nations Security Council. NATO's New Strategic Concept is the US answer to the vexed question of the Veto. The US has made sure that they need no longer employ shuttle diplomacy when confronted with a Security Council member threatening to use the veto. Now, Mr. Mandela, you are dead right when you say "the message they (Great Britain and US) are sending is that any country which fears the Veto (from the UN) can take unilateral

The message you refer to almost leaps out of NATO's New Strategic Concept. It is like a blow in the face of the good, the brave and the true. Of those who believed in the integrity of the framers of the Charter. Many who naively believed that the UN Charter was the answer to the world's ills would now be forced to the conclusion that NATO's New Strategic Concept is Goodbye to the United Nations.

Your interview ends on the mournful note that only that "international chaos" confronts us. You are saddened by the thought, confirmed by many, that a racist element has crept into Anglo-US policy towards the United Nations. You are disturbed that all this is happening because Kofi Annan, "the UN secretary general is black". You, Mr. Mandela. who achieved the almost impossible dismantling of APARTHEID in your native South Africa would naturally feel more than uneasy at this surprising new trend. Mahatma Gandhi, Asian mankind's liberator in the passing century, did not let the "stings and arrows of outrageous fortune" to stand in the way. Gandhi was kicked out of the first class cabin to which he had a right and thrown on a South African station by a white racist. He, however marched right onwards, "nothing daunted clouds would break". "Wrong was 14 Across Frontiers/May, 2000

worsted" in his very lifetime, and "right triumphed". You, Mr. Mandela, won deathless fame as the liberator of South Africa and brought renewed hope to the blacks and the world over that lost dignity was restored.

Mahatma Gandhi understood the malaise our world is afflicted when he declared most emphatically "I do not wish to live in a world without WORLD GOVERN-MENT." The only alternative to 'international chaos' is DEMOCRATIC FEDERAL WORLD GOVERNMENT. US. and their friends can and have reduced the UN to impotency and arrogantly display prejudice to its legally elected 'black' Secretary General, because of the inherent defects of the UN Charter - defects which the framers, US and company, designedly injected into the Charter. At that time the whole world was crying for an organization that would not repeat the defects of the League of Nations. But what the victorious powers needed was the preservation of the status quo. So old ghosts were resurrected. The principle of sovereignty became the basis of the Charter. To ensure that theirs would be the ultimate say - the Framers of the Charter - the Big Five - embedded in it their right to Veto. From its inception, therefore, the UN was sterile. For a time the US encouraged the members of the UN in the illusion that the UN can be reformed. When the call for it became too vociferous the screw was turned with NATO's New Strategic Concept, which gives license for the US to rule the world. You, Mr. Mandela, refer to Iraq and Kosovo. The blow is now

directed to the UN itself. The fact that the Secretary General is 'black' adds grist to the mill.

In this situation, Mr. Mandela, you have a

towering part to play. Honored throughout the world – black, yellow, brown and in many cases white - you, in our opinion, have your role cut out. The social impact of eight years of unnecessary sanctions by the defunct United Nations have devastated standards of traditional behavior evidenced by the collapse of Islamic family values. Sanctions have undermined the children and parents' mutual expectations of each other. Sanctions have forced the Iraqi people to live with humiliation. Again the children are the hardest hit. Now they are forced to work to bring money into the family. There is an extremely high school drop-out rate. Children are now committing street crime, which was previously unheard of in Baghdad. The incidence of begging is now very common.

In general, there's a sense of hopelessness and depression, an inhuman punishment of the Iraqi people perpetrated by the United Nations. In April 1998, a GREN delegation visited Iraq and had consultations with senior officials of the Iraqi government on America and Britain's responsibility for the crime of aggression and

7-8 years of his life in Samoa, where he died in 1887 or 88 and is buried there on a hilltop. He left behind a fabulous colonial house on top of a hill outside Apia, which is now used as an official guest and reception place for the Samoan Government. There a great reception for all the delegates was given by the Government. Le Tagaloa Pita, introduced me there as a keynote speaker, representing a great organization, WCPA, an organization with combined affiliation of more than 100 million people, etc. It was the best introduction I ever got, and accordingly I was inspired for good speech about World Government, World Constitution, World Parliament, WCPA, etc. I could tell

by the strong applause afterwards, that it must have been good. Later, I handed the constitution personally to the Prime Minister of Samoa, Hon. Tuilaepa SaiLELE.

The Graduate School of World Problems

Building Leadership Skills for the Earth Federation

The Graduate School of World Problems was established by World Legislative Bill Number Four, adopted by the First Session of the provisional World Parliament, which was convened according to Article XIX of the Constitution for the Federation of Earth, in Brighton, England, in September 1982.

A fundamental purpose of the Graduate School of World Problems is to study world problems from within the context or paradigm of emerging non-military democratic federal world government, as described by the Constitution for the Federation of Earth. Other primary goals are to prepare students for implementing the World Legislation enacted by the Provisional World Parliament, and for preparing the personnel for all ministries and agencies for the World Government.

Initially operating as a think tank, the Graduate school is presently planning the development of a comprehensive curriculum for the training of persons from a wide variety of backgrounds. In a classroom format, students will study a core curriculum of World Government Philosophy, World federal History, the Constitution for the Federation of Earth, World Legislation, Global Public Administration as well as a balance of World Problems. Students will be exposed to the wealth of information which addresses these topics. GSWP students will take an active role in the approach to the resolution of numerous world problems, and will participate in global administrative functions within the Provisional World Government as part of the GSWP training program.

The GSWP understands that addressing the monumental global crises faced by the contemporary world – such as environmental destruction, militarism and violence, population explosion, poverty and misery, and human rights violations - requires that new leaders be educated who think in a different way, more globally, more democratically, more synergistically, and more creatively. The core curriculum of the GSWP is unique in that it focuses on the philosophy and history of the world government movement, and, in particular, on the work of the Constituent Assembly, Provisional World parliament, and world Constitution and Parliament Association and the Global ratification and Elections

Network. The goal fo the curriculum is to educate students in the concepts, functioning and history of world government so that they can serve as effective leaders under a new non-military democratic world order for which there is no historical precedent.

As an integral part of this educational process, the GSWP will employ scholars from all areas of expertise relevant to world problems. The school will offer inter-disciplinary courses of advanced study and confer degrees in major areas of world problems, including, but not limited to, climate, change, environment, food and water resources, energy supplies, global commons, global economy, human rights, labor and markets, oceans and atmosphere, public planning, technology, trade and travel, world resources and human needs.

Graduates of the school will be expected to have mastered the understanding and vision necessary to function in a truly integrated, federal democratic world order. They will be expected to have understood the processes of functioning within the world constitution and world law while addressing world problems from the various ministries of world government. While each graduate will be expected to gain expertise in some specific area of world problems, for example, the global environmental crisis, each graduate will also be educated in the interconnection and interrelationship of the many problems faced by human beings on

planet Earth, an obvious example is the relationship between the environmental crisis and global poverty, militarism and population explosion.

The GSWP believes that seeing these interconnections and relationships is vital if the ministries of world government are to work closely together to bring the planet Earth back from its present destructive course to a world which has protected the eliminated militarism. environment, addressed the problem of global poverty, and initiated the protection of human rights for every person on the planet. Graduates will be expected to think creatively and synergetically to address world problems within the context of the Constitution for the Federation of Earth and World Law as legislated by the World Parliament.

The GSWP is seeking qualified students from all countries in the world and from all cultures, races, and religions, to work together in a practical educational process of understanding the simultaneous unity and diversity of the world within the context of federal world government. Through this emphasis on a diverse student body working together within a practical and dynamic educational process, we hope that our graduates will enrich the forthcoming world government with leaders who can address world problems while respecting the integrity of the world's diversity of nations, cultures, races, and religions.

Our educational mission is not completed once world government has effectively begun. We are planning for the World University System to expand under the world government to every continent, with branches in every major city on Earth. In this way, we hope to create an educational process which effectively serves a future Earth in which there is peace among nations and peoples, justice for all under democratically established laws, and unity and integrity for the planet and its environment. A future unified Earth will require an ongoing educational system of the highest quality and integrity.

- 4. From the Maltese side, we can say that we have been briefed about the primary aims and objectives of the association and are aware that such a relationship can offer numerous possibilities to foster the current primary objectives of WCPA-GREN, namely: Sessions of the World Parliament, effective ratification of the Constitution for the Federation of Earth, the Establishment of function-

ing Ministries of Federal World Government, with the possibility that a First World Zone (per Article XV of the Constitution for the Federation of Earth) may be located in Malta.

5. The Malta Branch of WCPA-GREN is being launched with this framework and we are sure that once the necessary procedures have been completed, a number of activities can be conceived involving the participation of political and non-political figures who have played a major role in the day to day life in Malta and even in the present day are key players in the local economy and society of Malta.

This document is considered by both parties as a protocol of cooperation in launching the Malta branch of WCPA-GREN.





RESOLUTION FORM

Resolution for Ratification of the Constitution for the Federation of Earth and of the Federal World Legislative Act Number Eleven

WARE of the many extreme world problems and crises situations which threaten the People of Earth with disaster and destruction from many sources, among the foremost being the spread of nuclear and other weapons, multiple environmental degradations, climate change, the spread of exaggerated local conflicts, and the lack of a viable life-serving global economy;

CONVINCED of the necessity for a Democratic Federal World Government to achieve disarmament and to solve peacefully for the benefit of everybody the many problems which transcend national boundaries;

RECOGNIZING that a World Constitution is required for the functioning of a Democratic World Government, with sufficient authority given to an equitably representative World Parliament, a World Executive and Administration responsible to the Parliament, and mandatory World Courts which can protect human rights, while assuring the proper jurisdiction of national governments over their internal affairs:

RECOGNIZING FURTHER that a new global finance and credit system, designed to serve the peaceful needs of humanity rather than the profits of investors or exploiters, must be implemented concurrently with the World Constitution;

HAVING EXAMINED THE CONSTITUTION FOR THE FEDERATION OF EARTH, or a fair summary thereof, which has already achieved very widespread recognition and support, and believing that this Earth Constitution provides a rational and adequate basis for a Democratic Federal World Government, given the competence to solve supra-national problems both now and in the future;

HAVING EXAMINED ALSO the financial procedures defined by World Legislative Act Number Eleven, as the basis for immediate economic benefits under World Government;

REALIZE THAT DEFINITE ACTION FOR World Government under an adequate World Constitution, together with a new global finance and credit system, must be taken without delay, as a first priority for survival and progress on Earth;

We, acting officially on behalf of the Government, Parliament, or other entity as specified below, do hereby ratify the CONSTITUTION FOR THE FEDERATION OF EARTH, and recognize it as the highest Law of Earth, to serve the peaceful needs of humanity; and also do hereby ratify World Legislative Act Number Eleven, so that it can go into effect immediately and concurrently with the beginning of World Government;

We further understand that the Constitution for the Federation of Earth shall go into effect for the First Operative Stage of World Government, as defined in the Constitution, as soon as ratification is accomplished by 25 countries, with the ratification campaign to continue until the full stage of World Government is reached.

How World Government will Work

Main provisions of the Constitution for the Federation of Earth adopted at the 1977 Session of the World Constituent Assembly and revised at the 1991 Session

WORLD PARLIAMENT composed of three houses, to adopt World Legislation.

House of Peoples, elected directly by the people equally from 1000 World Electoral and Administrative Districts.

House of Nations, appointed or elected by national governments.

House of Counselors of 200 elected by the other two houses, chosen for global perspective; has nominative consultative, initiative and referral functions.


WORLD EXECUTIVE, elected by and responsible to the Parliament. Presidium of a rotating president and 4 vice presidents, all MPs nominated by House of Counselors. Executive Cabinet of 30 ministers, all MPs. The World Executive may not veto or suspend the Parliament or the Constitution.

WORLD ADMINISTRATION of about 30 departments, each headed by a Cabinet Minister or Vice President; coordinated by a Secretary General chosen by the Presidium and confirmed by the Cabinet.

INTEGRATIVE COMPLEX, including agencies for World Civil Service, Boundaries and Elections, Institute on Assessment, World Financial Administration and Legislative Review.

WORLD JUDICIARY, composed of 8 Benches having mandatory jurisdiction over different kinds of issues, with 5 continental seats. Collegium of World Judges is nominated by House of Counselors and elected by Parliament, headed by a Presiding Council of 5 members which assigns judges to the several Benches.

THE ENFORCEMENT SYSTEM, non-military, is headed by an Office of World



DISARMAMENT of nations accomplished when constitution ratified. The World Government does not retain nor use weapons of mass destruction

Attorneys General and commission of 20 Regional World Attorneys, elected by and removable by Parliament. The World Attorneys appoint the World Police (removable by the Parliament) to apprehend individual lawbreakers.

WORLD OMBUDSMUS, to protect human rights and ensure proper government functioning, is headed by a Council of 5 World Ombudsen nominated by House of Counselors, and commission of 20 Regional World Advocates, all elected by the Parliament.

BILL OF RIGHTS of 18 sections, effective when Constitution is ratified.

DIRECTIONAL PRINCIPLES of 19 sections, additional rights and benefits to be implemented over a period of time for all world citizens.

JURISDICTION OF WORLD GOV-ERNMENT defined in Grant of Powers of 40 sections. Nations retain jurisdiction over internal affairs.

FOR ELECTIONS AND ADMINIS-

TRATION. Earth is divided into 1000 Districts, 20 Regions, 10 Magna-Regions, at least 5 Continental Divisions.

FIVE WORLD CAPITALS to be established in 5 continental divisions, one is the Primary Capital, the others are Secondary Capitals.

IMPLEMENTATION OF THE EARTH CONSTITUTION BY STAGES: Provisional World Government, before 25 countries have ratified.

First Operative Stage, when 25 countries have ratified.

Second Operative Stage, when 50% of countries have ratified.

Full Operative Stage, when 80% of countries, comprising 90% of Earth's population, have ratified.

DISARMAMENT of nations accomplished when constitution ratified. The World Government does not retain nor use weapons of mass destruction.

VIABLE AGENCIES OF THE U.N. are transferred to the World Government.

peacefully enforceable inter-popular law. The only viable path in this direction would seem to be a world-embracing union of the established democracies. This would inevitably be federal in type since all participants would insist on guarantees that the general government would be unable to interfere in matters of legitimate national

concern

If at the beginning of this century the world had not been enslaved by the demon of national sovereignty, it is conceivable that we would have escaped both world wars, the holocaust, the UN's Korean War and all its successors. The crimes committed by Hitler, Mussolini, Saddam Hussein and the like could have been obviated by arresting the miscreants for conspiracy to

commit — before the intended atrocities could take place. Protected by national sovereignty, their friends could always prevent their arrest by lawful means, whereas under a system of peacefully enforceable interpopular law (e.g. in a federal union), attempting to prevent the arrest of a suspected criminal would be a federal felony, making the felon himself liable to arrest.
