

I agree: (a) to abide by and be bound by the applicable constitutions and bylaws of the Federation, as may be amended, available online at www.AFGE.org or upon request, and (b) that my membership is for a one-year term beginning on the date that I sign this form; and (c) that my membership is irrevocable for the entire year and will automatically renew annually thereafter, and (d) to pay my membership dues, including dues amounts which I understand may be adjusted periodically in accordance with the applicable constitution and bylaws by the Federation or its affiliates; and (e) that I may revoke my membership in the Federation by submitting the AFGE Dues Cancellation form online at www.afge.org/Cancel or to ATTN: Dues Cancellation, 80 F St. N.W. Washington D.C. 20001, provided that such written notice is received within 30 days before the anniversary date of my annual membership (the "annual window period") or when AFGE is notified that membership is no longer possible due to the member's death and that in doing so I will lose all rights, benefits, and privileges of membership.

EFT/CREDIT CARD TERMS AND CONDITIONS I authorize the AFGE to deduct from my checking account, savings account or charge my credit card, in accordance with the agreed upon EFT or credit card procedures above, an amount equal to the then current annual dues, fees and/or assessments required for membership in the AFGE and its affiliates on an annual basis, subject to any adjustments. My authorization for EFT or credit card payments is in full force and effect until I terminate this payment agreement by notifying AFGE in writing during the annual window period. I understand my written notification to AFGE must be received by the 1st day of the month in order for EFT or credit card payments to be changed in any manner or terminated in that month. This authorization shall remain in full force and effect if I change AFGE Locals during that 12-month period. I further agree that if any such withdrawal is dishonored, AFGE shall be under no liability whatsoever if such dishonor results in late charges or fees. AFGE may charge you a \$12 ACH Return fee each time your financial institution for any reason (insufficient funds, account closed, etc.) returns an ACH payment to the AFGE. Payment of the Member's debt to AFGE is not the responsibility of the Member's bank. Subject to the above, this agreement shall be governed by the laws of the District of Columbia.
