Down Payment Assistance Program



The Santa Clara County REALTORS® Foundation (SCCRF), the charitable arm of SCCAOR, is excited to announce the launch of the Down Payment Assistance (DPA) Program to assist Santa Clara County first-time homebuyers in attaining homeownership.

The DPA Program was designed to assist first-time homebuyers with their initial down payment for a Single Family Residence, Townhouse, or Condominium within Santa Clara County.

The Fund will benefit Santa Clara County homebuyers with an Area Median Income (AMI) no more than 100%. To qualify, a beneficiary must be a first-time homebuyer. The awarded funds are in the form of a grant, therefore repayment is not required.
