I understand that CATS Basics' Classes allow 2- Make-ups for classes missed. I agree that make-up classes must be arranged at least one day in advance, at the same location, in the same level, apply only to the current session and must be taken no later than two weeks after the missed class. A make-up never carries to the next term.

There are no Make-ups for Game CATS Sports Development or Tennis classes.

I understand that payment is due upon registration. After the term begins any unpaid balances will incur a **\$25.00 LATE FEE.**

RETURNED CHECKS incur a \$50.00 service charge. **TRANSFERS:** Transfers may be made within the same level for a fee of \$25.00 after a term begins.

REFUND/Withdrawal POLICY: For all withdrawals, there is a \$50.00 Processing Fee. Tennis class refunds will be given only if withdrawal notification is received two weeks prior to first day of class. For all other classes, withdrawal notification must be received at least 24 hours prior to the first or second class of CATS' session not to incur the fee for that day's class. 48 hours after the second class of the enrolled session, **neither REFUNDS nor CREDITS WILL BE GIVEN.** Refund/Withdrawal requests must be made directly to an office manager (not to a coach). Pro-rated refund payments are by check only and take up to four weeks. No exceptions. Membership is non-transferable.

I understand that CATS, Inc. retains the right to any photographs taken at CATS to be used for publicity or advertising and for which no fees will be paid.

The Children's Athletic Training School, Inc. reserves the right to cancel a class due to insufficient enrollment.

CATS is in a public facility and cannot be held responsible for personal items.

Registration and Regulations Con't.

1. PLACEMENT IS NOT HELD WITHOUT PAID REGISTRATION

2. **GUESTS AND SIBLINGS:** Guest invitation/participation (by one who is age appropriate) is considered a **Trial Class** and must be arranged with the office **at least 1 day in advance** of requested attendance. Guest/trial fees are **\$40.00** for CATS BASICS & for GAME Sport Development classes, and **\$50.00-\$80.00** for a Tennis class. **Non-enrolled siblings may not** attend class nor be present on the gym floor.

3. **CLASS PARTICIPATION/OBSERVATION:** Baby & Kiddie groups need **full** participation by the parents/caregivers who also must wear soft soled shoes. **Please do not talk/text on your cell phones when in class.** No food or coffee in the gym. For Junior CATS 1: After the first 2 weeks of class parents/care givers may no longer stay in class. From Junior CATS on up, parents/care givers are not permitted to stay in the gym during class. The Observation Area is provided for your use. Seating is on a first come first served basis.

4. **ENTRANCE / DISMISSAL:** All students must be supervised before class by their parents/care givers. **PLEASE REMEMBER THAT THIS IS ALSO AN OFFICE.** Siblings of students in class must be watched—**NO Climbing/Kneeling on benches;** NO running; & NO yelling. We appreciate your help. **No child will be dismissed after class without a supervising adult.** Please notify the office if someone new will be picking up your child.

5. **CLOTHING:** Students must wear their appropriate **CATS T-shirt** (given out in class with paid enrollment.) Sneakers are a must, as is comfortable leg wear.

6. **ILLNESS:**

Children should not attend class if they are ill. Instructors may ask children exhibiting symptoms (i.e. runny noses, fevers, coughing, etc.) to leave their class.
