**Credit History:** Applicant authorizes all of the Applicant's creditors and reference, including, but not limited to, those herein, to release Hometown Feed and More, LLC. and whatever information may be contained in their files pertaining to personal and financial dealings with Applicant and grants Hometown Feed and More, LLC. Permission to complete any credit investigation of Applicant, including but not limited to, reposts by a credit reporting agency or entity.

**Supplier Liens:** Texas Feed Sakes: To the extent that feed products are sold to the applicant in the State of Texas Applicant understand that the sale of animal feed on credit is subject to Chapter 188, Texas Agriculture Code. Failure to pay the agreed or reasonable charges for the feed may result in the attachment of lien to the proceeds of the livestock for which the feed is used or the proceeds of the animal products produced for the livestock.

**Change in Business Form:** Applicant agrees that should credit be extended to Applicant or to any business entity in which Applicant has a proprietary interest, commences doing business under another name, different ownership, or legal form, Applicant guarantee and shall be personally, jointly and severally responsible for such change in business status, such written notification received by Hometown Feed and More, LLC., credit department, and the prior entity or form has paid any balance.

**Policies & Terms**

➤ **Payment & Client Information Form**

- Prior to your first order, you will be asked to fill out our customer information forms.
- Payment is due upon receipt; third party freight trucks do not return to our facility, we will need to have ACH draft information on file for these orders.
- We accept cash or check only.
- If any checks come back for insufficient funds, you will be charged \$35.00. If your check is deposited twice and still returned for insufficient funds, you will be charged \$35.00 twice.

➤ **Placing orders**

- All orders currently have a 7 to 10 business day lead time. However, if you order a specialty item (bulk bags or something we don't generally keep on the floor) it could take 10 -14 business days.
- All orders pickups are done on a first come first served basis. At this time, we are not assigning pick up times.
- Delivery orders will try to be scheduled to meet your deadlines; however, please understand that there may be times when a delivery company cannot be scheduled to meet your specific deadline. Please take this into consideration when placing your order before you are out of product.
- Delivery freight rates are charged/per ton of product weight.

➤ **Discounts**

- Product discounts are available and based on the tonnage purchased.
- Tonnage discounts are as followed;  
Orders less than 20 tons.....Price Level 1  
Orders over 20 tons.....Price Level 2  
(If requested your order to be delivered it must be a minimum of 6 tons and a maximum of 22 tons)

➤ **Returned Product**

- There will be no return or exchange on feed after 30 days from the date of purchase. Please order accordingly to keep your feed the freshest possible.
- Products such as textured sweet feeds have a very short shelf life, much the same as a perishable grocery items. We recommend that you maintain no more than a two week supply and rotate your stock with each new shipment.
- Any product returns should be in the original container if at all possible.
- No product returns will be accepted on our delivery trucks without prior authorization from our office. Exceptions will be only on goods damaged on our truck or in the normal processing of unloading at your store.

➤ **Miscellaneous Fees**

- Shrink Wrap Fee \$4.00 per pallet
- We **DO NOT** accept the return of bulk bags due to FDA regulations. Wood pallets may be returned but no credit will be issued.
