

Contract Let for First Piece of Concrete Road; Means Much to Saginaw.

Saginaw has made a start on a permanent high type road building program. On June 2nd the contract was let for building ten miles of the Saginaw road from the Genesee County limits, this side of Clio, through to Cook's Corners. The Saginaw County Road Commission advises that the contract was for approximately \$25,000 a mile. This will give a through concrete road as far as Cook's Corners, and plans are already under way to continue such a road through to the city limits.

The Board of Commerce at its annual meeting May 15th went on record favoring a high type permanent road of at least 18 feet width from Genesee County into Saginaw and from Saginaw west to the Gratiot County limits by way of Merrill.

State Highway Commissioner, Frank F. Rogers, realizing the importance of these

two roads has promised federal and state aid to the best of his ability.

Now that the good roads bond issue has been passed and the legislature is providing the enabling acts whereby this money can be raised and expended it is up to Saginaw County to go ahead and get in on the ground floor, and secure its share of this money for the roads which rightfully should receive such aid.

Steps are already being considered for such a high type road to Merrill and Gratiot County is ready to go ahead with such a program. The impression seems to be created that a north and south road, and east and west road across Saginaw County should be of such type. Such roads bear an immense amount of traffic—farmer's produce, trucking, passenger, tourist, etc.,

The company will increase its capitalization from \$25,000 to \$200,000, will increase its plant, and expect to start operations within thirty days. NEW BUILDING FOR E. F. HUBBELL

E. F. Hubbell, of the Hubbell Auto Sales Co., has completed arrangements for the purchase of his old site at corner of Genesee Avenue and Water Street and will build at once a new Ford sales and service building. This new building will give the company a modern plant on the east side and the one on the west side, which will be continued, the two serving the city in thorough manner. The new building will be 100 by 132 feet, at least two stories high.

With the Retail Merchants' Bureau

The monthly meeting and dinner of the Retail Merchants' Bureau will be held at the Saginaw Canoe Club Tuesday, June 24th, at 6:15, according to an announcement of the committee on arrangements Gardner Palmer, A. D. Philippe and C. G. Christensen.

Mayor Mercer will be present and a talk will be given by H. J. Clifford, late welfare worker at the Buick Factory at Flint, a powerful and convincing speaker who has come to the First Presbyterian Church.

There will be several reports given at this meeting and every member of the bureau is urged to be present.

May Meeting a Success

The monthly meeting of the Retail Merchants' Bureau was held in the Hotel Bancroft, Tuesday evening, May 20th. Vice-President H. P. Baker presided.

Addresses were given by Mayor B. N. Mercer, A. W.Seeley, of the War Board, and Assistant Secretary C. M. Howell, of the Board of Commerce.

A report was made on messages to Congressman J. W. Fordney, and Senators Truman H. Newberry and Chas. E. Townsend, of Washington, by the Board of Commerce,

the Retail Merchants' Bureau, and the Retail Dry Goods Dealers asking repeal of the luxury tax.

G. F. Opperman brought up the matter of an ordinance for a license protecting Saginaw retailers from transient peddlers. A Committee was appointed consisting of Mr. Opperman, H. B. Schneermann and A. E. Jochen to take up this matter with the city. On motion of Mr. Opperman, seconded by Mr. McDonald, and carried, the Bureau went on record favoring such an ordinance.

W. C. Wiechmann presented the matter of drayage companies reporting to city officials families moving into and from one part of the city to another so that accurate information could be secured on new population and changes within the city.

A. D. Philippe brought up the matter of uniform closing hours. The matter was left to the chairman of the different groups to secure their opinions. It was the sense of the meeting for uniformity of opening and closing hours.

Vice-President H. P. Baker named the committee to make arrangements for the next monthly meeting and dinner.

and are of vital importance to Saginaw and should be of wide permanent type able to bear and hold up this immense traffic.

Good permanent roads cost money, but they mean money for a community, and it is the impression that with such events as the style show, retail trades and wholesale trade reaching out for expansion to the natural Saginaw territory the most important feature in the development of this part of our community life is that of good roads. People want to come to Saginaw and in order to come they must have the roads to travel over. The better the roads the easier and more convenient it is going to be to reach the city.

The Saginaw County Road Commission has adopted the resolutions of the Board of Commerce annual meeting for a high type, at least 18 feet wide, road from the Genesee County limits into Saginaw and from Saginaw to the Gratiot County limits by way of Merrill. Plans have been made for building a concrete road out Gratiot Avenue beeween the bridges, this work to be done this year. This is a start on this road.

District Highway Engineer R. W. Roberts reports that he has arranged for all preliminary work for a concrete road between St Louis and Alma.

The Saginaw County Road Commission is doing a large amount of work and this is shown in the fact that the roads are in better shape this year than at any time in the past.

DIRECTOR GUIDER, STRONG WORKER HAS LEFT US.


Wm. M. Guider, Secretary-Treasurer and Manager of the Saginaw Mirror Works, Secretary of the Saginaw Show Case Company, Ltd., Director of the Board of Commerce, and a member of the city board of estimates, died Tuesday, May 20th. He was 60 years old. Mr. Guider left us very suddenly. Only a few days before he assisted materially in the annual meeting of the Board of Commerce.

Born in Saginaw County, prominent business man, hard worker for anything for the betterment of Saginaw, a keen student of municipal conditions, and one of those who played a large part in the merging of sectional organizations into the Board of Commerce, he leaves a place in Saginaw which is hard to fill. He is survived by the widow and three sons, Arnold R., Carl H., and Frederick O. Guider.

CLEAN-UP CAMPAIGN WAS A GREAT SUCCESS

The Clean-Up and Paint-Up and Keep It Up Campaign Committee of the Board of Commerce met Monday night, May 26th, and reviewed the conditions of the second annual Clean-Up Week May 12th to 17th. Chairman David A. Wolsey and the committee were well satisfied with the results and believe that there has been inoculated into the mind and spirit of every one in Saginaw the thought of making Saginaw even a cleaner city than the enviable record that it now enjoys.

Fifteen thousand school children took part in the Campaign. A large number of these wrote essays on Clean-Up subjects. All of them took pledge cards home to their parents. The Women's Clubs, the Fire Department, the Police Department, Health Department of the City, the ministersevery possible agency, assisted in this movement. The results of the Camera Contest were very gratifying. About forty pictures of unsanitary and unsightly spots were turned in. The Boy Scouts brought in several hundred report cards showing conditions that could be bettered. The Board of Commerce Committee is cooperating thoroughly with Mayor B. N. Mercer and City Health Officer Dr. W. B. Clark. Some of these cards have been turned over to the City Departments.

The Committee was very successful in its effort to secure the appropriation for a systematic block by block clean-up of rubbish next spring, the Board of Estimates allowing \$750 for this work.

Great aid was received through the theatres, every theatre in town willingly cooperating in running slides calling attention to Clean-Up Week and what it meant. The members of the Committee to whom great credit is due for launching and carrying this Campaign are as follows:

"Expansion of City Limits Seems Necessary"—Sec. Kirby

"The undertaking of the City Council and Charter Commission looking into the question of extending the City Limits so as to take within and make a part of the City of Saginaw that territory immediately adjacent to and surrounding the present City Limits, built up with comfortable workingmen's homes such as Buena Vista, Carrol-



ton, and other places, seems to be a step in the right direction.

"While we are continuing to urge the building of homes within the corporate limits upon the many vacant lots, admirable building spots, yet we must not overlook the fact that thousands of people are living in comfortable homes adjacent to our city limits but not favored with public conveniences and protection afforded to those whose homes are situated within the city.

"In connection with the remarkable industrial expansion, we observe the many new comfortable workingmen's homes being erected just at the outskirts of the city, which is largely accounted for in the reasonable prices offered by way of lots, and


personally I believe it the duty of those in charge of the City Government to afford these homes fire and police protection, schools, water, sewers, lights and transportation, as well as the other advantages to be obtained by incorporating and placing these homes within the city. People seeking and occupying such homes are entitled to the conveniences mentioned and it will result in a valuable return to the city in that we will have a contented labor and a contented citizenship when they are able to avail themselves of these necessary public improvements and utilities.

"I trust that the proposed enlargement of the city limits will meet with the hearty approval of not only the people residing within the city at this time but the sections proposed to be added. It is my purpose to call this very important matter to the attention of the Board of Directors at the earliest possible moment for their consideration."

The Board of Commerce has received very gratifying letters from R. A. Turner, of Lansing, State Club Leader of the Boys' and Girls' Agriculture and Home Economics work and from Miss Theresa McDonald, Saginaw County Club Leader, thanking for the Certificates of Award furnished by the Board and bearing the signature of the President and Managing Secretary, and the board's seal. These were awarded to thirty boys and girls of Saginaw townships who were leaders for the last year.

REFERENDUM ON CHARTER CHANGES

The members of the Board of Commerce have an opportunity through a referendum to voice their views on any features they think should be written in the charter now undergoing revision by the Commissioners elected April 7th. Managing Secretary Julius B. Kirby, following the action of the Board of Directors, named a committee consisting of Geo. W. Weadock, Chairman, Benton Hanchett, Arnold Boutell, H. A. Savage, and John Popp to represent the Board of Commerce in making suggestions

to the Charter Commissioner. This Committee met with the Managing Secretary and decided to place a referendum before the membership. The replies have been very general.

George B. Morley, President of the Second National Bank, headed a party of that institution to Grand Rapids, June 9th, to inspect bank property with a view of securing an idea to work into the big office and bank building which the Second National will erect in Saginaw.

Important Resolutions on Water and Charter Revision by Board of Directors.

BOARD BACKS PLAN OF COUNCIL

Record of a meeting of the Board of Directors of the Saginaw Board of Commerce, held at the Board of Commerce Rooms, Thursday evening, June 19th, 1919, at 7:30 o'clock.

Present

At this meeting the following resolutions were offered and unanimously adopted:

"WHEREAS, Honorable B. N. Mercer, Mayor of the City of Saginaw, has requested the Saginaw Board of Commerce to appoint five (5) delegates and submit their names to him not later than Monday, June 23rd, so that he can place the list before the Council on June 24th in accordance with the resolution heretofore adopted by the City Council to consider some plan by which the City of Saginaw may be supplied with pure water, and

WHEREAS, it appears that other civic and fratenal organizations have likewise been invited to name a similar number of delegates for the same purpose, now, therefore,

BE IT RESOLVED, that the Saginaw Board of Commerce hereby designates and names George H. Hannum, W. H. Wallace, W. J. Wickes, A. D. Eddy, Wallace Craig Smith as delegates to act and represent the Board of Commerce in the proposed undertaking, and

BE IT FURTHER RESOLVED, that the Board of Commerce, through its Board of Directors, hereby endorses the plan undertaken by the City Council and hereby pledges its membership to faithfully cooperate and support whatever plan a majority of the joint committee so selected may approve of.

RESOLVED FURTHER, that the Board of Commerce regards the movement and undertaking to secure an unlimited and wholesome supply of pure water for the City of Saginaw as a vital and important movement at this period of industrial expansion and that it will do each and every thing within its power to the end that our City be supplied with an adequate and satisfact ory supply of pure water."

REPORT OF CHARTER COMMITTEE

At the same meeting the following resolutions relative to Charter Revision was offered and unanimously adopted:

"WHEREAS, the Charter Commission now organized and considering the revision of the Saginaw City Charter has requested the Board of Commerce to submit proposals and suggestions to be considered by it in the

revision of the Charter, and

WHEREAS, the Board of Commerce appointed a committee consisting of Hon. Geo. W. Weadock, Chairman; Benton Hanchett, Arnold Boutell, H. A. Savage, and John Popp to make recommendations to the Board of Directors of the Board of Commerce of such proposals and suggestions, and

WHEREAS, such committee has made written proposals and suggesttions appearing from 1 to 7 inclusive, which are hereto attached, now, there-

fore BÉ IT RESOLVED, that the Managing Secretary of this organization transmit to the City Charter Commission said proposals and suggestions presented by the committee aforesaid along with the said resolution, and that such proposals and suggestions are hereby ratified, confirmed, and endorsed, and submitted for the consideration of the Charter Commission in response to the request made as aforesaid."

TO THE BOARD OF COMMERCE OF THE CITY OF SAGINAW.

Your Committee on the Revision of the Charter of the City of Saginaw, beg leave to report that it has had the subject under consideration and submits the following recommendations:

1. That the present Commission form of government be re tained, giving to the Mayor, the power of veto over all matters subject to vote by the Council.

2. That the salaries of the Mayor and other members of the Commission be increased so as to give them adequate compensation for the services performed.

3. That the Charter may be so revised that the City may acquire, own and operate, either within or without its corporate limits, utilities for supplying pure water, and to enable the City to raise the necessary funds to pay for the same.

4. To the end that the present restrictive provisions preventing the furnishing of adequate street car transportation facilities for the City be abolished, we recommend that Sections 198, the last nine lines of Section 199, and Sections 200, 206 and 209 of Chapter XVII of the present Charter be omitted.

5. That the Eastern and Western taxing districts of the City be consolidated.

6. That the Board of Education, East Side, and Union School District, West Side, be consolidated into one school system for the whole city.

7. That provision be made to insure better public health service.

All of which is respectfully submitted. Signed



Deeper Waterways to Ocean Mean Much to Saginaw's Future.

The Directors of the Board of Commerce at their May meeting went on record in favor of deepened water way plan being proposed in Canada and the United States which lately received attention at Lansing and the National Capitol.

Managing Secretary J. B. Kirby was authorized to prepare Resolutions expressing the sentiment of the Board of Commerce. The Resolution follows:

"WHEREAS it has come to the attention of the Saginaw Board of Commerce that a great movement is now being inaugurated to deepen the St. Lawrence River and Welland Canal and the construction of larger and better locks so that transportation of ocean boats may be had to and from the Great Lakes.

The Saginaw Board of Commerce fully realizing the importance of such undertaking to the World Commerce and the great States bordering upon the Great Lakes hereby endorses the undertaking and pledges its support to the same.

NOW THEREFORE BE IT RE-SOLVED that Hon. Albert E. Sleeper, Governor of Michigan, be and he is hereby requested to place this important matter before the Michigan Legislatures at the earliest possible moment with recommendation of the creation of a commission to represent the State of Michigan along with an adequate amount of money to carry on its business for two years, and

RESOLVED FURTHER that a copy of this resolution be handed each of the respective representatives from Michigan in the United States Congress and United States Senators Chas. E. Townsend and Truman H. Newberry a view that the subject matter receive attention of the United States Congress and be made a part of our National program."

These Resolutions have been sent to Governor Sleeper and to every Congressman from Michigan and the two Senators at Washington, and from letters received from Washington they are being given every consideration.

Senator Townsend writes that the Saginaw Resolutions have been written into the records of the senate. Congressman Nichener of Michigan, is a member of the committee on Rivers and Harbors.

Saginaw with its Shipbuilding plant is vitally interested in a deepened water way to reach the Atlantic sea board.

The Banks Are An Accurate Barometer of Saginaw Prosperity.

James Cook Mills in an article published in the News-Courier, May 26th set forth the financial condition of Saginaw in a manner leaving no doubt about the prosperity of Saginaw. His article in part follows:

"The gain of more than seven million dollars represent savings of thrifty citizens and commercial and trust deposits due to increased activity in all lines of business in this city.

"In this connection it is worth while to draw a comparison between the summaries of our banks and the banks of Flint. While that city may have topped us in population, its banks have not overtaken our financial 543,492.71 to \$27,745,867.65, a gain of \$6,202,374.94, or 28.8 per cent. At the latter date the total capitalization was \$1,400,000 and the surplus and undivided profits \$2,192,362.46, a total of capital resources of \$3,592,362.46, and showing a substantial gain over previous reports.

On May 12, 1919, the five banks of Flint showed total deposits of \$23, 262,88T7.12, or \$4,482,980.53 less than Saginaw banks, while the total resources were \$27,869,872.43 as against \$33,802, 265.50 of Saginaw banks, or nearly \$6,000,000 less. At the same time the capital resources of Flint banks were \$962, 142.75 less than the local banks."


