Agility Comes Easy for Nicky Theis!

It was a good thing he was in a no-kill animal shelter. Who would adopt a two-time loser named Pickles? Especially one with that much fur! The person dropping him off at the shelter said that he was a stray they found, but said, "He's too much trouble to take care of."

Fortunately, not long after he arrived at the Max Fund animal shelter in Denver, he caught the eye of Michael Theis. An 'interview' soon followed, Michael fell in love with the little guy and started the adoption process. The only problem he had with the Cairn Terrier/Pomeranian mix was his name: Pickles. He mentioned to a friend at work, "If the dog gets out of the house, I can't be running down the street yelling PICKLES!!!" The friend said an easy solution was to call him Nickles and transition to Nicky. Wow, a great idea.

Nicky was so happy to be out of the shelter and into a real home. It turned out; he was a no "trouble" at all. On the news one night, there was an interview with the owner of a dog training company close to where Michael lived. One of the things they teach is Agility. In the video, you could see dogs going over jumps, through weave poles, tires, tunnels and even running over a teeter-totter. Intrigued, Michael drove there with Nicky and after passing a short obedience test, they were enrolled in a beginner agility class.

Nicky absolutely loved it and quickly moved up the ranks to the Advanced level. Though small, he is fast as a bullet. Agility competitions are scored by the time it takes to complete a course with time deducted for faults (such as knocking the bar of a jump, missing the entrance to a tunnel or missing a weave pole). Nicky could have easily competed in the sport but his handler, Michael, was not up to the task due to age and COPD. So, they do agility just for the fun of it.

Since moving to Oro Valley, they continue to do agility but not on a weekly basis as they did Denver. Hot summer months preclude training outdoors and the only indoor facility is a good distance away. But usually once a month or so, you can find Nicky and Michael running side-by-side as Michael calls out the next obstacle, and Nicky does the real work.
