**Arrival/ Pick-up:** Decorating Staff will arrive     . We cannot be held responsible for delays (or incomplete décor) if not allowed a reasonable amount of time to complete décor services as described in this agreement. Pick up rental items will be pick up accordingly.

**Terms/Payment:** **Full payment MUST be received.** Final payment must be received at the time indicated of the fulfillment of this agreement.

### Accident Clause:

We are not responsible for accidents or injuries related to our decor that is caused by mischief or mishandling by the client, guests or site staff. Please, do not allow guests to put the latex balloons into their mouths. **Be aware that some Children and Adults have allergic reactions to latex. These Children/Adults should refrain from having contact with the latex balloons.**

**Damages:** We are not responsible for any damaged walls, equipment, décor items, and any related items that balloons will be attached to. Will be using command hooks to attach anything on the walls and ceilings.

**Inclement Weather Clause:** Fanciful Balloons LLC. Shall not be responsible should weather conditions make it impossible to perform décor service (as described in this agreement). This includes (but is not limited to) strong winds, rain or SNOW STORMS. However, if inclement weather prevents installation of agreed décor.

**Outdoor Décor Clause:** We make every possible effort to ensure that your décor will meet or exceed your expectations. However, due to the general nature of balloons, we cannot guarantee that that your balloons will remain perfect and intact when used outdoors. If inclement weather conditions make it difficult or impossible to produce as specified Floating Memories will do its best to be flexible with providing décor alternatives. It is clearly understood that there will be no refunds or discounts for loss, breakage or failure to produce due to factors outside and beyond our control.

**Equipment Guidelines:** Customer acknowledges that in the event any rented materials.
