Long-Term Growth Catalysts

Since 2020, global defense spending has grown at a 4.2% annual rate – about 4x higher than prepandemic levels. Spending is expected to grow at a 5% annualized rate to \$3.4 trillion by 2030.⁽¹⁾



Reimagining the Defense Industry

Governments are increasingly reliant on advanced military systems that require specialized hardware, creating demand for sensors, artificial intelligence chips, and other processing/ networking solutions.



Differentiated Exposure

Defense Tech spans sectors like industrials, cybersecurity, AI, and augmented reality. Unlike civilian markets, defense revenues are closely tied to military needs and are not necessarily linked to



Global X Defense Tech Index
