High Growth Potential

Increasing Al investments are likely to boost cloud's share of total IT spending from an estimated 15% in $2023^{(1)}$ to roughly 40% in 2030, $^{(2)}$ as companies look to capitalize on the flexibility and turnkey nature of the cloud model.



Structural Tailwinds

More data requires more cloud resources, and the proliferation of AI is generating tremendous amounts of data. By 2030, AI could drive more than half of all online data creation, likely creating opportunities for cloud providers. (2)



The Indxx Global Cloud Computing Index is designed to provide exposure to exchange-listed companies in developed and emerging markets that are positioned to benefit from the increased adoption of cloud computing technology, including but not limited to companies whose principal business is in offering computing Software-as-a-Service ("SaaS"), Platform-as-a-Service ("PaaS"), Infrastructure-as-a-Service ("laaS"), managed server storage space and data center REITs, and/or cloud and edge computing infrastructure and hardware (collectively, "Cloud Computing Companies"), as defined by Indxx LLC, the provider of the Indxx Global Cloud Computing Index ("Index Provider").
