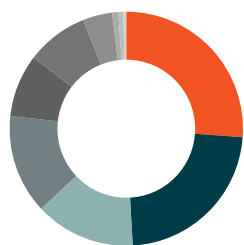

Effective as of the close of business on October 29, 2021, the predecessor fund was reorganized into the Fund. The Index consists of the FTSE Norway 30 Index from the inception of the Fund through July 14, 2014, and the MSCI Norway IMI 25/50 Index going forward.
