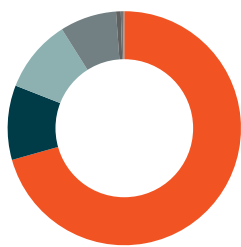

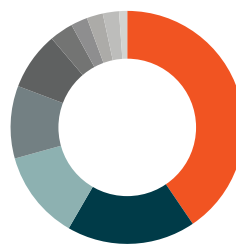

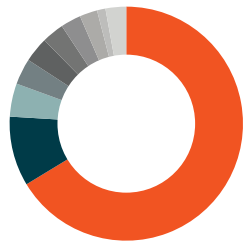

## Indxx Artificial Intelligence &amp; Big Data Index
