- Nick Henderson-Human Services Director, Family & Children Services, Replacing Brenda Mahoney.
  - Has been with Stearns county for over 15 years. Started as a probation officer, 10 years with adolescence, 3 years mental health, 1 year with repeat DWI offenders, and 7 months ago took over.
  - Has a coach vs ref perspective---Wants to be supportive vs telling you just did it wrong.
  - Not afraid to challenge Human Services, however, it will not change overnight. It will take some time, so please be patient.
  - 60-80 providers lost, foster homes are becoming very hard to find, treatment and group homes are closing.
  - 77 new staff members in the county, 23 in the past 6 months.
- Is going to work with the Sheriff's department to get something like Morrison county as in, an active shooter/school lockdowns, there will be a message sent to providers also so they are aware and can lock down/do the correct procedures.
