## Terms & Conditions of Sales

A 1 . NEXA INFINITY DESIGN STUDIO provides 24 months warranty for defective workmanship for all our projects and all terms and conditions pertaining to warranty is clearly indicated in each and every of our agreement. In cases of unforeseen delay when works have started, especially in Covid 19 conditions (HRW), we will endeavour to work together with Customers to reach a mutually acceptable solution.

A2. Due to the nature of our business, exchange or refund of customised products are not applicable.

For electrical appliances, sanitary fittings and fixtures, etc... installed, customers are to refer to manufacturers' warranty accordingly where applicable.

A3. If work has not started, Customer who wishes to cancel the agreement can do so by writing in to us officially, stating reason for cancellation. We will process their refund request within 5 working days from date of receipt of official request letter. Deposit paid will be refunded in the following manner:

Cheque or PayNow : deposit less admin fees 1%

\*NETS : deposit less merchant and admin fees 1.8%

\*VISA or \*Mastercard : deposit less merchant and admin fees 3.6%

Agreement cannot be cancelled once work including preparation works, 3D drawings, has commenced.

Should customer terminates the contract before its completion, 3D drawings become payable at \$200 per drawing. This only applies to contracts with Design & Services scope.

A4. NEXA INFINITY DESIGN STUDIO does not issue voucher. Hence, redemption of voucher is not applicable.

A5. NEXA INFINITY DESIGN STUDIO is committed to deliver the best interior design experience. Upon receiving Customer's notification for defective workmanship under warranty coverage, in normal conditions, we will carry out rectification works within 7 working days.

A 6 . NEXA INFINITY DESIGN STUDIO will provide a signed copy of the contract to all customers before work commences. The signed contract will clearly indicate the scope of works, item cost breakdown and a works programme.

A 7. Likewise as per clause A6, for variation addendum, NEXA INFINITY DESIGN STUDIO will provide all customers with the signed variation contract clearly indicating the additional scope of works, additional item cost breakdown and additional works programme.

A8. The Singapore dollar is the official currency of Singapore and NEXA INFINITY DESIGN STUDIO only accepts Singapore currency. NEXA INFINITY DESIGN STUDIO accepts ONLY \*NETS, \*Visa, \*MasterCard, PayNow and cheques. Cheque is to be crossed and made payable to NEXA INFINITY DESIGN STUDIO PTE LTD.  
(Note: \*Cards are accepted for deposit and last payment only)

A9. NEXA INFINITY DESIGN STUDIO is committed to avoid over or under-charging and to ensure correct change is given and will issue receipts for all payment made.

A10. In general, NEXA INFINITY DESIGN STUDIO do not charge delivery or shipping charges. Should there be any such charges, we will clearly indicate them in all signed contract.

A11. NEXA INFINITY DESIGN STUDIO will clearly states any additional charges incurred besides the contract price, such as site preparation fees, 3D drawings, delivery charges, etc... in all signed contracts.

A12. NEXA INFINITY DESIGN STUDIO will clearly indicate payment schedule in all signed contracts, stating the amount to be paid at various stages. For Variation Orders, Customer has to make 100% payment upon confirmation of additional Works. For omission works which resulted in contract overpayment, NEXA INFINITY DESIGN STUDIO will refund customer upon unit handover.
