REGISTRATION OFFICE OPEN 7AM – 10 PM

1. QUIET HOURS **11:00PM – 7:00AM GENERATORS OFF.** MUSIC & CONVERSATION LOW. WE RESERVE THE RIGHT TO SUSPEND THE USE OF ANY GENERATOR THAT WE DEEM TO BE OF EXCESSIVE NOISE OR CREATING A SAFETY HAZARD DUE TO FUMES.
2. VEHICLES ALL VEHICLES MUST FIT ON YOUR SITE. VEHICLES ENTERING THE PARK MUST STOP AT THE OFFICE TO REGISTER. **SITEHOLDERS MUST PRE-REGISTER AND PRE-PAY ALL VEHICLES.**
3. GOLF CARTS GOLF CARTS & SCOOTERS MUST BE PAID FOR IN ADVANCE. SPEEDWAY SPORTS PARK RESERVES THE RIGHT TO REVOKE THE USE WITHIN THE PARK IF RECKLESS OR UNSAFE USE IS REPORTED. THESE UNITS ARE NOT ALLOWED ON N.H.M.S. PROPERTY. THE SITEHOLDER, NOT SPEEDWAY SPORTS PARK (OR AFFILIATES OF S.S.P). IS RESPONSIBLE FOR ANY INJURY OR DAMAGE CAUSED BY THESE UNITS.
4. PETS PETS ARE ALLOWED AND MUST BE ON LEASHES AT ALL TIMES. IT IS THE SITEHOLDERS RESPONSIBILITY TO CONTROL AND CLEAN UP AFTER PETS. ANY INJURY OR DAMAGE CAUSED BY PETS, ARE THE SITEHOLDERS RESPONSIBILITY, NOT SPEEDWAY SPORTS PARK OR AFFILIATES OF S.S.P.
5. WATER WATER FILL UP IS FOR ALL. **DO NOT STAY CONNECTED TO THE FAUCETS.** SSP reserves the right to terminate water faucets and hoses that are connected.
6. CAMPFIRES NH FIREWOOD ONLY. WOOD BURNING ONLY. NO ACCELERATES ARE TO BE USED. NO BURNING OF CANS, GLASS, GARBAGE, NAILS, OR ANY ITEMS OTHER THAN WOOD. NO BON FIRES. NO SKY LANTERNS. THE FIRE MARSHALL MAY BAN CAMPFIRES IF CONDITIONS WARRANT. **ANY EVIDENCE OF UNAUTHORIZED BURNING WILL RESULT IN THE PERMENANT LOSS OF SITE.**
7. TRASH PLACE ALL TRASH IN TIED BAGS IN DUMPSTERS. **DO NOT LEAVE TRASH AT YOUR SITE** OR ON THE GROUND.
8. SHOWERS REMOVE ALL YOUR PERSONAL ITEMS WHEN FINISHED (SOAP, SHAMPOO, SHAVERS, WASH CLOTHS ETC.) NO SMOKING IN SHOWER BUILDINGS. HELP TO KEEP THESE CLEAN.
9. PORTA-JOHN NO GRAFFITI. NO DISPOSING OF FOOD OR GREASE. OIL OR GREASE USED FOR COOKING SHOULD BE POURED BACK INTO ORIGINAL CONTAINER OR IN COFFEE CANS (IF CANS ARE NEEDED, PLEASE SEE US AT THE OFFICE) NO SMOKING. HELP TO KEEP THESE CLEAN.
10. PAYMENTS ALL PAYMENTS MUST BE PAID IN FULL BY THE TIME YOUR CAMPER ARRIVES AT SSP. ALL PAYMENTS ARE FINAL. THERE WILL BE NO REFUNDS FOR PAID SITES, HOWEVER PER THE OWNERS DISCRETION A CREDIT FOR NO MORE THEN 1 YEAR MAY BE ISSUED FOR PAYMENT RECEIVED.

FIREWORKS AND LANTERS OF ANY KIND ARE PROHIBITED AND WILL RESULT IN IMMEDIATE LOSS OF SITE. TENTS ARE NOT ALLOWED (PER TOWN ORDER). DRAINING OR DRIPPING OF GRAY WATER IS PROHIBITED. SITEHOLDERS ARE RESPONSIBLE FOR ALL PEOPLE, VEHICLES, AND UNITS AT THEIR SITE.

VIOLATION OF ANY REGULATION WILL RESULT IN IMMEDIATE EVICTION AND LOSS OF SITE, WITH NO COMPENSATION. SPEEDWAY SPORTS PARK AND ITS AFFILIATES ARE NOT RESPONSIBLE FOR THEFT, FIRE, ANY DAMAGE, ACCIDENT AND/OR INJURY.
