Cancellations

If the client wishes to cancel the services, he/she must give at least 45 days’ notice. Any amount paid over the \$100 nonrefundable retainer will be refunded if a 45-day notice of cancelation is provided.

The client will not be held liable for payments and Jason Schmitt will not be liable for refunds, due to unforeseen or uncontrollable circumstances such as accidents, illnesses or other “acts of God” that are outside the control of either parties.

Equipment

I provide all my equipment. If required to use equipment that is not provided by me, I will not be held responsible for equipment failure or poor-quality sound. The client agrees to pay for all damages to Jason Schmitt’s equipment caused by the negligence of the client or any of the event guests. The client will be allowed to inspect the equipment prior to the start of the event if they so choose.
