Keep your child/children at home if your child/children or any

household member has at least ONE of the following symptoms:

- 1. Fever of 100.4F or higher.
- 2. Cough.
- 3. Shortness of Breath.
- 4. Chills.
- 5. Repeated Shaking with Chills.
- 6. Muscle Pain.

- 8. Sore Throat.
- 9. New loss of taste or smell.
- 10. Diarrhea.
- 11. Vomiting.
- 12. Has been in contact with someone who tested positive.

*** Keep your child at home until child is symptom-free, with no help from fever

reducing medications, for 72 hours.

During the day precautions:

- 1. Constant handwashing.
- 2. Constant disinfecting of tables, chairs, toys, etc
- 3. Separate all the tables and have the same lunch/snack group throughout the day.


