
# Mission and Vision

# Tokenomics Explained

#### $\odot$

- Community (75%)
- The majority of tokens are allocated to the community to encourage participation, growth, and decentralized ownership. This allocation will be distributed through various community engagement initiatives and exchanges. We will collect votes via our website/social media for user input along the way
- Dex/CEX/ Liquidity (Total 15%)
- Tokens reserved for liquidity provisioning on decentralized exchanges (DEXs) such as
  Uniswap, as well as centralized exchange listings. This ensures the token maintains
  healthy liquidity, facilitating seamless trading with minimal slippage and fostering price
  stability.
- Future Development (5%)
- These tokens are allocated for the future development of the ClearLeaf Coin. This will be distributed over time as needed to further develop and secure CLF's position in the market
- Team (5%)
- Reserved for the founding and development team as an incentive and reward for their ongoing commitment to the project's success. These tokens will be subject to a vesting schedule to align long-term incentives.
